## Independent Auditor's Report

To the Trustees  
Ford of Slidell 401(k) Plan  
Slidell, Louisiana

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Ford of Slidell 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### **Note 1 - Description of Plan -**

#### Description of Plan

The following description of the Ford of Slidell 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a 401(k) defined contribution plan adopted in 2002. The Plan covers all eligible employees of Ford of Slidell, LLC, Nissan of Slidell, LLC, Supreme Chevrolet, LLC, Kramor of Plaquemine, LLC, and Supreme Ford of Laplace, LLC (collectively, the Companies) who are at least 21 years of age and have 90 days of service as defined in the Plan articles. As of December 2, 2024, Kramor of Plaquemine, LLC, is no longer a participant of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

#### Contributions

Employees may defer a portion of their salary under the applicable section of the Internal Revenue Code. The Plan allows each eligible participant to elect to defer up to the maximum allowed by law. Participants age 50 or older who make the maximum allowable deferral are eligible to contribute an additional catch-up contribution. The Companies may make discretionary matching contributions. For the year ended December 31, 2024, the Companies elected to match 25% of the participant's elective deferral up to 6% of the participant's compensation. The Companies made discretionary matching contributions of \$77,254 for the year ended December 31, 2024.

#### Participant Accounts

Each participant's account is credited or charged with the participant's contribution, the Companies' matching contribution, an allocated portion of the Plan's earnings, and certain Plan administration costs not covered by the Companies. Allocations are based upon participant account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions. Vesting in the Companies' matching contributions is based on the following vesting schedule.

### Payment of Benefits

Upon termination of service, death, disability or retirement, participants or their beneficiaries may elect to receive a lump-sum amount or installments equal to the value of the participant's vested interest in his or her account.

### Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are used to reduce future contributions of the Companies and to pay administrative fees. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$27,153 and \$17,916, respectively. During 2024, forfeited non vested accounts were used to pay administrative expenses and reduce employer contributions of \$2,939.

## **Note 2 - Summary of Accounting Policies -**

### Basis of Accounting

The financial statements of the Plan are prepared in accordance with the accrual basis of accounting and investments are valued at current fair value as quoted by the custodian of the Plan. At December 31, 2024 and 2023, all assets of the Plan are participant directed.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and such differences may be material.

### Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Plan Sponsor determines the Plan's valuation policies utilizing information provided by the Plan Custodian. See Notes 5 and 6 for discussion of fair value measurements and contract value measurements, respectively.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Investment income (loss) includes gains and losses on investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year. Benefits are recorded when paid. Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which employee contributions are withheld from compensation.

### Risks and Uncertainties

The Plan provides for various investment options in any combination of pooled separate accounts or guaranteed interest - fixed account. The funds are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these funds, it is at least reasonably possible that changes in the values of the funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### Administrative Expenses

Certain administrative expenses of maintaining the Plan may be paid directly by the Companies and are excluded from these financial statements. Fees for certain transactions, such as withdrawal processing, are charged directly to the account of the participant reporting such a transaction and included in administrative expenses. Investment related expenses are included in investment income (loss).

### Reclassifications

Certain items in the 2023 financial statements may have been reclassified to conform to the presentation in the current year financial statements. Such reclassifications had no effect on the previously reported change in net assets available for benefits.

### Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through September 30, 2025, the date which the financial statements were available to be issued.

### **Note 3 - Plan Termination -**

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue operations at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

### **Note 4 - Tax Status -**

The Companies have adopted a prototype plan which has received a favorable determination letter from the Internal Revenue Service that it qualifies under the applicable section of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan itself has not separately applied for recognition of tax-exempt status. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is no longer subject to income tax examinations for years prior to 2021.

## Note 5 - Fair Value Measurements -

The fair value measurement accounting literature provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs to the valuation methodology are based on unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are based primarily on quoted prices for similar assets in active or inactive markets and/or based on inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs are unobservable and are based on assumptions market participants would utilize in pricing the asset.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. When available, valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts - These accounts are valued daily as the number of units held multiplied by the accumulation unit value (AUV). The AUV is determined based on the quoted net asset values of the shares of the underlying securities, the fund's dividends and the account charges.

Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) The investment objective of these funds seeks capital appreciation and maximum long-term capital growth. The portfolio invest mainly in common stocks of companies in the United States and foreign countries.
- (b) The investment objective of these funds is to seek long-term capital appreciation. Under normal market conditions, the portfolio invests the majority of its net assets in equity securities.
- (c) The investment objective of these funds is to seek long-term growth of principal and income. A secondary objective is to achieve a reasonable current income. The portfolio primarily invests in larger mature companies.
- (d) The investment objective of these funds is to seek income or growth of income, with less emphasis on capital appreciation. The portfolio primarily invests in bonds, a portion of which may be in high risk, below investment grade securities.
- (e) The investment objective of these funds is to seek a high total investment return with preservation of capital and prudent investment risk. The portfolio invests in a combination of equity securities, debt instruments, and money market instruments.
- (f) The investment objective of these funds seeks total return consistent with an asset allocation targeted to retirement at a specified date. The underlying funds invest in U.S. stocks, international stocks, U.S. bonds, and other debt instruments, and the portfolio uses an asset allocation strategy designed for investors expecting to retire at a specified date.
- (g) The investment objective of these funds is to seek growth of capital. The fund invests primarily in common stocks and seeks to invest in companies that appear to offer superior opportunities for growth of capital.
- (h) The investment objective of these funds is to provide high current return, consistent with preservation of capital and liquidity, through investment in high quality money market instruments while maintaining a stable share price of \$1.00. The portfolio invests in a portfolio of high quality U.S. dollar denominated, short-term debt securities that are determined by the sub-adviser to present a minimal credit risk.

#### **Note 6 - Contract Value Measurements -**

The Plan holds a traditional fully benefit- responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company (Voya) totaling \$171,708 and \$147,494 as of December 31, 2024 and 2023, respectively. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a semiannual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the schedule maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include:

1. Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan),
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,

3. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan,
4. The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA,
5. Premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include:

1. An uncured violation of the Plan's investment guidelines,
2. A breach of material obligations under the contract,
3. A material misrepresentation,
4. A material amendment to the agreements without the consent of the issuer.

**Note 8 - Party-in-Interest Transactions -**

Certain plan investments are shares of pooled separate accounts managed by Voya Retirement Insurance and Annuity Company, the custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in investment income (loss), as they are paid through revenue sharing, rather than a direct payment. The Companies may also pay directly any other fees related to the Plan's operations. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note 9 - Delinquent Participant Contributions and Loan Payments -**

For the year ended December 31, 2024, participant deferrals totaling \$1,276, were not timely remitted to the Plan in accordance with the requirements of the Department of Labor. The contributions were remitted to the Plan upon discovery of the errors.
