### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of The Myers Industries Profit Sharing and 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

independent of The Myers Industries Profit Sharing and 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. ## NOTES TO FINANCIAL STATEMENTS

### The Myers Industries Profit Sharing and 401(k) Plan

#### 1 Description of Plan

The following description of The Myers Industries Profit Sharing and 401(k) Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### *General:*

The Plan was established in 1975 by Myers Industries, Inc. ("Company" and "Plan Administrator") to provide retirement benefits to eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The assets of the Plan are maintained, and transactions therein are executed, by Principal Life Insurance Company, the Plan's Trustee.

The Plan was amended effective May 20, 2024 and August 1, 2024 related to the acquisition of Signature Systems Group, LLC. Participants were able to participate in the plan in May 2024. Participant balances from Signature Systems, LLC 401(k) Plan were transferred into the Plan on August 5, 2024 in the amount of \$4,602,950.

##### *Eligibility:*

An employee is eligible to participate in the Plan if they are not a member of a union in which retirement benefits have been subjected to collective bargaining and are not covered under another qualified pension or profit-sharing plan maintained by the Company.

An employee must complete 30 days of service with the Company to be eligible for employee deferrals and the employer safe-harbor match.

##### *Contributions:*

Plan participants may make tax-deferred contributions to the Plan of 1% to 75% of their total compensation and may make Roth contributions. Voluntary after-tax contributions to the Plan are not permitted. The Plan also allows catch up contributions up to the Internal Revenue Service limits for certain participants who are eligible.

Employees who have completed 30 days of service are automatically enrolled in the Plan with a deferral withholding rate of 3%. Participants have the ability to opt out of the Plan prior to automatic enrollment. The automatic salary deferral will increase by 1% per Plan year up to a maximum of 10% of eligible compensation, as defined by the Plan.

The Company makes safe-harbor contributions to each eligible participant's account by matching 100% of the first 3%, and 50% of the next 2% of their total compensation.

Rollover contributions are permitted to be deposited into the Plan at the discretion of the Trust Committee.

## NOTES TO FINANCIAL STATEMENTS

### The Myers Industries Profit Sharing and 401(k) Plan

#### 1 Description of Plan, Continued

##### *Participants' Accounts:*

401(k) Accounts - Each participant's account is credited with the participant's elective contributions, employer matching contributions, earnings and losses, and expenses thereon.

##### *Vesting:*

Participants are 100% vested in safe-harbor employer matching contributions after one year of service. If a participant has a separation from service on account of death, retirement or disability retirement, the participant will be deemed fully vested in their profit sharing contributions. Otherwise, vesting in the profit sharing portion of the Plan shall be 0% until the employee has completed two years of vesting service, at which time they will become 20% vested with an additional 20% for each additional year of service completed. Participants are fully vested upon completion of six years of service.

##### *Forfeitures:*

Forfeitures are deposited into a suspense account maintained and invested by Principal Life Insurance Company. The forfeiture suspense account is adjusted for earnings and losses until it is allocated among the eligible participants or used to reduce the employer matching contribution, in accordance with Plan provisions. As of December 31, \$148,766 (2024) and \$21,154 (2023) were available for allocation to participants.

##### *Notes Receivable from Participants:*

Participant loans are classified as notes receivable from participants, which are segregated from Plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

The Plan allows for participants to borrow from the 401(k) portion of their account a minimum of \$1,000 and a maximum of 50% of their vested balance up to \$50,000. The interest rate must be a reasonable rate as determined by the Plan Administrator. Maturities on these loans must be greater than six months and not exceed five years, unless the loan is for the purchase of a home, in which case the loan maturity may be for a period of up to ten years. The loans are secured by the balance in the participant's account.

##### *Other Plan Provisions:*

Normal retirement age is 65, however, a participant may elect early retirement on or after age 60. The Plan also provides for early payment of benefits after reaching age 59-1/2.

## NOTES TO FINANCIAL STATEMENTS

### The Myers Industries Profit Sharing and 401(k) Plan

#### **1 Description of Plan, Continued**

##### ***Payment of Benefits:***

Upon retirement at age 65, with provisions for early or delayed retirement, total and permanent disability, death, termination or financial hardship, the participant or beneficiary may elect to receive a benefit payment.

Benefit payments are paid directly to the participant from the net assets available for benefits and are made in lump sum amounts subject to the provisions of the Plan. As of December 31, 2024 and 2023, there were no participants who elected to withdraw funds, but had not been paid.

##### ***Hardship Withdrawals:***

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

##### ***Investment Options:***

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the participant-directed portion of the Plan.

#### **2 Summary of Significant Accounting Policies**

##### ***Basis of Accounting:***

The Plan's transactions are reported on the accrual basis of accounting.

##### ***Valuation of Investments:***

Investments are stated at fair value. Marketable securities (mutual funds) are reported at fair market value as of the balance sheet date. Fair market values of the mutual funds represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. Fair market values of the pooled separate accounts are based on the net fair value of the underlying assets and the net asset value. The fair value of the stable value fund is based on the contract value of the fund (contract value approximates fair value).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as held during the year.

##### ***Use of Estimates:***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

## NOTES TO FINANCIAL STATEMENTS

### The Myers Industries Profit Sharing and 401(k) Plan

#### **2 Summary of Significant Accounting Policies, Continued**

##### ***Administrative Fees:***

Administrative expenses of the Plan are primarily paid by the Plan.

##### ***Plan Termination:***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

##### ***Risks and Uncertainties:***

The Plan's investment includes investments in mutual funds, pooled separate accounts and a stable value fund with varying degrees of risk, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

##### ***Contributions:***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

##### ***Subsequent Events:***

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

#### **3 Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

## NOTES TO FINANCIAL STATEMENTS

#### 3 Fair Value Measurements, Continued

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets.
- \* Quoted prices for identical or similar assets or liabilities in inactive markets.
- \* Inputs other than quoted prices that are observable for the asset or liability.
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds:***

The fair value of the mutual funds is based on quoted market prices and are classified in the Level 1 category of the valuation hierarchy.

#### ***Stable Value Fund/Common Collective Trust:***

The fair value of the stable value fund is based on the contract value of the fund (contract value approximates fair value). The fair value is expressed in units. The stable value fund is valued based on NAV as the practical expedient, as they can be redeemed at their net asset value on their measurement date. The stable value fund can be redeemed on a daily basis, and there are no unfunded commitments.

#### ***Pooled Separate Accounts:***

The fair values of the pooled separate accounts are based on the net fair value of the underlying assets. The underlying investments are valued at fair value based on commercial quotation services. The fair value is allocated among the contract holders based on a unit value. The pooled separate accounts are valued based on NAV as the practical expedient, as they can be redeemed at their net asset value on their measurement date. The pooled separate accounts can be redeemed on a daily basis, and there are no unfunded commitments.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

**4 Tax Status**

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities.

The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there were no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.
