Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Seurat Technologies 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS**

A. DESCRIPTION OF PLAN:

The following description of Seurat Technologies 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. General - The Plan is a defined contribution plan covering substantially all employees of Seurat Technologies, Inc. (the Employer) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan excludes bargaining employees, nonresident aliens with no U.S. income, leased employees, and intern employees who are regularly scheduled to work less than 1,000 hours of service in an entry service period.
2. Eligibility - Employees age 18 or older are eligible to participate in all components of the Plan.
3. Contributions - Eligible participants are permitted to elect to have a dollar amount or percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) and/or after-tax Roth contributions to the Plan. Participants age 50 or older are allowed to make catch-up contributions.

The Employer will make a safe harbor matching contribution to the Plan at a rate of 100% of the first 4% of eligible participants' compensation contributed to the Plan.

The Employer may, at its discretion, elect to make a discretionary contribution to the Plan. There were no discretionary contributions for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

4. Participant Accounts - Each participant's account is credited with the participant's contributions, the Employer's contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.
5. Vesting - Participants are immediately vested in their contributions, safe harbor matching contributions, and discretionary contributions plus actual earnings thereon.
6. Notes Receivable From Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.
7. Payments of Benefits - Upon termination of service, death, disability, or retirement (age 65), a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 59 1/2 and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Administrator may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

A. DESCRIPTION OF PLAN: (Continued)

8. Forfeitures - Any forfeiture that takes place during the year is first used to reduce administrative expenses and then will be used to reduce any future employer contributions under the plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled zero. There were no forfeitures used to reduce Employer contributions for the years ended December 31, 2024 and 2023. There were no forfeitures used to pay administrative expenses for the years ended December 31, 2024 and 2023.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

1. Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.
2. Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, and the participant note balance is reduced and a benefit payment is recorded.
5. Benefit Payments - Benefits are recorded when paid.
6. Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan or the Employer, as provided by the Plan document. Expenses paid directly by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

C. INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED):

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Human Interest Inc., the qualified institution of the Plan through December 31, 2023, has certified to the completeness and accuracy of notes receivable from participants and investment information reflected on the accompanying statement of net assets available for benefits as of December 31, 2023.

Principal Trust Company, the qualified institution of the Plan effective January 1, 2024, has certified to the completeness and accuracy of notes receivable from participants and investment information reflected on the accompanying statement of net assets available for benefits as of December 31, 2024, the schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets for the year ended December 31, 2024.

D. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Collective Investment Trusts - The Collective Investment Trusts held by the Plan during 2024 consist of Principal LifeTime Hybrid Income Collective Investment Trusts. The Funds are investment companies based on the characteristics defined in Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 946, Financial Services - Investment Companies. Investments in investment companies are valued at their net asset value ("NAV") per unit as of the close of business on the valuation date and are included in Level 1. Collective trusts and pooled separate accounts are valued using the NAV as a practical expedient, which represents the price at which the Fund is able to initiate a transaction.

Money Markets - The money market fund held by the Plan during 2023 is a master deposit account. The fund seeks to maintain a constant NAV of \$1 per share by investing in high-quality, U.S. dollar denominated money market securities.

D. FAIR VALUE MEASUREMENTS: (Continued)

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts - Investments in investment companies are valued at their NAV per unit as of the close of business on the valuation date and are included in Level 1. Collective trusts and pooled separate accounts are valued using the NAV as a practical expedient, which represents the price at which the Fund is able to initiate a transaction.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. INVESTMENT CONTRACT WITH INSURANCE COMPANY:

The Plan's Stable Value Guaranteed Income Fund provided through a group annuity contract with Principal Trust Company is considered fully benefit-responsive and is recorded at contract value.

The account is credited with earnings based on the underlying investments guaranteed specific rate of interest and charged for participant withdrawals and administrative expenses. Contributions are maintained in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Trust Company, represents contributions made under the contract, plus earnings and credited interest, less participant withdrawals and investment fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

E. INVESTMENT CONTRACT WITH INSURANCE COMPANY: (Continued)

Contract value may be subject to adjustments in connection with contract holder directed withdrawals that are subject to market value adjustment.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the contract issuer, however, it may not be less than 0.15% or greater than 3%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Employer, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the plan participants are probable of occurring.

In addition, certain events allow the contract issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the contract issuer.

The contract value at December 31, 2024 and 2023 was \$1,748,126 and zero, respectively.

F. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

G. PLAN TERMINATION:

The Employer has stated its intent to continue the Plan indefinitely; however, continuation of the Plan is voluntary on the part of the Employer, and the Employer reserves the right to modify or terminate the Plan at any time. In the event of Plan termination, participants will remain 100% vested in their accounts, net of any expenses necessary to terminate the Plan.

H. TAX STATUS:

The Plan is placing reliance on an opinion letter dated June 30, 2020 received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Employer has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan investments are managed by Delaware Charter Guarantee & Trust Company dba: Principal Trust Company. Delaware Charter Guarantee & Trust Company dba: Principal Trust Company is the qualified institution of the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

J. SUBSEQUENT EVENTS:

Management has evaluated events occurring after the statement of net assets available for benefits date through September 25, 2025, the date on which the financial statements were available to be issued. No material events have been identified which would require disclosure.
