1. DESCRIPTION OF THE PLAN

The following description of the JTL Leasing FLP 401(k) Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan's provisions. The Plan Administrator is responsible for oversight of the Plan and monitors investment performance.

General - The Plan is a defined contribution plan covering substantially all employees of Dodge City Motors, Inc.; Lewis Automotive Group, Inc.; Lewis Motors, Inc.; Lewis Chrysler, Inc.; JTL Leasing FLP; Garden City Motors, LLC; Ralph Motors, LLC; LAG Rentals, LLC; Lewis Chevrolet of Dodge City, LLC; Lewis Ford of Dodge City, Inc.; and Lewis Chevrolet of Liberal LLC (collectively, the Company) which constitute a controlled group under Internal Revenue Code 414(b) and 414(c) excluding collective bargaining (union) employees, leased employees, an individual considered to be an independent contractor who is later determined by the Internal Revenue Service to be an employee, or consultants. Employees who are at least age 21 become eligible to participate in the Plan on the first day of the calendar quarter following completion of one year (1,000 hours) of service hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute up to 75% of eligible pre-tax, post-tax or a combination thereof annual compensation, up to the maximum allowed by the Internal Revenue Code (\$23,000 for 2024). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 for 2024). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company is not required to make a matching contribution to the Plan. The Company made a discretionary match contribution equal to 50% of employee deferrals up to 6% of employee compensation. Participants may direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts - Each participant's account is credited with the participant's contribution, the Company's contribution, and Plan earnings, and charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of participants' accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

Normal Retirement - Normal retirement age is 59.5 years of age.

Payment of Benefits - On termination of service, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or delay receipt of benefits through fixed period and fixed payment installment options.

Forfeitures - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$29,078 and \$14,433, respectively. Forfeitures may be used to reduce the Company's discretionary

contribution and to pay Plan expenses. In 2024, \$12,567 from forfeited nonvested accounts was used to reduce employer contributions and pay plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates - The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect: (1) the reported amounts of assets and liabilities, (2) disclosures such as contingencies, and (3) the reported amounts of revenues and expenses included in such financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition - Investments are valued at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor, custodian, and insurance company. The purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Contributions - Contributions from plan participants and the Company discretionary matching contributions are recorded in the year in which contributions are withheld from compensation.

Benefits Paid - Benefits are recorded when paid.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction in contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Administrative and Other Expenses - Certain expenses of the Plan may be paid directly by the Company and are therefore excluded from these financial statements. Some investment related expenses may be included in net change in fair value of investments.

Subsequent Events - These financial statements considered subsequent events through September 24, 2025, the date the financial statements were available to be issued.

4. INVESTMENTS AND FAIR VALUE MEASUREMENTS

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The following describes three levels of inputs that may be used to measure fair value:

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the

valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds - These investments are valued using a quoted price in an active market.

Common Collective Trust - These investments are valued at the Net Asset Value (NAV). The NAV, as provided by Principal, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

Pooled Separate Accounts - These investments are valued at the NAV. The NAV, as provided by Principal, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

5. GROUP ANNUITY CONTRACT WITH PRINCIPAL LIFE INSURANCE COMPANY (UNAUDITED)

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal Life) totaling \$245,886 and \$275,303 for 2024 and 2023, respectively. Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.2%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit Principal Life to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transaction under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

5. GROUP ANNUITY CONTRACT WITH PRINCIPAL LIFE INSURANCE COMPANY (UNAUDITED) (CONTINUED)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are invested and managed by Principal, and therefore, these transactions qualify as party-in-interest transactions. The various funds' operating expense ratios ranged from 0.00% to 0.95%, as of December 31, 2024. The Plan paid \$25,995 for administrative expenses for the year ended December 31, 2024.

7. TAX STATUS

The Plan adopted a Prototype Non-standardized Profit-Sharing Plan designed to qualify under Section 401 of the Internal Revenue Code (IRC). The Plan has obtained a copy of a favorable determination letter for the prototype non-standardized profit-sharing plan dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRC. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management evaluated the Plan's tax positions and concluded that it had taken no uncertain tax positions that require recognition or disclosure in the financial statements. No provision or liability for income taxes has been included in the financial statements.

8. PLAN TERMINATION

Although it has not expressed an intention to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, the interests of the participants in the Plan shall be fully vested at the time of termination, and Principal shall liquidate all assets of the trust and continue to administer the trust in accordance with its provisions until all obligations have been satisfied.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
