Effective for the Plan Year ended December 31, 2024, there has been a change in the valuation software. In accordance with Revenue Procedure 2017-56, the following conditions have been met:

1. There has been both a change in the enrolled actuary for the plan and a change in the business organization providing actuarial services to the plan;
2. The method used by the new actuary is substantially the same as the method used by the prior actuary and is consistent with the information contained in the prior actuarial valuation reports or prior Schedules SB of Form 5500. Also, the method used by the new actuary has been applied to the prior year (using the assumptions of the prior actuary) and the absolute value of each resulting difference in target normal cost and funding target, that is attributable to the change in cost method, does not exceed three percent (3%) of the respective amounts calculated by the prior actuary for that year;
3. The actuarial value of plan assets, as determined by the new enrolled actuary as of the valuation date for the prior plan year (using the actuarial assumptions of the prior enrolled actuary), is within 2% of the value for that prior plan year as determined by the prior enrolled actuary.
4. The change in costs due to the change in method is treated in the same manner as an experience gain or loss;
5. The Plan Administrator agrees with this change and has been made aware of this change prior to the filing of the Schedule SB.
6. In accordance with Section 4.01 of Rev. Proc. 2017-56 the valuation date has been changed from the first day of the Plan year to the last day of the Plan year.
7. The new valuation software is generally used by the enrolled actuary for the single-employer plans to which the enrolled actuary provides actuarial services.
8. For either the prior plan year or the current plan year, the funding target, target normal cost (without regard to any adjustment for employee contributions and plan-related expenses), and actuarial value of plan assets determined under the new valuation software are each within 2% of the respective values under the valuation software used for the prior plan year (all other factors being held constant).
9. The modifications to the computations in the valuation software or the use of a different valuation software system are designed to produce results that are no less accurate than the results produced prior to the modifications or change.
