Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sarnova HC, LLC Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Sarnova HC, LLC (the “Company”) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering employees of the Company who are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Transfer: On November 14, 2024, the Plan was amended and the respective assets of the Cignet, LLC 401(k) Plan related to the employees of One Beat CPR Learning Center, LLC (“One Beat”), were transferred into the Plan. The assets of employees of One Beat were included in an existing plan controlled by Cignet, LLC. One Beat CPR Learning Center, LLC was acquired by the Company in May 2024. The transfer increased net assets of the Plan by \$1,239,966.

Prior to the transfer, participants of the Cignet, LLC 401(k) Plan, inclusive of One Beat eligible employees, were subject to a vesting schedule based on years of service. Following the transfer, these participants will continue to follow the same vesting schedule until fully vested. No changes to vesting provisions occurred as a result of the plan transfer.

In-service withdrawal provisions were grandfathered into the Plan for One Beat participants. All other terms and provisions of the Sarnova HC LLC Profit Sharing Plan and Trust, including eligibility and contribution limits apply to the transferred participants.

Participant Contributions: Each year, participants may contribute a maximum dollar amount as determined by the Federal Government. For 2024, the maximum dollar amount was \$23,000. Eligible participants who have attained age 50 prior to the close of a Plan year are also eligible to make a catch-up contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. As of December 31, 2024, the Plan offers a number of investment options in mutual funds, a self-directed brokerage account and a stable value fund. The Company, on a discretionary basis, contributes a matching amount as a percentage of the amount a participant contributes to the Plan. The matching Company contribution is invested in the investments as directed by the participants for their pre-tax deferrals. Additional amounts may be contributed at the option of the Company’s board of directors. Contributions are subject to certain limitations.

Automatic Enrollment: The Plan provides that if an associate meets the Plan’s eligibility requirements the associate may be automatically enrolled into the Plan. Pre-tax deferral contributions were deducted from the participants’ pay at a rate of 6% of eligible compensation for the year ended December 31, 2024. The participant may elect to not be enrolled. If the participant was enrolled prior to automatic enrollment plan provisions and has pre-tax deferral contributions below 6% of eligible compensation, the Plan provides for an automatic increase each year of the deferral contribution percentage. The annual increase was 1% limited to 6% of compensation for the year ended December 31, 2024. Participants may opt out of automatic escalation.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is generally 100% vested after four years of credited service.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years or up to a reasonable period of time for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at various interest rates ranging from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: If a participant's employment ceases as a result of normal retirement, death or disability, the participant or the participant's beneficiaries, are entitled to receive the entire contents of the account. If a participant terminates for any other reason, the participant is entitled to receive only the vested percentage of the account. Also, in service distributions are allowed, in addition to hardship distributions. Participants will receive benefits in a single lump sum.

Administrative Expenses: The costs of administering the Plan are paid for by the Company with the exception of certain recordkeeping fees, which are paid for by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees charged to the Plan are a reduction of investment return and included in the investment income (loss) reported by the Plan.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,635 and \$11,124, respectively. These accounts will be used to reduce future employer contributions. For the year ended December 31, 2024, \$190,541 in forfeitures were used to reduce employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Risks and Uncertainties: The Plan provides for various investment options in any combination of investments offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuations, liquidity, and credit risks. Due to the risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in market values, interest rates, or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Benefit Payments: Benefit payments are recorded when paid. Upon termination or after age 59 1/2, a participant may elect to receive a lump sum amount equal to the value of his or her vested balance in his or her account or a rollover to another qualified plan or individual retirement account.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) Topic 820 defines fair value as the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In many cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

Self-Directed Brokerage Accounts: These investments are brokerage accounts held at Charles Schwab and consist of publicly traded equity securities and mutual funds. Equity securities and mutual funds are valued at the closing price reported on the active market on which the individual securities are traded (Level 1 inputs).

Mutual Funds: The fair values of mutual funds are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust: The fair values of participation units held in the collective trust are based on the net asset values per unit as reported by the fund managers and in the audited financial statements of the fund. The fund provides for daily redemptions by the Plan at reported net asset value per share for participant transactions.

NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company, the trustee of the Plan.

NOTE 4 - TAX STATUS

The Plan sponsor adopted the restated version of a non-standardized Prototype Plan Document. The Internal Revenue Service has determined and informed the prototype plan sponsor, by a letter dated August 19, 2020, that the prototype plan, as then designed, was in compliance with applicable sections of the Internal Revenue Code (the "IRC"). Although the Plan has been amended from the original prototype document, Plan management believes the Plan is designed and is currently being operated in accordance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 - PARTIES-IN-INTEREST

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Certain administrative and fiduciary functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan invests in certain mutual funds managed by T. Rowe Price, an affiliate of the trustee, and a stable value fund managed by T. Rowe Price Trust Company, the trustee of the Plan. These investments and related investment income represent party-in-interest transactions to the Plan. T. Rowe Price Retirement Plan Services, Inc. is the Plan's recordkeeper, and contract administrative fees to this service provider qualify as party-in-interest transactions. Total fees paid to the service provider were not material for the year ended December 31, 2024. Notes receivable from participants and related interest represent party-in-interest transactions of the Plan.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through September 23, 2025 which is the date the financial statements were available to be issued.
