## Independent Auditors' Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Fire-Dex, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ### NOTES TO FINANCIAL STATEMENTS

#### **Note 1. Description of Plan**

The following description of the Fire-Dex, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General:

The Plan began November 1, 1997 and is a defined contribution plan covering substantially all employees of Fire-Dex, LLC and its subsidiaries (the "Company"), excluding union employees and leased employees. The Plan covers employees who have completed at least 90 days of eligible service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

##### Contributions:

Participants may make pre-tax contributions in any amount up to 100% of their eligible compensation as defined by the Plan, subject to certain limits imposed by the Internal Revenue Service ("IRS"). Participants may also make Roth contributions in any amount up to 100% of their eligible compensation, and may elect to make in-plan transfers of their vested accounts into Roth accounts in accordance with the terms of the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan also provides that participants who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan may also make catch-up contributions, subject to certain IRS limitations.

The Plan requires an employer safe harbor matching contribution equal to 100% of participant's contributions that do not exceed 3% of a participant's eligible compensation plus 50% of a participant's contributions between 3% and 5% of eligible compensation. The Company may also make a discretionary matching contribution which will not exceed 4% of a participant's eligible compensation, and a discretionary profit sharing contribution. No discretionary matching contributions or discretionary profit sharing contributions were made for the year ended December 31, 2024.

In addition, employer safe harbor true-up matching contributions ("True-Ups") may be required. True-Ups in the amount of \$11,340 and \$7,433 were due to the Plan at December 31, 2024 and 2023, respectively. During 2025, \$1,922 of forfeited non-vested accounts was utilized to satisfy the True-Ups due at December 31, 2024 and is netted with the employer contributions receivable at December 31, 2024. During 2024, \$6,672 of forfeited non-vested accounts was utilized to satisfy the True-Ups due at December 31, 2023 and is netted with the employer contributions receivable at December 31, 2023.

##### Participant Accounts:

Each participant's account is credited with the participant's contribution, any Company contribution, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants direct their investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 1. Description of Plan (Continued)**

Notes Receivable From Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to one-half of their vested account balance under the Plan, not to exceed \$50,000. The loans are secured by the balance in the participant's account and bear interest at the prime rate. Principal and interest is paid ratably through payroll deductions.

Vesting:

Participants are vested immediately in their contributions and employer safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution and discretionary profit sharing contribution portions of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service (0% in years one and two, 100% in year three), or in the event of death, disability, or attaining normal retirement age as defined by the Plan.

Payment of Benefits:

Upon termination of employment, death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. The Plan also provides for in-service distributions upon attaining age 59-1/2, and hardship withdrawals, subject to certain limitations.

Forfeited Accounts:

Any forfeited non-vested accounts may be used to reduce future employer contributions. At December 31, 2024 and 2023, there was -\$0- and \$431, respectively, of unutilized forfeited non-vested accounts.

**Note 2. Summary of Significant Accounting Policies**

- A. Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").
- B. Investment Valuation and Income Recognition – Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by Empower Annuity Insurance Company of America ("Empower"), the Custodian of the Plan. On December 31, 2020, Empower Retirement LLC acquired the retirement business of Massachusetts Mutual Life Insurance Company ("MassMutual"), the previous custodian of the Plan and issuer of the Plan's current insurance contract. Following an initial transition period, Empower Retirement LLC became the sole administrator of the Plan's contract during 2021. Empower is an affiliate of Empower Retirement LLC. See Note 5 for discussion of fair value measurements.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 2. Summary of Significant Accounting Policies (Continued)**

**B. Investment Valuation and Income Recognition (Continued):**

Purchases and sales of securities are recorded on a settlement-date basis. Interest income is recorded when received. There is no significant difference between this methodology and the accrual basis of accounting for the periods presented. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**C. Notes Receivable From Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the plan document.

**D. Administrative Fees** – Fees of the Plan are paid by the Company or the Plan at the discretion of the Company. In addition, certain transactions and account maintenance fees are charged to the affected participants. Fee credit payments are made from excess revenue generated by the Plan through fund revenue or fees that are made available to the Plan. The Company monitors the payments received by the Plan service providers to ensure that they are used properly for qualifying Plan purposes. Revenue sharing income totaling \$8,278 was received by the Plan during the year ended December 31, 2024 and is included in administrative fees.

**E. Use of Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**F. Benefit Payments** – Benefits are recorded when paid.

**G. Subsequent Events** – The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

**Note 3. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested and receive a total distribution of their account.

**Note 4. Unaudited Information**

The Custodian of the Plan holds the Plan's investment assets and executes transactions therein. The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the plan administrator received a certification from Empower Annuity Insurance Company of America acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the statements of net assets available for benefits at December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) at December 31, 2024, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 5. Fair Value Measurements**

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

Level 1 – Quoted market prices in active markets for identical assets and liabilities

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data

Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodology used for plan assets measured at fair value:

- The investments in pooled separate accounts are held and managed by MassMutual. The fair value of investments held in these accounts is based on their reported net asset value ("NAV"). The NAV is based primarily on observable inputs and the market value of the underlying investments, and is classified as Level 2.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. There have been no changes in the methodology used from 2023 to 2024. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6. Group Annuity Contract**

Investments in the MassMutual Fixed Account meet the fully benefit-responsive investment contract criteria and are, therefore, reported at contract value as determined and certified by Empower. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. All transactions within this contract are executed at contract value including full liquidation of the fund.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on several factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. These rates are established without the use of a specific formula and are reset annually as determined by Empower. The crediting interest rate is guaranteed to be at least 1%.

The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 6. Group Annuity Contract (Continued)**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**Note 7. Income Tax Status**

The Plan has adopted a prototype plan document. This plan document has obtained an opinion letter dated June 30, 2020 from the IRS in which the IRS stated that the document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the prototype plan document, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The Plan's management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

**Note 8. Party-in-Interest Transactions**

Plan investments are held in pooled separate accounts and a group annuity contract managed by the Custodian or an affiliate. In addition, administrative expenses were paid to the Custodian or their affiliates during the year ended December 31, 2024. These transactions qualify as party-in-interest transactions.

**Note 9. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
