*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of RPA Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

*Opinion*

#### Note 1 - Description of Plan

The following description of RPA Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan under Section 401(a) of the Internal Revenue Code ("IRC"). The Plan was established on November 1, 1986, for the benefit of eligible employees of Rubin Postaer and Associates (the "Company", the "Employer" or the "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Certain officers of the Plan Sponsor are responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to these officers. Employees who are 21 years old are immediately eligible to make contributions to the Plan. The profit-sharing feature and 401(k) discretionary employer matching contribution cover all employees of the Company who have completed one year of service and are age 21 or older. The entry dates are the first day of the Plan year and the first day of the seventh month of the Plan year following the date the employee meets the eligibility requirements.

##### **Contributions**

Each year, participants may elect to contribute up to 15% of their pre-tax or after-tax annual compensation, as defined in the Plan. Participants who have attained 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

The Company may make discretionary matching 401(k) contributions for eligible participants up to 50% of the first 7% of the participant's eligible compensation. The Company may also make discretionary profit-sharing contributions. For the year ended December 31, 2024, no matching or discretionary profit sharing contributions were made.

Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

##### **Participant accounts**

Each participant's account is credited with the participant's contributions and Company discretionary matching contributions, as well as allocations of the Company's profit-sharing contribution, Plan earnings and forfeitures of terminated participants' nonvested accounts not utilized by the Company. Participants' accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are vested immediately in their contributions and rollovers from other plans plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing and matching 401(k) contributions plus actual earnings thereon is based on years of service. A participant is 100% vested after six years of credited service.

Participants also become fully vested at their normal retirement age of 65, and upon death, retirement due to disability or termination of the Plan.

#### Notes receivable from participants

Participants may borrow from their vested funds, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loan interest rate is set at prime rate, as defined, plus 1% on the last day of each month. The notes receivable is secured by the balance in the participant's account. Principal and interest are paid ratably through semi-monthly payroll deductions.

Any unpaid balances are due upon termination of employment. If not repaid based on the terms of the loan, the unpaid balances are reclassified as a distribution to the participant. In the event a participant is laid off for economic reasons and has an unpaid note principal balance greater than \$25,000, special consideration will be given to accept payments by check directly to the Company for a period up to 12 months from the date of termination, not to exceed the original note term payoff date.

#### Payment of benefits

On termination of service due to death, disability or normal retirement, a participant or the participant's beneficiaries may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments or an annuity contract. For termination of service due to other reasons, a participant may receive only the value of the vested interest in his or her account. Accounts with values greater than \$7,000 can be distributed in a lump-sum distribution or installment payments. Accounts with values less than \$7,000 but greater than \$1,000 are automatically rolled into a Merrill Lynch Individual Retirement Rollover Account, unless the participant elects to receive a distribution or roll over into an eligible retirement plan. Accounts with a value of \$1,000 or less are automatically distributed to participants.

#### Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$54,515 and \$71,370, respectively. These accounts will be used to reduce future employer contributions. Any remaining forfeitures will be used to offset Plan administration expenses. For the year ended December 31, 2024, \$71,370 from forfeited nonvested accounts was used to reduce 2023 employer contributions made in 2024 and \$17,257 was used offset Plan administration expenses.

### Note 2 - Summary of significant accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance companies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### **Subsequent events**

The Plan has evaluated subsequent events through September 24, 2025, which is the date the financial statements were available to be issued.

### **Note 3 - Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under the Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market funds:* Consists of obligations issued or guaranteed as to principal and interest payments issued by the U.S. Government or its agencies. These U.S. Government obligations are valued at amortized cost, which approximates fair value.

*Collective trust funds:* Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### Note 4 - Related party transactions and parties-in-interest transactions

The Plan's investment assets represent funds invested in or maintained by Bank of America and BlackRock, Inc. ("BlackRock"). In 2006, Merrill Lynch and BlackRock combined their investment management divisions. Bank of America, N.A., formerly Merrill Lynch, is the trustee of the Plan and, therefore, these investments represent exempt party-in-interest transactions. Fees paid by the Plan for administration and recordkeeping services amounted to \$72,021 for the Plan year ended December 31, 2024.

#### Note 5 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### Note 6 - Tax status

The IRS has informed the trustee by a letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan used to establish the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

### **Notes to Financial Statements December 31, 2024**

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 8 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee of the Plan.

#### **Note 9 - Amounts allocated to persons withdrawn from participation**

At December 31, 2024 and 2023, there was \$92,881 and \$622,579, respectively, allocated to the accounts of individuals who had withdrawn from participation in the Plan.
