## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Contractors Plan Trust Health Reimbursement Arrangement

### **Opinion**

We have audited the accompanying financial statements of Contractors Plan Trust Health Reimbursement Arrangement (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Contractors Plan Trust Health Reimbursement Arrangement as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

1. DESCRIPTION OF THE PLAN

The following description of Contractors Plan Trust Health Reimbursement Arrangement (the "Plan") provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

The Plan has been established as a health reimbursement arrangement, as defined in the Internal Revenue Code (the "Code") and the Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan is part of The Contractors Plan Trust II ("Trust"). The Plan's custodian is American Bank of Commerce (the "Custodian"). Fringe Benefit Group, Inc. ("FBG") serves as the third party administrator and recordkeeper to the Plan. FBG is responsible for determining whether claimed benefits are provided for by the Plan, processing claim payments, ensuring the claim payments are correct and within the payment limits stipulated by the Plan, and maintaining all documentation in support of claim payments. Hamilton Construction Company (the "Sponsor" or "Employer") serves as Plan sponsor.

Eligibility

The Plan is offered to two categories of employees: administrative employees and craft employees. For both categories, eligibility for participation in the HRA requires employees to work 30 or more hours per week for both 2024 and 2023. Both administrative and craft employees must be either be enrolled in the company-sponsored Major Medical plan, or registered in a valid other employer-sponsored health plan for the 2024 plan year. For the 2023 plan year, administrative employees must enroll in the company-sponsored Major Medical plan to be eligible, whereas all craft employees are eligible to enroll in the plan; however, contributions to the HRA are made only if the employee is actively providing services on a project or contract subject to prevailing wage laws. In certain cases, management may elect to provide a discretionary HRA contribution for craft employees working on nonprevailing wage jobs. The date of eligibility begins on the first of the month following 60 days of continuous employment. They will become a participant in the Plan on that date. Former employees are eligible to use up their remaining Plan funds until their account has been depleted.

Benefits

The Plan provides for reimbursement of qualifying medical expenses and covers eligible employees of the Sponsor from the participant's Health Reimbursement Account ("HRA"). Each participant's benefits are limited to the amount contributed by the Sponsor annually. Remaining funds stay in the participant's HRA until used.

1. DESCRIPTION OF THE PLAN (continued)

Employer contributions

For craft employees, Employer contributions are based on government determined prevailing wages. The Sponsor provides an hourly rate contribution which covers the cost of participant benefits. Any funds remaining after paying the employee's benefits are allocated to a premium reserve account. The premium reserve account accumulates up to two month of premiums for all benefits. Any excess funds are deposited into the HRA and made available for use in reimbursing the participant's eligible medical, prescription drug, dental, or vision claims, or any Medicare premiums. For administrative employees, Employer contributions are at a set rate as agreed upon by the Sponsor. Contributions to eligible employee accounts accumulate up to an annual maximum determined by the Company. Contributions to eligible craft employee accounts could accumulate up to an annual maximum of \$2,500 in 2024 and \$5,000 (if elected) or \$2,500 (if defaulted) in 2023. Administrative employees could accumulate up to \$2,080 in both 2024 and 2023, respectively.

Plan terminations

Although it has not expressed any interest to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, all assets of the Plan go first to pay Plan administrative expenses and then to pay benefits of Plan participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of estimates

The preparation of the financial statements in conformity with US GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Actual results could differ from these estimates.

Employer contributions

The Plan is funded exclusively through Employer contributions. Employer contributions are recognized when received and allocated to participant accounts based on eligibility and plan provisions. Unused balances may be carried forward.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Due from Plan sponsor

Represents the amount that the Plan Sponsor is obligated to contribute under the terms of the Plan for work that administrative participants performed prior to January 1, 2022. The Plan's management considered all receivables to be fully collectible. Accordingly, there is no allowance for uncollectible amounts.

Payment of benefits

Claim payments are recorded when paid by FBG.

Expenses

Administrative expenses are recorded to the Plan up to \$6.50 per month per participant or the remaining funds within the participant's account.

Subsequent events

The Plan has evaluated subsequent events through September 8, 2025, which is the date the financial statements were available to be issued.

3. INTEREST TRUST

The Plan utilizes The Contractors Trust Plan II (the Trust), which is a trust arrangement maintained FBG for the benefit of multiple employee benefit plans. The Trust holds all employer contributions made to the Plan. As of the date of this financial statement, the Trust assets solely consisted of non-interest bearing cash, which represents readily available funds to reimburse participants for qualified medical expenses incurred under the Plan.

The value of the Plan's interest in the Trust is based on the beginning of year value of the Plan's interest in the Trust plus actual contributions less payments and administrative expenses. As of December 31, 2024 and 2023, the Plan's interest in the net assets of the Trust was approximately 14% and 13%, respectively.

4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan paid expenses that consist primarily of administrative fees paid to FBG. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

5. TAX STATUS

The trust established under the Plan to hold the Plan's net assets is a welfare benefit fund as defined in Section 419 of the Internal Revenue Code. As such, contributions to this welfare benefit fund by the Sponsor is subjected to certain limitations. The Trust is subject to federal income tax on unrelated income. For the years ended December 31, 2024 and 2023, the Trust paid no income taxes because there was no unrelated income earned by the Trust.

In accordance with guidance on accounting for uncertainty in income taxes, management has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. DUE FROM PLAN SPONSOR

Prior to January 2022, participants included in the plan solely consisted of craft employees. Upon the restatement of the Plan, the balances pertaining to administrative employees as of December 31, 2021, were transferred into the Plan. However, management elected to transfer cash related to these balances on a discretionary basis. The initial balance upon transfer was \$370,065. During 2024 and 2023, management settled \$20,626 and \$1,280, respectively, with \$37,965 and \$58,591 remaining as of December 31, 2024 and 2023, respectively. The Plan's management deems all balances to be fully collectible.

7. RISK AND UNCERTAINTIES

The Trust includes cash held within a financial institution. At times, such deposits may be in excess of the Federal Deposit Insurance Corporation ("FDIC") insurance limit. Plan management does not believe the Plan is exposed to any significant credit risk.
