NOTES TO THE FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023

NOTE 1 - PLAN DESCRIPTION

The following description of the Holzer Health System 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General - The Plan was established on August 1, 2000 and was restated effective January 1, 2013. It is a defined contribution plan covering all who are employed by Holzer Clinic, LLC; Holzer Hospital Foundation; Holzer Medical Center - Jackson; Holzer Senior Care Center; Gallia Health Partners, LLC; and Jackson Health Partners, LLC (the Companies). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participation in the Plan commences immediately.

Contributions - Each year, participants may contribute up to 100% of pretax or after-tax annual compensation, as defined in the Plan and subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and common collective trust funds as investment options for participants. Employer contributions are not permitted under the Plan.

Participant Accounts - Each participant's account is credited with the participant's contribution and an allocation of (a) Plan earnings and (b) administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The number of outstanding loans is limited to one per participant. Loans are secured by the balance in the participant's account and bear a reasonable interest rate that is commensurate with the prime rate (7.50% at December 31, 2024 and 8.50% at December 31, 2023) plus 1% per year. Principal and interest is paid ratably through biweekly payroll deductions.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant or their beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by Plan management in the preparation of the accompanying statements of net assets available for benefits and related statement of changes in net assets available for benefits and the related notes to the financial statements follows:

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value, see Note 4), which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurement. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is written off and a benefit payment is recorded.

Payments of Benefits - Benefits paid to participants are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees incurred by, or attributable to, a particular participant account will be assessed against that individual participant's account. The Plan will charge to all participants on a pro rata basis, based on account balances, all other plan-related expenses not paid for by the Companies.

Risks and Uncertainties - The Plan invests in securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent events are defined as events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are issued or are available to be issued. Management has evaluated subsequent events through September 25, 2025, the date that the financial statements were issued.

NOTE 3 - FAIR VALUE MEASUREMENT

The Financial Accounting Standards Board (FASB) accounting standard for Fair Value Measurement establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Fixed Annuities:* The reported values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

*Variable Annuities:* Prices/unit values for variable annuity investment options are calculated daily by the annuity provider according to the methods described in the annuity contract.

*American United Life Insurance Annuities:* Reported at fair value. The valuation of the Plan's investments in the American United Life Insurance Annuities are calculated daily by quoted market prices and other observable data points such as standard interest rates, yield curves, implied volatilities or credit spreads.

*Common Collective Trusts:* Valued at the NAV of units of an insurance company collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments (consisting of guaranteed investment contracts, security-backed contracts and common collective trusts) held by the fund, less its liabilities. In accordance with the terms of the Plan of trust, the NAV of the fund is determined daily. Units are issued and redeemed at the latest NAV. Also, in accordance with the Plan trust, net investment income, if any, and realized and unrealized gains on investments are not distributed.

*Self-Directed Investments:* The following types of self-directed investments are valued as follows:

Common/Preferred Stock - Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Exchange-Traded Funds - Valued at the closing price reported on the active market on which the individual securities are traded.

Units in Trust - Valued at daily closing price as reported by the fund. Units in trust held by the Plan are open-end funds, and are required to publish their daily NAV to transact at that price. Units in Trust held by the Plan are deemed to be actively traded.

The methods described above might produce a fair value calculation that might not be indicative of net realizable value or reflective of future fair values. Further, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - INVESTMENT CONTRACT

The Plan maintains a group annuity contract that is a traditional fully benefit-responsive investment contract with American United Life Insurance Company (AUL) as of December 31, 2024 and 2023, which maintains the assets in an unallocated fixed index annuity that is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The contract is presented on the face of the statements of net assets available for benefits at contract value, which approximates fair value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer. The crediting interest rate is determined by AUL based on various factors, which include current economic and market conditions and the general interest rate environment, among other things. Such interest rates are reviewed on a semiannual basis for resetting.

Generally, there are not any events that could limit the ability of the Plan to transact at contract value to be paid within 90 days or in rare circumstances, contract value paid over time. The Plan administrator does not believe that the occurrence of any events that would limit the Plan's ability to transact at contract value with participants is probable.

NOTE 5 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEES

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, Empower Trust Company and American United Life Insurance Company, trustees of the Plan.

NOTE 6 - TAX STATUS

The Plan adopted a volume submitter plan with FIS Business Systems, which received an opinion letter on March 31, 2017, in which the IRS stated that the form of the Plan document was acceptable under the applicable requirements of the IRC. The Plan has been designed to qualify under Section 403(b) of the IRC. Although the Plan has been amended since receiving this opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions, however there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - PLAN TERMINATION

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue the Plan at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA. Certain administrative functions are performed by officers or employees of the Companies at no cost to the Plan. These transactions qualify as party-in-interest transactions.
