Opinion

We have audited the accompanying financial statements of the Teamsters Insurance Premium Reimbursement Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Teamsters Insurance Premium Reimbursement Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.


Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.





In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.



NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of the Teamsters Insurance Premium Reimbursement Fund (the Plan) is provided for general information purposes. Participants should refer to the Summary Plan Description for more complete information.

General - The Plan, created January 1, 2009, is the successor to the NLS-Teamsters Insurance Premium Reimbursement Trust previously created by National Linen Service and the Southern and Eastern Regions of the International Brotherhood of Teamsters. This Teamsters Insurance Premium Reimbursement Fund will reimburse retired employees and eligible spouses of participating employers, including ALSCO, Kellogg Snack Company and Aramark, for all or part of their COBRA premiums, marketplace premiums charged for an Affordable Care Act policy, or any other individual comprehensive medical benefit policy approved by the Plan's Board of Trustees (Trustees) until the earliest of:

- Reaching 65 years of age;
- Reaching the applicable lifetime reimbursement limit;
- Becoming eligible for group coverage from any other health plan including Medicare/Medicaid;
- Death; and
- In the case of an eligible spouse, upon receipt of 36 months of reimbursement after the ceasing of benefit payments to the applicable participant, the date no longer married to the applicable participant, or death.

Benefits - The Plan provides for the reimbursement of all or part of the premiums paid for insurance plans by the eligible participants on behalf of themselves and/or if applicable, eligible spouses. To be eligible for benefits from the Plan, one must:

- Be a retiree of a contributing employer;
- Have been in receipt of benefits from the NLS-Teamsters Insurance Premium Reimbursement Fund in the month of December 2008, or had at least 312 weeks of contributions made to the NLS-Teamsters Insurance Premium Reimbursement Fund and/or this Fund; and
- Not be eligible for medical benefits under any group health plan (except for COBRA continuation coverage under the Employer's group health plan) or Medicaid/Medicare.



NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Contributions - Contributions are made to the Plan in accordance with collective bargaining or participant agreements.

Fund Termination - The Trustees have the absolute right, in their sole discretion, to amend or terminate benefits for participants or spouses at any time. In the case of a termination, the Trustees would allocate the Plan's net assets to participants and beneficiaries in the manner specified by the Employee Retirement Income Security Act of 1974 (ERISA).

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates - The accompanying financial statements have been prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents - The Plan considers cash and cash equivalents to include cash on deposit with financial institutions, money market accounts, and other investments purchased with original maturities of 90 days or less.

Administrative Expenses - Administrative expenses are paid by the Plan.

Employer Contributions Receivable - This amount represents contributions received shortly after the close of the plan year. Therefore, an allowance for doubtful accounts is deemed unnecessary. Contributions receivable are stated at the amount management expects to collect from balances outstanding at year end. Based on a review of historical losses, current economic conditions and supportable and reasonable forecast assumptions, management has concluded that any expected credit losses on balances outstanding at year end will be immaterial.

Payment of Benefits - All claims are recorded by the Plan when paid.

NOTE 3. SIGNIFICANT PLAN AMENDMENTS

For the years ended December 31, 2024 and 2023, there were no significant amendments.



NOTE 4. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan shared offices, management, and staff with the Teamsters Joint Council No. 83 of Virginia Health and Welfare and Pension Funds. These funds have an expense sharing arrangement whereby most administrative expenses, including salaries, are shared. The Plan paid less than 1% of such expenses in 2024 and 2023. During the years ended December 31, 2024 and 2023, \$29,808 and \$42,761, respectively, were paid by the Plan in shared expenses under the expense sharing agreement. As of December 31, 2024 and 2023, the Plan owed \$14,749 and \$16,378, respectively, to the Teamsters Joint Council No. 83 of Virginia Health and Welfare Fund for shared expenses. These amounts were settled in the subsequent periods.

As disclosed in Note 2, the Plan pays certain administrative expenses of various service providers. These transactions are party in interest transactions under ERISA.

NOTE 5. TAX STATUS

The Plan has obtained a favorable determination on the Plan's tax status and is exempt from federal income taxes pursuant to Internal Revenue Code (IRC) 501(c)(9). The Plan has been amended since receiving that determination letter. However, the Plan's administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related Trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan's administrator is not aware of any uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements as of December 31, 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6. CONCENTRATION OF CONTRIBUTIONS SOURCES

The Plan has only two active employers, comprising all of the contributions, including 86% and 90% of total contributions from a single employer (ALSCO) in the years ended December 31, 2024 and 2023, respectively.

NOTE 7. LITIGATION

Based on the advice of Plan Counsel, there is no litigation, either pending or threatened, which would have a material adverse effect on the Plan's net assets available for benefits.



NOTE 8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through July 28, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
