Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of 403(b) Thrift Plan of Lawrence Family Jewish Community Center of San Diego County (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements (the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of the 403(b) Thrift Plan of Lawrence Family Jewish Community Center of San Diego County (the “Plan”) provides only general information. Participants should refer to the Plan agreement and the Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 2009 and was subsequently amended April 1, 2023. The Plan is a qualified, defined contribution plan covering all employees of Lawrence Family Jewish Community Center of San Diego County (the “Organization”) who elect to participate in the Plan. An employee is eligible to become a participant in the Plan on their hire date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Organization has appointed Mutual of America Life Insurance Company (“Mutual of America”) as the Trustee of the Plan assets with authority over management and investment of Plan assets.

Contributions

Participants may make elective deferral contributions up to the maximum dollar amount established by the Internal Revenue Code (“IRC”) of pretax annual compensation (\$23,000 in 2024), as defined in the Plan. Participants age 50 and older may make catch-up contributions to a maximum dollar amount established by the IRC. During 2024, a participant’s catch-up contributions for the plan year may not exceed \$7,500. Participants may elect to designate all or any portion of their Elective Deferral Contributions as Roth Elective Deferrals. Participants may also contribute amounts representing distributions from other tax qualified plans (rollovers).

The Organization matches participant elective deferral contributions after a period of twelve (12) consecutive months in which the employee completes 1,000 hours of service. The Organization’s matching contribution is equal to the lesser of: (a) 50% of the employee elective deferral contributions or (b) 3% of compensation received during the Plan year in which the eligibility requirements are met. The Organization’s matching contributions totaled \$109,342 for the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Organization’s matching contribution, and earnings and losses on investments selected by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participant Accounts (continued)

Participants direct the investment of their contributions and Organization contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and money market funds.

Forfeitures

Forfeitures are used to reduce the Organization's contribution or to pay Plan expenses. Forfeitures of \$5,739 were used to offset the Organization's contributions for the year ended December 31, 2024.

Vesting

Participants are immediately 100% vested in their contributions to the Plan. The Organization matching contributions and base contributions, if applicable, vest as follows:

Administrative Expenses

Expenses of the Plan, including legal, audit, administrative, and trustee expenses, are generally paid by the Organization, with the exception of certain administrative expenses which are paid for by the Plan and charged to participants' accounts. The Plan paid \$1,796 of administrative expenses for the year ended December 31, 2024.

Payment of Benefits

On termination of service, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or payment in the form of an annuitized series of payments. Participants may withdraw any part of their vested account upon attaining age 59 1/2. The Plan permits hardship withdrawals in certain circumstances.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting which is in accordance with accounting principles generally accepted in the United States of America (“GAAP”). Employee and employer contributions were recognized in the period that contributions are due.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant’s account balances and the amounts reported in the statements of net assets available for benefits.

3. Investments

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy based on inputs used to measure fair value and enhance disclosure requirements for fair value measurements. The fair value hierarchy distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity (observable inputs that are classified within Level 1 or 2 of the hierarchy) and the reporting entity's own assumptions about market participant assumptions (unobservable inputs classified within Level 3 of the hierarchy).

- Level 1- Inputs are quoted prices in active markets for identical investments that the investment manager has the ability to access at the measurement date.
- Level 2- Inputs are inputs other than quoted prices included within Level 1 that are observable for the investment, either directly or indirectly.
- Level 3- Inputs are unobservable inputs for the investment.

The mutual funds held by the Plan are measured at fair value. Mutual funds are valued at the daily closing price as reported by the respective fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded, and therefore are classified within the Level 1 of the valuation hierarchy.

The Plan is a party to a fully benefit-responsive guaranteed interest account with Mutual of America. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits. The guaranteed interest account is presented on the face of the accompanying statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on

competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Organization or other Organization events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the value of certain financial instruments could result in a different value measurement at the reporting date. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

4. Information Certified by the Trustee

The following information regarding the Plan is included in the financial statements and supplementary information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, and was obtained from data that has been prepared and certified as complete and accurate by the trustee:

- a. The total value of mutual funds and the guaranteed interest account as of December 31, 2024 and 2023, as indicated on the statements of net assets available for benefits;
- b. All mutual funds and the guaranteed interest account information, as indicated in the statement of changes in net assets available for benefits; and
- c. All information on the supplementary Schedule H, Line 4i - Schedule of Assets (Held at End of Year)

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary schedule.

5. Party-In-Interest Transactions

Certain Plan investments are managed by Mutual of America, the trustee, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation or depreciation in fair values of investments on the Statement of Changes in Net Assets Available for Benefits.

6. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Tax Status

On January 1, 2009, the Organization adopted the Mutual of America 403(b) Basic Plan. The Plan was amended and restated on December 1, 2017, and subsequently on April 1, 2023. The Plan is intended to comply with the applicable requirements of Section 403(b) of the Internal Revenue Code ("IRC"). A tax determination letter program is not yet available for IRC Section 403(b) plans through the IRS. The Plan Administrator believes the Plan is currently designed and operated in compliance with applicable requirements of the IRC and, as such, is exempt from federal income taxes. Therefore, no provision for income tax has been included in the Plan's financial statements. The Plan's management will make any changes deemed necessary to ensure the Plan maintains its tax-exempt status.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or a disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Subsequent Events

In preparing these financial statements, the Plan management has evaluated events and transactions for potential recognition or disclosure through September 30, 2025, the date the financial statements were available to be issued.
