The supplemental schedule of Schedule H, Line 4i – Schedule Of Assets (Held At End Of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that is agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following brief description of the Glenn O. Hawbaker, Inc. Benefit Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

GENERAL

The Plan is a defined contribution plan covering substantially all full-time employees of Glenn O. Hawbaker, Inc. (the “Company”) who are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

CONTRIBUTIONS

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan up to the maximum limits of the Internal Revenue Code (“IRC”). Participants may also contribute up to 100% of post-tax annual compensation as a Roth contribution, as defined by the Plan.

Eligible employees will automatically be enrolled in the Plan. Their contribution will initially be set at 3% of their eligible compensation, unless the eligible employee elects a different percentage or elects to cease making deferral contributions. These employees will be subject to an automatic increase of 1% per year up to a maximum of 10%.

Each year, the Company contributes a discretionary contribution to the Plan at an amount not less than the amount received by the Company allocated to “retirement benefits” pursuant to the Davis Bacon Act. Additional amounts may be contributed at the option of the Company subject to IRC Section 404 limits.

In addition, the Company makes a matching contribution to the Plan equal to 50% of the active participant’s salary deferral, up to 5% of their salary with a maximum value of \$3,000.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participant contributions to the Plan are recorded in the period that payroll deductions are made from participants. Contributions are subject to certain limitations.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contributions, (b) Plan earnings, and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are immediately vested in their voluntary and Company prevailing wage rate contributions plus actual earnings thereon. Vesting in the remaining Company contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service. The participant will also become fully vested upon death or disability prior to termination or upon attainment of retirement age.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Borrowings are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50% at December 31, 2024. Principal and interest is paid ratably through weekly payroll deductions. Terms range from one to thirty years depending on the purpose of the note receivable. Notes receivable are stated at their unpaid principal balance plus accrued interest.

PAYMENT OF BENEFITS

Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, the Plan allows for hardship distributions if certain criteria are met.

FORFEITED ACCOUNTS

Nonvested forfeitures reallocated to the remaining participants were \$279,388 in 2024 and \$235,676 in 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The accompanying financial statements of the Plan are presented under the accrual method of accounting.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value (except for the fully benefit-responsive guaranteed investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FULLY BENEFIT-RESPONSIVE GUARANTEED INVESTMENT CONTRACT

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (“Principal” or “issuer”) on October 1, 2016 totaling \$25,593,774 as of December 31, 2024 and \$25,815,201 as of December 31, 2023. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer but may not be less than the Guaranteed Minimum Interest Rate. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract does not permit the issuer to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive guaranteed investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive guaranteed investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

ADMINISTRATIVE EXPENSES

Except for loan origination fees associated with notes receivable from participants and withdrawal fees associated with benefit payments, all expenses of maintaining the Plan are paid by the Company.

SUBSEQUENT EVENTS

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 23, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The Plan measures its investments at fair value on a recurring basis in accordance with accounting principles generally accepted in the United States of America. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework that authoritative guidance establishes for measuring fair value includes a hierarchy used to classify the inputs used in measuring fair value. The hierarchy prioritizes the inputs used in determining valuations into three levels. The level in the fair value hierarchy within which the fair value measurement falls is determined based on the lowest level input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The levels of the fair value hierarchy are as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible to the Plan for identical assets. These generally provide the most reliable evidence and are used to measure fair value whenever applicable.

Level 2 – Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted market prices in active markets for similar assets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

Level 3 – Inputs to the valuation methodology are unobservable inputs and significant to the fair value measurement.

NOTES TO FINANCIAL STATEMENTS

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. There were no transfers of investments between Level 1 and Level 2 during the years ended December 31, 2024 and 2023. The Plan held no Level 2 or 3 investments during 2024 and 2023.

- Mutual funds: Valued at the quoted net asset value of shares held by the Plan at year end.
- Investments measured at net asset value (“NAV”): Pooled separate accounts are valued based upon the units of the pooled separate accounts held by the Plan at year end times the respective unit value. The NAV is based on the fair value of the underlying investments held by the accounts less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The pooled separate accounts invest mainly in domestic stocks.

4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets are administered under a contract with Principal Trust Company (the "Trustee") a party-in-interest as defined by ERISA. Contributions are held and managed by the Trustee, who invests cash received. The Trustee invests investment income and makes distributions. Administrative expenses of the Trustee are shared by the Company and the Plan.

Participants may borrow from their fund accounts and therefore these transactions also qualify as party-in-interest transactions.

Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.

5. TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated August 8, 2014, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Company has taken any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Additionally, the Plan has not incurred any penalties by any taxing jurisdictions for any reason. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

6. INFORMATION CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2502.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental schedule of Schedule H, Line 4(i) – Schedule Of Assets (Held At End Of Year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year then ended. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. LITIGATION AND CONTINGENCIES

In June 2021, the Philadelphia Regional Office of the U.S. Department of Labor, Employee Benefits Security Administration notified the Plan that it was conducting an investigation pursuant to the Employee Retirement Income Security Act of 1974. The outcome of these proceedings is unknown at this time.

In September 2021, the Pennsylvania Department of Transportation ("PennDOT") began debarment proceedings against the Company for up to three years. On September 23, 2021, the Company filed in the Commonwealth Court proceeding a Motion for Adjudication of Civil Contempt or in the Alternative Petitioner's Motion for a Preliminary Injunction seeking to enjoin the PennDOT debarment proceedings. On January 19, 2022, the Court issued an order enjoining PennDOT from proceeding with any debarment action against the Company. The outcome of these proceedings is unknown at this time.

Also during 2021, two putative class action complaints were filed by certain individuals for themselves and on behalf of the Plan alleging that the Company and the Plan Administrator underpaid prevailing wages to employees working on projects subject to prevailing wage laws. Any recovery may, in fact, be payable to the Plan. The outcome of these proceedings is unknown at this time.

8. RECONCILIATION TO FORM 5500

The Department of Labor regulations [Reg. 2520.103-1(b)(3)] require the notes to the separate financial statements to explain any variances from accounting principles generally accepted in the United States of America or differences between the information reported in the separate statements and in Schedule H. There were no material differences between the financial statements and the Form 5500.

9. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in various combinations of investment funds. Investment funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
