### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Agricultural Bank of China 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 financial statements).

## **Note 1. Description of the Plan**

### ***General***

The Agricultural Bank of China 401(k) Plan (the Plan) is a defined contribution plan and is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA). The Plan was established on January 1, 2014, which has been amended and restated effective January 1, 2022, and covers substantially all employees of Agricultural Bank of China (the Company or Plan Administrator). Empower Retirement (Empower) is the record-keeper of the Plan. Empower Retirement, LLC, acting as the Trustee (Trustee), holds the Plan's investment assets, and executes investment transactions. Empower, also acting as the record-keeper (Record-keeper), maintains participant accounts for the Plan. The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### ***Contributions***

The Plan provides each participant with an opportunity to make elective pre-tax contributions and/or Roth elective deferrals to the Plan, up to 100% of compensation, and subject to the limitations of the Internal Revenue Code (IRC).

The Plan utilizes an automatic enrollment feature for eligible employees. Unless participants otherwise enroll or specifically decline to contribute, participants are automatically enrolled at a 3% deferral rate of compensation.

The Company is required to make safe harbor matching contributions of 100% of the participant's salary deferrals that do not exceed 3% of their eligible compensation, plus 50% of a participant's salary deferrals between 3% and 5% of the participant's eligible compensation.

### ***Vesting***

Participants are immediately and fully vested in their own contributions, safe harbor matching contributions, and discretionary nonelective contributions, plus actual earnings thereon.

### ***Notes Receivable from Participants***

Borrowings are available for all participants. Notes receivable from participants are limited to a minimum of \$500 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance, subject to certain restrictions as defined by the Internal Revenue Service (IRS). A one-time origination fee is charged at inception of the note receivable from participants. The notes receivable from participants are secured by the vested balance in the participant's account and bear interest at a rate determined reasonable by the Company. All notes must be repaid within five years, unless for the purchase of a primary residence, in which case the repayment period may not exceed 10 years. Repayments are made through payroll deductions and are reinvested in the participant accounts according to individual investment elections. At December 31, 2024, interest rates on notes receivable from participants range from 9.0% to 9.5% per annum.

### ***Payment of Benefits***

Upon normal retirement age, death, disability, or termination, a participant's benefits may be payable in a lump-sum amount equal to 100% of the participant's vested account balance. Employees may also make hardship withdrawals on the balance of their vested account related to their elective deferral contributions. Account balances of \$5,000 or less at the time of termination will be "cashed out" as an involuntary lump sum payment.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's contribution and (b) the Plan's earnings and is charged with an allocation of administrative expenses for investments with the trustee. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Investment Options***

The Plan provides for contributions to be invested by the participants among any of the various investment options in accordance with participant investment elections and the provisions of the trust agreement. Participants should refer to the plan document for additional fund information.

***Forfeitures***

Forfeitures of terminated participants' non-vested accounts are used to reduce company contributions or pay plan administrative expenses. These amounts are reported as a component of net assets available for benefits. As of December 31, 2024 and 2023, there were \$0 forfeitures available for use.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are stated at fair value, except for the guaranteed interest account which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

***Subsequent Events***

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available for issuance.

**Note 3. Investment Information Certified by the Trustee**

The Plan Administrator has obtained a certification from the trustee that such information is complete and accurate.

***Guaranteed Investment Contract with Insurance Company***

The Plan entered a fully benefit-responsive, guaranteed annuity contract and the contributions are maintained in a general account. The account is credited with earnings based on the specified crediting rate and charged with participant withdrawals and administrative expenses. The guaranteed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the guaranteed investment contract. As of December 31, 2024 and 2023, the guaranteed investment contract is presented on the face of the statements of net assets available for plan benefits at contract value.

**Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value of measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value fall into one of the three levels of the fair value hierarchy below and are defined as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 – Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

- Pooled separate accounts: Valued at its accumulated unit values which are based on the net asset values as reported by the custodian based upon the underlying assets, primarily equity and fixed income mutual funds, included in the pooled separate account. The underlying funds held by the Plan's pooled separate account are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. The Plan believes its valuation methods are appropriate and consistent with other market participants; even so, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

## **Note 6. Related-Party Transactions**

Certain plan investments are managed by the Plan's trustee and, therefore, transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Other fees and expenses, such as investment fees and certain plan administrative expenses, may be deducted directly from investment returns in accordance with the applicable investment option selected by the participants.

**Note 7. Tax Status**

On November 14, 2022, the IRS stated that the prototype adopted by the Plan, as designed, qualifies under Section 401(a) of the IRC. The Plan has not received a determination letter specific to the Plan itself, and has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's management believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 8. Risks and Uncertainties**

The Plan's investments are concentrated in funds that invest in marketable equity securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain equity securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.
