Brinkmann Company Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 And 2023**

**1. Description Of The Plan**

The following description of R.G. Brinkmann Company Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established by R.G. Brinkmann Company (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan's trustee and recordkeeper are Principal Trust Company (Principal Trust) and Principal Life Insurance Company (Principal Life), respectively.

**Eligibility**

All employees of the Company, except for union employees, interns, and leased employees, are eligible to participate in the salary deferral, discretionary matching and profit sharing contributions of the Plan upon hire and reaching 18 years of age. Participants may enter the Plan quarterly upon satisfying the eligible requirements.

**Contributions**

Participants may defer 100% of eligible compensation as salary deferral contributions, Roth contributions or a combination of both. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participants, upon meeting the eligibility requirements, are automatically enrolled in the Plan at a default salary deferral contribution rate of 6%. The contribution rate shall be automatically increased as soon as administratively feasible on or after each January 1 by 1% up to a maximum contribution rate of 25%. The participant may affirmatively elect a different percentage or elect not to make salary deferral contributions, and may elect to designate all or portion of their contributions as Roth contributions.

The Plan provides for a discretionary matching contribution and profit sharing contribution. The Company's discretionary matching contribution was 50% of the first 6% of eligible compensation for the years ended December 31, 2024 and 2023. The Company did not make profit sharing contributions for the years ended December 31, 2024 or 2023.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account was credited with the participant's deferral contributions, the Company's contributions, and an allocation of the Plan's earnings and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account balance.

**Vesting**

Participants are 100% vested in their salary deferral contributions, Roth contributions and rollover contributions. Vesting of Company matching and profit sharing contributions is based on years of service, with balances vesting at a rate of 20% for each year of vesting service after the second year, becoming fully vested after six years. Participants are also 100% vested upon retirement, disability or death.

**Notes Receivable From Participants**

Effective January 1, 2024, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the vested balance in the participant's account and bear interest at current fixed rates being charged by commercial lending institutions. Participants are limited to two loans for a rolling twelve month period. Principal and interest is paid ratably through payroll deductions.

**Forfeitures**

Participants who terminate their employment and are less than 100% vested in their account will forfeit their nonvested portion. Forfeited nonvested accounts may be used to pay Plan expenses or reduce Company contributions. Forfeitures used to reduce Company contributions for the years ended December 31, 2024 and 2023 were \$99,152 and \$40,020, respectively. Forfeitures used to pay Plan expenses for the years ended December 31, 2024 and 2023 amounted to \$28,408 and \$13,883, respectively.

Forfeitures available for future use amounted to \$3,614 and \$982 as of December 31, 2024 and 2023, respectively.

**Payment Of Benefits**

Upon termination of employment, retirement, or death, a participant's vested balance may be distributed in a lump sum, installment payments, or partial payments.

**In-Service Distributions**

Active participants who reach age 59-1/2 may withdraw all or part of their vested account. Additionally, a participant who has been an active participant for at least five years may withdraw any part of their vested matching or discretionary contributions as an In-Plan Roth Rollover.

**Administrative Expenses**

Salaries and related benefits of employees who administer the Plan are provided by the Company. Other administrative expenses, primarily transaction fees, account fees, and professional fees are shared by the Plan and the Company. Investment related expenses are included in net change in fair value of investments.

**Investment Options**

A participant may direct contributions to a variety of investment options provided by the Plan. Participants may change the investment elections on future contributions or balances any time.

**2. Significant Accounting Policies**

**Basis Of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This estimate must include consideration of historical experience, current conditions and reasonable and supportable forecasts.

The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or December 31, 2023.

**Investment Valuation And Income Recognition**

The Plan's investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year and any capital gain distributions.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment Of Benefits**

Benefits are recorded when paid.

#### **4. Fair Value Measurements**

The Plan follows accounting rules that establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Trust Funds**

Valued at the NAV of units of the individual funds. The NAV, as provided by trustees of the funds, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. All of the collective trust funds held by the Plan final annual reports on Form 5500 as direct filing entities.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**6. Income Tax Status**

The Plan adopted a prototype plan document sponsored by Principal Financial Group. Principal Financial Group obtained an opinion letter dated June 30, 2020 in which the IRS stated that the prototype plan document was in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter. The Plan has been amended since the date of the opinion letter. However, the Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan and the related trust are tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's federal tax returns for tax years 2021 and later remain subject to examination by taxing authorities.

**7. Risks And Uncertainties**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**8. Party In Interest Transactions**

The Plan pays administrative fees to various service providers for recordkeeping, trust, and advisory services. In addition, certain participants have outstanding loans with the Plan as of December 31, 2024. These transactions qualify as allowable party in interest transactions under ERISA.

**9. Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

Effective June 1, 2025, the Plan was amended to allow an adopting employer, RGBC Holdings Company MC, LLC, to participate in the Plan.
