Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ingersoll Machine Tools, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

Note 1. Plan Description

The following description of the Ingersoll Machine Tools, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan was formed January 1, 1994. The Plan is a defined contribution plan covering substantially all employees of Ingersoll Machine Tools, Inc. (the Company), except for those who are non-resident aliens with no United States source income, independent contractors, or leased employees. Employees are eligible to enroll in the Plan on the first day of each month following the completion of 30 days of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Trustees are responsible for oversight of the Plan.

Contributions: Participant contributions are limited to the lesser of 100% of eligible compensation or the maximum contribution dollar amount allowed by the Internal Revenue Service (IRS). Participants who will attain age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The employer provides a fixed matching contribution of 100% of the participant's eligible compensation related contribution up to a maximum of \$2,000.

Participant accounts: Each participant's account is credited with the participant's contributions and allocations of: (a) the Company's matching contribution and (b) plan earnings, and charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participant contributions, including rollover contributions, and earnings thereon vest immediately. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited services.

Investment options: Participants are allowed to invest in a variety of investment choices as more fully described in the Plan's literature. Participants may elect to change their investment options on a daily basis.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note maturities are not to exceed five years, unless the note is used to acquire a primary residence of the individual, in which case the note maturities may extend to 10 years. The notes are secured by the balance in the participants' account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions or direct payment.

Payment of benefits: Upon termination of service for any reason, participants may elect to receive their vested account balance in a lump-sum distribution or in installments based on various annuities. A lump-sum distribution is mandatory if their vested account balance is \$1,000 or less. In-service withdrawals at age 59½ and hardship withdrawals are permitted.

Forfeited accounts: At December 31, 2023 and 2022, forfeited nonvested account balances were \$21,400 and \$22,100, respectively. Forfeited accounts are used to reduce future employer contributions or pay Plan expenses. During 2023, and 2022, employer contributions were reduced by approximately \$51,400 and \$0, respectively, from forfeited nonvested accounts.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accounted for on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess participant contributions: Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Administrative expenses of the Plan can be paid by either the Company or the Plan. The expenses of maintaining the Plan, that are paid directly by the Company are excluded from these financial statements.

Subsequent events: Plan management has evaluated subsequent events through October 3, 2025, the date on which the financial statements were available to be issued.

Note 3. Information Certified and Provided by Fidelity, the Current Plan Trustee, and Mutual of America Life Insurance Company, the Former Plan Trustee

The following is a summary of the Plan's asset and income information as of December 31, 2023 and 2022, and for the year ended December 31, 2023, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by Fidelity, the current trustee of the Plan as of December 31, 2023, and for the period from October 1, 2023 to December 31, 2023; and by Mutual of America Life Insurance Company (MOA), the former trustee of the Plan, from January 1, 2023 to September 30, 2023, and as of December 31, 2022, and provided to the Plan Administrator. The Plan Administrator has obtained certifications from MOA and Fidelity that information provided to the Plan Administrator by them is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets and income.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been changes in the methodologies used at December 31, 2023 and 2022.

The TPA was Fidelity in 2023 and used the following methodologies:

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Certain self-directed brokerage accounts invest in mutual funds.

Money market funds: Certain self-directed brokerage accounts invest in money market funds. Money market funds are valued at cost plus accrued income, which approximates fair value.

Certificates of deposit: Certain self-directed brokerage accounts invest in certificates of deposits. Certificates of deposits are valued using pricing models maximizing the use of observable inputs for similar certificates of deposits issued by similar or similarly rated entities with comparable maturities and size.

Common stock: Certain self-directed brokerage accounts invest in common stock, which is valued at the closing price reported on the active market on which the individual securities are traded.

U.S. government securities: Certain self-directed brokerage accounts invest in U.S. government securities. U.S. government securities are valued using pricing models maximizing the use of observable inputs for similar securities.

Note 4. Fair Value Measurements (Continued)

The TPA was Mutual of America Life Insurance Company in 2022 and used the following methodologies:

Insurance company general account: The Plan's investment in the insurance company general account is valued at fair value using a discounted cash flow approach based on current yields of similar instruments with comparable durations while considering the creditworthiness of the issuer. Since the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only.

Insurance company pooled separate accounts: The Plan's investments in the insurance company's pooled separate accounts are valued at the NAV per share as determined by the insurance company, which represents the fair value of the underlying investments held in the pooled separate accounts. The NAV is used as a practical expedient to estimate fair value. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
