## Independent Auditor's Report

To the Plan Administrator and Participants  
The Field Museum of Natural History 403(b) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of The Field Museum of Natural History 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### Note 1 - Plan Description

The following description of The Field Museum of Natural History 403(b) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan that provides benefits to all eligible employees of The Field Museum of Natural History (the "Company"), as determined according to the provisions of the plan agreement. The Plan is intended to be a qualified retirement plan under Section 403(b)(7) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Plan Administration**

The Plan is administrated by the Company. Certain plan expenses are paid by the Company, with maintenance and processing fees paid by the participants, as provided in the plan document. The Company has appointed the following custodians of the Plan (collectively, the "Custodians"):

- Teachers Insurance Annuity Association of America (TIAA), an insurance company, and College Retirement Equities Fund (CREF), an investment company (collectively, TIAA-CREF)
- The Variable Annuity Life Insurance Company (VALIC)
- Commonwealth Annuity and Life Insurance Company (as administrator for Zurich American Life Insurance Company) (Zurich)
- Fidelity Management Trust Company (Fidelity)
- AIG Federal Savings Bank (AIG)
- Corebridge Financial (Corebridge)

The Company stopped offering Fidelity, Zurich, and TIAA-CREF investment options to new participants for plan years beginning on or after January 1, 1998; January 1, 2006; and January 1, 2013, respectively. However, participants who were contributing funds to these providers were able to do so during their employment until December 31, 2012. The Company revised its plan offering for new contributions beginning on January 1, 2013. As of January 1, 2013, VALIC and AIG are the only custodians offered for new contributions.

#### **Eligibility**

All employees of the Company are eligible to participate in the Plan on their first day of employment. Entry dates into the Plan are the first of every month following employment.

#### **Contributions**

Participants may make pretax contributions to the Plan subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 may make catch-up contributions in addition to their regular deferral contributions. Participants may also contribute, with the consent of the plan administrator, amounts representing distributions from other qualified retirement plans. Participant contributions are not subject to federal income tax until withdrawn. Contribution rates may be changed by the participant up to four times annually.

**Note 1 - Plan Description (Continued)**

Employer contributions include three components: matching, discretionary, and transition contributions. A matching contribution is made on behalf of eligible employees in an amount equal to 50 percent of the first 4 percent of compensation a participant contributes for each pay period, if the participant has reached age 21 and has completed one year of service. A discretionary contribution may be made to eligible employees who have reached age 21 and have completed one year of service, based on an amount approved by the board annually. This contribution is administered in the first quarter following the end of the plan year. For the 2024 plan year, a 1.5 percent discretionary credit for eligible employees was approved. There was a 3 percent discretionary contribution approved for the 2023 plan year. A transition contribution is provided to eligible employees who are former pension plan participants. Participants receive a 1 percent transition credit if the sum of their age and years of service as of December 31, 2014 is less than 60 or a 2 percent transition credit if the sum of their age and years of service as of December 31, 2014 is 60 or greater. Transition contributions are administered in the first quarter following the end of the plan year.

***Vesting***

Participants are fully and immediately vested in their voluntary contributions plus actual earnings thereon. Participants are also fully and immediately vested in the employer contributions plus actual earnings thereon.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, employer's contributions, and allocations of plan earnings and charged with an allocation of administrative expenses. Determination of the allocation methodology of these amounts is outlined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

***Plan Loans***

Plan loans are available to participants through TIAA-CREF and VALIC subject to certain limitations. Plan loans issued by TIAA-CREF and VALIC are directly issued from the funds owned by the Custodians, and the loan proceeds are not removed from a participant's account balance. However, a portion of the participant's account is reserved, or held as collateral, to cover 110 percent of the outstanding loan amount for the period of time the loan is outstanding. As such, loans issued by TIAA-CREF and VALIC are not considered assets of the Plan.

As of December 31, 2024 and 2023, participants had outstanding plan loan balances due to TIAA-CREF of \$0 and \$272, respectively, and plan loan balances due to VALIC were \$107,646 and \$64,987, respectively.

***Payment of Benefits***

Except as permitted in the Plan, as related to excess elective deferrals, withdrawals of amounts rolled over into the Plan, or termination of the Plan, the amount distributed from a participant's account upon a participant's retirement, termination of employment, death, or disability may be in the form of a lump sum, partial payments, installment payments, or an annuity amount. Participants may also withdraw their deferral contributions in the event of financial hardship, as described in the Plan, or upon their attainment of age 59½. Certain amounts invested in the TIAA Traditional Annuity group contracts may not be distributed in a lump sum (see redemption restrictions below).

Hardship withdrawals shall be permitted under the Plan to the extent permitted by the individual agreements and in accordance with the provisions of §1.401(k)-1(d)(3)(iii)(B) and 1.401(k)-1(d)(3)(iv)(E) of the income tax regulations.

**Note 1 - Plan Description (Continued)**

***Redemption Restrictions***

Certain contracts under the TIAA Traditional Annuity investment have limits on the ability of the participant to transfer or withdraw from the fund. Transfers from the Retirement Annuity (RA) and Transfer Payout Annuity (TPA) contracts must be paid out in 10 annual installments. Withdrawals from the RA contract must be paid out in 10 annual installments. The remaining contracts under the TIAA Traditional Annuity investment do not have restrictions related to transfers and withdrawals.

Transfers out of the VALIC Fixed Account Plus at contract value are limited to 20 percent of the account balance on an annual basis.

***Termination***

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all accounts will be valued as of the termination date, and account balances will be distributed as a single lump-sum payment to each participant in accordance with plan provisions.

***Party-in-interest Transactions***

Plan investments include guaranteed investment contracts, mutual funds, variable annuities, and pooled separate accounts and are managed by the Custodians or their affiliates. Therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

**Note 2 - Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

The fully benefit-responsive portions of the guaranteed investment contracts with TIAA and VALIC are valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. See Notes 5 and 6 for further discussion.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Allocated Insurance Contracts***

The Plan has allocated insurance contracts for retirees who were covered under the Plan in prior years. These contracts remain intact, and no additional contracts have been purchased. The activity related to the allocated insurance contracts for retirees receiving benefits is excluded from the financial statements. The Plan receives no income from these allocated insurance contracts.

***Benefit Payments to Participants***

Benefits are recorded when paid. There were no benefit payments requested but not paid (due to redemption restrictions) in the years ended December 31, 2024 and 2023.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 30, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

TIAA-CREF, Zurich, VALIC, AIG, Corebridge, and Fidelity hold the Plan's investments and execute all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodians.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

**Note 4 - Fair Value Measurements (Continued)**

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Variable Annuities**

The variable annuities are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

**Pooled Separate Accounts**

The pooled separate accounts with Zurich are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' net underlying assets. The pooled separate account with TIAA is valued at net asset value per share or its equivalent of the fund, which is based on the fair value of the fund's underlying assets, which primarily consist of rental property subject to long-term leases, and has been estimated on the basis of future rental receipts and estimated residual values discounted at interest rates commensurate with risks involved. There are no redemption restrictions or unfunded commitments on these investments.

**Guaranteed Investment Contracts**

The guaranteed investment contracts with Zurich and a portion of the contracts with TIAA are not considered benefit responsive and are presented at fair value. The unallocated contracts invest in the general assets of the issuers; however, since there are no specific securities in the issuers' general accounts related to these contracts and due to the contract terms, including the frequency of the interest rate reset intervals, contract value approximates fair value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

There were no unfunded commitments or redemption restrictions on the investments described above.

### Note 5 - TIAA Traditional Annuity Contracts

Based on the terms of the contracts, a portion of the TIAA Traditional Annuity is considered benefit responsive. The total balance in the TIAA Traditional Annuity was \$2,418,633 and \$2,858,499 at December 31, 2024 and 2023, respectively. The benefit-responsive portion of the TIAA Traditional Annuity totaled \$2,328,695 and \$2,663,535 at December 31, 2024 and 2023, respectively. The contract issuers maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a vintages approach. Under this methodology, TIAA groups the dollars it receives over defined time periods into vintages and determines a crediting rate for the applicable vintage. Interest crediting rates are determined during the accumulation phase of the applicable declaration year. When establishing interest crediting rates for this product, TIAA considers many factors, including the net investment earnings rate of the TIAA assets supporting that vintage, administrative expenses during the time period, and required contingency reserves. The minimum crediting rate for the benefit-responsive contracts is generally 3.00 percent; however, in some recent contracts, it has been between 1.00 and 3.00 percent.

**Note 5 - TIAA Traditional Annuity Contracts (Continued)**

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract or that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

**Note 6 - VALIC Group Annuity Fixed Accounts**

The Plan has a benefit-responsive investment contract with VALIC. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting. When establishing interest crediting rates for this product, VALIC considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. The minimum crediting rate varies by participant and depends on the date the participant established his or her account. Participant accounts set up prior to December 1, 2003 have a minimum guaranteed rate of 3.00 percent, and accounts set up subsequent to that date are guaranteed 2.00 percent. Effective January 1, 2011, contracts issued to new participants have an indexed guaranteed minimum interest rate, which was 2.60 and 2.75 percent as of December 31, 2024 and 2023, respectively.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

**Note 7 - Tax Status**

The plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of Internal Revenue Code Section 403(b). Therefore, no provision for income taxes has been included in the Plan's financial statements.
