### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Examinetics, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**Note 1. Description of the Plan**

***General***

The following description of Examinetics, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a complete description of the Plan's provisions, which are available from the Plan Administrator.

The Plan is a defined contribution plan sponsored by Examinetics, Inc. (the Company) for the benefit of its employees who have attained age 18. Employees are eligible to begin participation in the Plan on the first day of the quarter coinciding with or next following the date the employee satisfies the eligibility requirements. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Charles Schwab Trust Bank serves as plan custodian.

***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation subject to IRS limitations. Employee rollover contributions are also permitted. Contributions are subject to certain limitations. The Plan also allows for Roth 401(k) contributions by employees.

The Company may make annual discretionary profit sharing contributions in an amount determined by the Company's board of directors. Profit sharing contributions are allocated based on eligible compensation. Participants must complete a year of service during the plan year and be employed as of the last day of the plan year to be eligible for any profit sharing contributions. The Company did not make a profit sharing contribution for the years ended December 31, 2024 and 2023.

Each year, the Company may make discretionary matching contributions of a percentage, if any, to be determined annually based on a uniform percentage of employee salary deferral contributions. The Company made matching contributions totaling \$229,638 and \$225,259 for the years ended December 31, 2024 and 2023, respectively. The Company has the option to disregard salary deferrals made each year that exceed a certain dollar amount or a certain percentage of a participant's compensation for such period. Participants will share in the matching contribution regardless of the amount of service completed during the plan year.

***Participant Investment Account Options***

Investment account options available include various mutual and collective investment funds. Each participant has the option of directing his or her contributions into any of the separate investment accounts and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise.

***Participant Accounts***

Each participant's account is credited with the participant's voluntary contributions (including rollover contributions, if any), the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Participants' accounts are valued daily. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Forfeitures***

Forfeited nonvested accounts are used to reduce Company contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,054 and \$6,097, respectively. The Plan allows for forfeitures to first be used to pay certain administrative costs of the Plan, with any remaining amounts used to reduce future employer contributions. Administrative fees paid by forfeitures were \$16,189 and \$16,808 for years ended December 31, 2024 and 2023, respectively.

***Vesting***

Participants are immediately vested in their voluntary pre-tax contributions and rollover contributions plus earnings thereon. Vesting in the Company's contributions portion of their accounts plus earnings thereon is based on completed years of service. A participant is fully vested after five years of credited service. The nonvested balance is forfeited upon termination of service.

***Payment of Benefits***

A participant is entitled to a benefit equal to the full value in the participant's account upon attainment of age 59.5, permanent disability, or death prior to termination of employment. In the event of resignation or discharge before any of the above events, the benefits will be dependent on the Plan's vesting schedule. Benefits are payable in a lump sum or in installments. In the event of death, benefits are payable to the designated beneficiary.

The Plan permits hardship withdrawals. To qualify for a hardship withdrawal, the participant must demonstrate immediate and heavy financial needs, as defined in the Plan Document.

***Notes Receivable from Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. The maximum loan term is five years or for a reasonable period of time, which may exceed five years for the purchase of a primary residence. Generally, all loans are repayable through payroll withholdings; however, the participant may make payments by other means. The loans are secured by the balance in the participant's account and bear an interest rate equal to 1% above the prime rate.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants before March 15 of the subsequent year.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value the investments. Mutual funds are valued at the published net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in collective trust funds are valued based on information reported by the investment advisor using the audited financial statements of the collective trust funds at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Information Certified and Provided by Charles Schwab Trust Bank**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedules of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons. Individually non-material expenses paid to parties-in-interest aggregated \$72,206 for 2024 and \$61,695 for 2023.

Certain plan investments are shares of mutual funds and collective investment funds managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments.

The Company provides certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. Level 2 securities include collective investment funds. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan does not have any securities within Level 3 of the fair value hierarchy.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 7. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Retirement Plan Services, LLC. The IRS has determined and informed the Company by a letter dated June 30, 2020, that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
