Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Scott Equipment Company Employees 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule (see accompanying table of contents), as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing

procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the Scott Equipment Company Employees 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is a defined contribution plan, providing self-directed, individual investment accounts for all eligible participating employees of Scott Equipment Company (the "Employer" and Plan Sponsor). Members of Scott Equipment Company's management serve as Plan Trustee and Plan Administrator.

The Plan was established in January 1990 and most recently amended effective March 2023 (see Eligibility section below). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Operational changes to the Plan were enacted for recent legislative and regulatory updates, such as an automatic enrollment feature and increasing the age certain participants must begin receiving required minimum distributions from age 70 ½ to age 72.

Eligibility

Employees are eligible to participate in the Plan upon reaching age 20 and completion of either 500 hours in the first six months or 1,000 hours in the first year of eligibility service, as defined in the Plan document. Eligible employees may begin participating in the Plan on the first day of each Plan quarter. Employee classes that are excluded from participation eligibility include leased employees, non-resident aliens, or employees covered by a collective bargaining agreement.

Contributions

All contributions are subject to certain IRS limitations. Each year, participants may contribute on either a pre-tax or after-tax basis up to 100% of eligible compensation, as defined in the Plan. Participants age 50 and older may defer additional "catch-up" amounts. The Plan may accept rollover contributions representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment feature, whereby participants are enrolled in the Plan after meeting eligibility requirements, unless elected otherwise. The automatic enrollment deferral rate was 2% during the year ended December 31, 2024.

The Employer will annually make safe harbor non-elective contributions to the Plan in the amount of 3% of participants' eligible compensation. Highly-compensated employees, as defined in the Plan document, are not eligible to receive a safe harbor contribution. The Employer may, in its sole discretion, also make a profit sharing contribution to the Plan. Such contributions will be allocated in an amount designated by the Employer to be allocated to each eligible participant. In addition, the Employer may, at its discretion, make additional qualified non-elective contributions for the benefit of participants. Employer contributions receivable at December 31, 2024 and 2023 comprised both safe harbor and profit sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's elective salary deferral and an allocation of any applicable Employer contribution, as well as any investment earnings or losses (net of expenses) generated by the assets in which the participant's account is invested. Participants direct the investment of their contributions and any applicable Employer safe harbor or profit sharing contributions into various investment options offered by the Plan. The Plan currently offers investments comprised mutual funds and a stable-value common collective trust.

Vesting

Participants are immediately vested in their contributions and Employer safe harbor non-elective contributions, plus actual earnings thereon. Vesting in Employer discretionary profit sharing contributions is based on years of continuous service; a participant is fully vested after six years of such service. Additionally, participants shall become fully vested upon death, or after normal retirement age of 65 or upon becoming disabled while under employment with the Employer.

Forfeited Accounts

The Plan allows for forfeited non-vested accounts to be used to pay Plan administrative expenses, be reallocated to currently eligible participants, or to reduce Employer contributions. Forfeitures totaled \$21,798 and \$12,949 at 2024 and 2023. Plan forfeitures were used subsequent to year end to reduce the employer contributions.

Payment of Benefits

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon retirement, death, disability, or termination of service, subject to the terms of the Plan, a participant may receive a single lump-sum payment. The Plan allows for in-service withdrawals by participants who attain age 59 and one-half years from all fully-vested accounts. The Plan also allows for in-service hardship withdrawals from participants' elective pre-tax deferrals, subject to restrictions as defined in the Plan document. Participants may receive a distribution from rollover contributions at any time. The Plan generally requires lump sum distributions of vested account balances not exceeding \$5,000.

Notes Receivable from Participants

Active participants may apply for a loan from the Plan, subject to approval by the Plan Administrator. Participants may have more than one loan outstanding at any given time; however, the sum of all outstanding loan balances may not exceed the lesser of \$50,000 minus the difference between the highest outstanding balance of loans in the past twelve months and the outstanding balance of loans from the Plan on the date of the newest loan, or one half of the present value of the participant's vested account balance.

Loans are secured by the balance in the participant's account and bear interest at a reasonable rate based on prevailing rates charged by lenders for loans made under similar circumstances. Interest rates on loans outstanding at December 31, 2024 range from 4.25% to 8.5%. Principal and interest are paid through payroll deductions over terms not to exceed five years from the date of the loan, unless such loan is used to acquire a principal residence, where the maximum loan term is thirty years.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, all participants become 100% vested in their Employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of any financial statements in accordance with accounting principles generally accepted in the United States of America may require management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from such estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution is recorded. Five participant loans were noted as having met the criteria to be recorded as deemed distributions in 2024. This issue was self-corrected during 2025.

Investment Valuation and Income Recognition

Investments are reported at fair value. See Note 6 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain investment related expenses are included in the net appreciation (depreciation) in fair value of investments. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements.

3. Information Prepared and Certified by the Asset Custodian & Trustee

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. John Hancock Trust Company LLC, the Plan asset trustee, has certified to the completeness and accuracy of the related investment activity and interest income on notes receivable from participants reported in the accompanying Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023 and the supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

4. Income Tax Status

The prototype adopted by the Plan obtained its latest opinion letter on November 19, 2020, in which the Internal Revenue Service stated that the prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected.

5. Party-in-Interest and Related Party Transactions

Certain Plan investments are managed by the asset trustee as defined by the plan, and therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred for John Hancock investment management services and administration and advisory fees are included in the net appreciation (depreciation) of fair value of those investments while direct fees paid from participant accounts totaled \$88,574 for the year ended December 31, 2024. The Employer pays directly any other fees related to the Plan's operations. Certain administrative functions of the Plan are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions also qualify as party-in-interest transactions.

6. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date. The accounting framework for measuring fair value provides a hierarchy prioritizing the measurement inputs. The levels of this hierarchy are as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. As such, valuations of Level 1 investments does not entail a significant degree of judgment.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The hierarchy gives the highest priority to Level 1 inputs and the lowest priority to Level 3 inputs. The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Mutual Funds are valued at the daily closing price as reported by the fund and those held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund

The Money Market Fund is valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

Common Collective Trust (CCT)

This consists of a stable value fund composed primarily of fully benefit-responsive contracts valued at the NAV of units in the bank collective trust as determined by the trustee. The portfolio's investment objective is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. To achieve this objective, the portfolio invests in assets (typically fixed-income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements), enters into "wrap" contracts issued by third parties, and invests in cash equivalents represented by shares in money market funds.

The NAV is used as a practical expedient to estimate fair value that will not be used if it is determined to be probable that the fund will sell the investment for an amount other than the reported NAV. Participant transactions (purchases and sales) may occur daily. A plan sponsor-initiated withdrawal requires a 12-month written notice of intent to withdraw the assets.

The Plan has no unfunded commitments relating to the CCT at December 31, 2024 and 2023.

7. Contingencies, Risks and Uncertainties

Investment Options

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Reconciliation of Financial Statements to Schedule H of Form 5500

Both these audited financial statements and the Plan's Form 5500 have been prepared using the accrual basis of accounting. Net assets available for benefits per the Plan's Form 5500 are \$24,155,829 and \$21,616,193 as of December 31, 2024 and 2023. The net increase in net assets available for benefits per the Plan's Form 5500 is \$2,539,636 for the year ended December 31, 2024. Such amounts agree to these audited financial statements.

9. Subsequent Events

Management has evaluated subsequent events through September 30, 2025, the date on which the financial statements were available for issue. Other than the self-correction of deemed distributions described in Note 2, no significant events or transactions requiring recording or disclosure in these financial statements.
