### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Irwin Seating Company Profit Sharing Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. A. DESCRIPTION OF THE PLAN

The following description of Irwin Seating Company Profit Sharing Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. GENERAL. The Plan is a defined contribution plan for all salaried and hourly employees of Irwin Seating Company. The salary and hourly participants must have worked a quarter year of service and be 18 years of age or more. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. CONTRIBUTIONS. For the union participants the Company makes contributions to the Plan based on the number of hours each employee accumulates during the Plan year. Under the terms of the union contract at Irwin Seating Company, monthly contributions of .30 cents per hour are required for 2024 and 2023. Both salary (non-union) and hourly (union) participants may contribute up to 100% of their compensation, subject to certain limitations. The Company chose to match 100% of deferrals up to \$2,500 for 2024 and 2023. Also, each year the Company can contribute to the plan a discretionary percentage of its profits determined by management. The Company chose not to contribute in 2024 or 2023.
3. PARTICIPANT ACCOUNTS. Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, and (b) Plan earnings. Employer contributions are allocated to the participants' account, prorated based on compensation. Plan earnings are allocated to the participant accounts based upon their account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.
4. VESTING. Participants are immediately vested both in their voluntary and company contributions plus the earnings thereon.
5. PAYMENTS OF BENEFITS. On termination of employment, a participant may select to receive a lump-sum or a partial distribution. Also, if the balance of the participant's account is greater than \$1,000, they may elect to keep the balance in the plan.
6. NOTES RECEIVABLE FROM PARTICIPANTS. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan fund. Loan terms range from 1-10 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. The interest rate is 1% over prime for 2024 and 2023, respectively. The interest rate is determined annually by the Plan Administrators. Principal and interest is paid ratably through payroll deductions.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. ACCOUNTING METHOD. The financial statements of the Plan are prepared under the accrual method of accounting.
2. ESTIMATES. The preparation of financial statements in conformity with generally accepted accounting principles may require the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
3. INVESTMENT VALUATION AND INCOME RECOGNITION. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

The Plan holds units of a common/collective trust (“CCT”) with the Putnam Stable Value Fund (“Putnam”) that has investments in fully benefit-responsive investment contracts. The fair value of the Plan’s interest in the CCT is based on audited financial information reported by the issuer, Putnam Fiduciary Trust Company. The issuer determines fair value based on the underlying investments (primarily conventional, synthetic and separate account investment contracts, and cash equivalents). The value of the CCT represents contributions plus earnings, less participant withdrawals and administrative expenses. Participant-directed redemptions for the CCT have no restrictions; the Plan, however, is required to provide a one-year redemption notice to liquidate its entire share in the fund.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

4. NOTES RECEIVABLE FROM PARTICIPANTS. Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.
5. PAYMENT OF BENEFITS. Benefits are recorded when paid.
6. DATE OF MANAGEMENT’S REVIEW. Subsequent events were evaluated through September 16, 2025, which is the date the financial statements were available to be issued.

C. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

**Level 2** – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets
- b. Quoted prices for identical or similar assets or liabilities in inactive markets
- c. Inputs other than quoted prices that are observable for the asset or liability
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds.* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Variable Annuities:* Prices/unit values for Variable Annuity investment options are calculated daily by the annuity provider according to the methods described in the annuity contract.

*Common/collective trust funds.* The investments include a stable value fund. The fair values of participation units held in the stable value fund are based on NAV as a practical expedient to reflect all fund investments at fair value, including direct and indirect interests in fully benefit-responsive contracts. Accordingly, these NAV-based investments have been excluded from the fair value hierarchy.

The following tables set forth, by level within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023.

D. INFORMATION PREPARED AND CERTIFIED BY EMPOWER THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by the Trustee and furnished to the Plan. The Plan has obtained certifications from the Trustee as of December 31, 2024 and 2023 and for the periods January 1, 2024, through December 31, 2024 and January 1, 2023 through December 31, 2023, that such information is complete and accurate.

E. TAX STATUS

The Plan obtained its latest determination letter on November 14, 2022, from the Internal Revenue Service stating that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

F. ADMINISTRATIVE EXPENSES

The Plan can pay for plan expenses through a revenue sharing agreement set up with their third party administrator, Empower Retirement. Any administrative expenses not covered by the revenue sharing agreement are paid by Irwin Seating Company, the plan sponsor.

G. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

H. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

I. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower Retirement. Empower Retirement is the trustee of the Plan, and therefore, these transactions qualified as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.
