All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

- Management's estimate of the fair value measurements regarding plan investments in accordance with the level of measurements described in FASB ASC 820. We evaluated the methods, assumptions, and data used to develop the fair value classifications and estimates in determining that it is reasonable in relation to the financial statements taken as a whole.

Form 5500 Procedures

We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 1, 2025.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Description of Plan

The following description of Ozark Health, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document and *Summary Plan Description* for a more complete description of the plan's provisions. The Plan was most recently restated January 1, 2022, to bring the Plan into compliance with legislative and regulatory changes.

- A) *General.* The Plan is a defined contribution plan covering all employees of Ozark Health, Inc. who have at least two months of service. Ozark Health, Inc. is the plan sponsor. The board of directors of Ozark Health, Inc. control and manage the operation and administration of the Plan. The Board reviews the plan performance and investment options periodically. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B) *Contributions.* Each year, participants may contribute up to the IRS contribution limits, as defined in the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500 and \$7,500 for 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. On behalf of each participant, for each plan year, the employer may, at its discretion, make a contribution to the Plan. Contributions are subject to certain limitations.
- C) *Participant Accounts.* Each participant's account is credited with the participant's contributions, and allocations of (a) the employer's contribution, and (b) plan earnings, and charged with an allocation of administrative expenses, when applicable. Allocations are based on participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D) *Vesting.* Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in any employer discretionary contributions and earnings thereon is based on years of continuous service. A participant is 100% vested after three years of service.
- E) *Participant Loans.* Participant loans are not permitted under the Plan.
- F) *Payment of Benefits.* On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or request a direct transfer to an eligible rollover account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.
- G) *Hardship Withdrawals.* Participants may withdraw, at any time, upon substantial financial hardship (as defined by the plan), any portion of the balance in their account, which is fully vested.
- H) *Administrative Expenses.* Fees paid by the Plan for investment management and recordkeeping services amounted to \$25,646 for the year ended December 31, 2024.
- I) *Forfeited Accounts.* Plan forfeitures must first be used to restore previous forfeitures of rehired participants pursuant to the terms of the Plan. Any remaining forfeitures may be used to pay administrative expenses of the plan and trust. After payment of administrative expenses, if any forfeitures remain, they may be used to offset employer contributions. At December 31, 2024 and 2023, forfeited accounts totaled \$1,552 and \$2,036 respectively. During the year ended December 31, 2024, \$6,067 of forfeitures were used to offset employer contributions and administrative expenses reported on the statement of changes in net assets available for benefits.

Note 2 – Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

The fair values of the registered investment company accounts (mutual funds) are computed using closing prices; on nationally recognized stock exchanges or over-the-counter markets. Fair value of shares of the underlying fund equals the number of shares of the respective underlying fund multiplied by the closing net asset value per share quoted by that fund.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investment bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Expenses of maintaining the Plan can be paid by the Plan or by the plan sponsor at its discretion.

Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements.

Fees related to the administration of benefit payments to participants are charged directly to participant accounts. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

The plan administrator has evaluated events through October 1, 2025, the date the financial statements were available to be issued. The plan administrator is not aware of any subsequent events that would require recognition or disclosure in the financial statements.

Note 3 – Investments

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA and certified that the plan qualifies for a Section 103(a)(3)(C) audit. The Plan has Newport Trust Company, LLC as the custodian. Newport Trust Company merged with Ascensus, LLC. Newport Trust Company, LLC certified the investment information as of January 1, 2023 to November 13, 2024. Ascensus, LLC, as agent for Newport Trust Company, LLC, certified the investment information for November 14, 2024 to December 31, 2024. Accordingly, as permitted under such election, the following investment information was certified by Ascensus, LLC and Newport Trust Company, the custodian, and was not subjected to any auditing procedures performed by the independent public accountants:

- A) Total investments as shown in the accompanying statements of net assets available for benefits of \$3,625,787 as of December 31, 2024, and \$2,693,396 as of December 31, 2023.
- B) Net investment income as shown in the accompanying statement of changes in net assets available for benefits of \$304,549 for the year ended December 31, 2024.
- C) All investment-related information in the accompanying supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

Participants direct the custodian regarding the investment of amounts held in their accounts.

Note 4 – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4 – Fair Value Measurements (Cont.)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The inputs used for valuing assets are not an indication of the risk associated with investing in those assets.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds (Registered Investment Companies): Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Although it has not expressed any intent to do so, the plan sponsor has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their accounts for any discretionary employer contributions.

Note 6 – Tax Status

The plan sponsor has adopted a non-standardized pre-approved plan offered by Newport Group, Inc. The plan was effective January 1, 2020. The plan has received an opinion letter dated June 30, 2020, stating that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended and restated subsequent to the date of the opinion letter, the plan sponsor believes the plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan as amended and restated is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. As of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan's federal Form 5500 is generally open to examination by relevant taxing authorities for a period of three years from the later of the date filed or the return due date (including all approved extensions). There were no tax audits in process at December 31, 2024 or 2023.

Note 7 – Risks and Uncertainties

The plan invests in various investments. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 – Party-in-Interest Transactions

Administrative expenses of \$20,110 were paid to Newport Group, Inc. who served as the plan's third party administrator, record keeper and prototype plan sponsor.

Additionally, investment management fees of \$5,536 were paid by plan participants to Qualified Plan Advisors.

The plan sponsor, who also serves as the plan administrator and employer, absorbs certain administrative costs of the plan. Plan management believes the plan has no agreements or transactions with parties-in-interest that are prohibited transactions under ERISA section 3(14).

Note 9 – 401(k) Rollover Accounting

The Plan received a rollover contribution of \$48,112 in December 2024. The related participant documentation was completed in January 2025, at which time the contribution was allocated to the participant's account. As of December 31, 2024, these amounts were included in plan assets as (unallocated) cash.
