### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Walsworth Publishing Company 401(k) Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ## NOTES TO FINANCIAL STATEMENTS

### ( 1 ) Description of plan

The following description of the Walsworth Publishing Company 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

**General** - The Plan is a defined contribution plan sponsored by Walsworth Publishing Company, Inc. (the "Company") for the benefit of its employees who become eligible to participate immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Donning Company Publishers, a wholly-owned subsidiary of the Company, is a participating employer in the Plan. As of September 28, 2024, Donning Company Publishers was merged into the Company and no longer reported as a separate entity. The Plan is administered by the Company's Board of Directors who has appointed an Advisory Committee ("Committee") to oversee the management of the Trust and Plan assets. The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

**Plan change** - Under the provisions of Secure 2.0 Act, effective January 1, 2024, the automatic force out distribution limit was increased from \$5,000 to \$7,000. The Plan implemented this change and will be amended for this provision by the time prescribed.

**Plan amendment** - Effective December 2, 2024, the Plan was amended to allow installment withdrawal payments.

**Contributions** - Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan to contribute 5% unless they affirmatively elect not to participate in the Plan. Effective December 2, 2024, the auto enroll percentage increased to 6%. The Company contributes 25% of the first 5% of base compensation that a participant contributes to the Plan. Matching contributions are discretionary as determined by the Company. Additional amounts may be contributed at the option of the Company. For the years ended December 31, 2024 and 2023, the Company made a non-elective contribution for certain participants who are not eligible to participate in the Company's defined benefit plan. These certain participants received between 2% - 4% of eligible compensation based on their years of service.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**Participant investment account options** - The Plan currently offers various mutual funds and a common collective trust as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

### ( 1 ) Description of plan (continued)

**Participant accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, and (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant who was not originally a part of the Ovid Bell Press, Inc. 401(k) Plan or the Ripon Printers, Inc. Profit Sharing and 401(k) Plan are 100% vested after three years of credited service.

Employer contributions for participants who were previously a part of the Ovid Bell Press, Inc. 401(k) Savings Plan are subject to the following vesting schedule:

**Notes receivable from participants** - The Plan does not allow loans, however, loans were transferred in as a result of the Ripon Printers, Inc. Profit Sharing and 401(k) Plan transfer. No new loans will be issued. Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits** - On termination of service for any reason, if a participant's balance is less than \$1,000, the benefit equal to the value of the participant's vested interest in his or her account will be distributed in a lump sum payment. If the participant's vested account balance is between \$1,000 and \$7,000 (\$5,000 for the year ending December 31, 2023), the participant's account balance will be rolled over into an Individual Retirement Account for his or her benefit. If the participant's balance is greater than \$7,000, the participant may delay their distribution until they are required by law to receive a minimum required distribution. Participants may elect to receive a lump sum payment, partial payment or installment payment.

( 1 ) **Description of plan (continued)**

**Forfeited accounts** - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,228 and \$4,171, respectively. These accounts will be used to reduce future employer contributions. Also, \$159,768 and \$75,500 were used from the forfeiture account to reduce employer contributions in 2024 and 2023, respectively.

( 2 ) **Summary of significant accounting policies**

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual method of accounting.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments.

#### ( 3 ) Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments.

- Investments at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### ( 4 ) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standard Board Accounting Standards Codification 820 are described below:

The asset or liability's fair value measurement level within fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value

("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value common collective trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

(b) The Putnam Stable Value Fund may defer honoring employer withdrawal requests or an asset allocation fund's withdrawal request, for up to 12 months. Notwithstanding such 12-month deferral, qualified employee-initiated benefit payments generally will continue to be made.

### ( 5 ) Related party transactions and party-in-interest transactions

Certain plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan; therefore these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the trustee of \$1,210 and \$1,975 for the years ended December 31, 2024 and 2023, respectively, which was not covered by revenue sharing. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

### ( 6 ) Plan termination

Although it has not expressed any intent to do so, the Company have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

#### ( 7 ) **Tax status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### ( 8 ) **Risks, uncertainties and concentrations**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, approximately 15% of the Plan’s investments were invested in the Fidelity Advisor Freedom Blend 2030 Fund.

#### ( 9 ) **Subsequent events**

The Plan has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Walsworth Publishing Company 401(k) Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). ## NOTES TO FINANCIAL STATEMENTS

### ( 1 ) Description of plan

The following description of the Walsworth Publishing Company 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

**General** - The Plan is a defined contribution plan sponsored by Walsworth Publishing Company, Inc. (the "Company") for the benefit of its employees who become eligible to participate immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Donning Company Publishers, a wholly-owned subsidiary of the Company, is a participating employer in the Plan. As of September 28, 2024, Donning Company Publishers was merged into the Company and no longer reported as a separate entity. The Plan is administered by the Company's Board of Directors who has appointed an Advisory Committee ("Committee") to oversee the management of the Trust and Plan assets. The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

**Plan change** - Under the provisions of Secure 2.0 Act, effective January 1, 2024, the automatic force out distribution limit was increased from \$5,000 to \$7,000. The Plan implemented this change and will be amended for this provision by the time prescribed.

**Plan amendment** - Effective December 2, 2024, the Plan was amended to allow installment withdrawal payments.

**Contributions** - Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan to contribute 5% unless they affirmatively elect not to participate in the Plan. Effective December 2, 2024, the auto enroll percentage increased to 6%. The Company contributes 25% of the first 5% of base compensation that a participant contributes to the Plan. Matching contributions are discretionary as determined by the Company. Additional amounts may be contributed at the option of the Company. For the years ended December 31, 2024 and 2023, the Company made a non-elective contribution for certain participants who are not eligible to participate in the Company's defined benefit plan. These certain participants received between 2% - 4% of eligible compensation based on their years of service.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**Participant investment account options** - The Plan currently offers various mutual funds and a common collective trust as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

### ( 1 ) Description of plan (continued)

**Participant accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, and (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant who was not originally a part of the Ovid Bell Press, Inc. 401(k) Plan or the Ripon Printers, Inc. Profit Sharing and 401(k) Plan are 100% vested after three years of credited service.

Employer contributions for participants who were previously a part of the Ovid Bell Press, Inc. 401(k) Savings Plan are subject to the following vesting schedule:

Employer matching contributions for participants who were previously part of the Ripon Printers, Inc. Profit Sharing and 401(k) Plan are immediately vested. Employer profit sharing contributions are subject to the following vesting schedule:

**Notes receivable from participants** - The Plan does not allow loans, however, loans were transferred in as a result of the Ripon Printers, Inc. Profit Sharing and 401(k) Plan transfer. No new loans will be issued. Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits** - On termination of service for any reason, if a participant's balance is less than \$1,000, the benefit equal to the value of the participant's vested interest in his or her account will be distributed in a lump sum payment. If the participant's vested account balance is between \$1,000 and \$7,000 (\$5,000 for the year ending December 31, 2023), the participant's account balance will be rolled over into an Individual Retirement Account for his or her benefit. If the participant's balance is greater than \$7,000, the participant may delay their distribution until they are required by law to receive a minimum required distribution. Participants may elect to receive a lump sum payment, partial payment or installment payment.

**Forfeited accounts** - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,228 and \$4,171, respectively. These accounts will be used to reduce future employer contributions. Also, \$159,768 and \$75,500 were used from the forfeiture account to reduce employer contributions in 2024 and 2023, respectively.

( 2 ) **Summary of significant accounting policies**

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual method of accounting.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments.

#### ( 3 ) Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments.

- Investments at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### ( 4 ) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standard Board Accounting Standards Codification 820 are described below:

The asset or liability's fair value measurement level within fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value

("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value common collective trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

(b) The Putnam Stable Value Fund may defer honoring employer withdrawal requests or an asset allocation fund's withdrawal request, for up to 12 months. Notwithstanding such 12-month deferral, qualified employee-initiated benefit payments generally will continue to be made.

### ( 5 ) Related party transactions and party-in-interest transactions

Certain plan investments are shares of mutual funds managed by Fidelity. Fidelity is the trustee as defined by the Plan; therefore these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the trustee of \$1,210 and \$1,975 for the years ended December 31, 2024 and 2023, respectively, which was not covered by revenue sharing. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

### ( 6 ) Plan termination

Although it has not expressed any intent to do so, the Company have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

#### ( 7 ) Tax status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### ( 8 ) Risks, uncertainties and concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, approximately 15% of the Plan’s investments were invested in the Fidelity Advisor Freedom Blend 2030 Fund.

#### ( 9 ) Subsequent events

The Plan has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
