Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MSSC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the MSSC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General—The Plan is a defined contribution plan covering substantially all salaried and hourly employees of MSSC Inc. (the “Company”). Fidelity Management Trust Company serves as trustee and recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility—Regular full-time employees who have completed 30 days of service and are not:

- Union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, unless the collective bargaining agreement requires the employee to be included in the Plan.
- Certain nonresident aliens who have no earned income from sources within the United States.
- Leased employees.
- Japanese Nationals or Resident Aliens, on assignment in the United States, from the Parent Corporation (Mitsubishi Steel Manufacturing).

Contributions:

Participant Contributions—Each year, participants may contribute up to the maximum amount allowed by Internal Revenue Code (IRC) of their pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing rollovers from other qualified defined benefit or defined contributions plans.

Company Match Contributions—The Company provides matching contributions, matching 50% of the first 6% of the compensation that a participant contributes to the Plan.

Age 50 and Over Catch-Up Contributions—The Plan provides that participants who are projected to be age 50 or older by the end of the taxable year and who are making deferral contributions to the Plan may also make catch-up contribution; these contributions are ineligible for a Company matching contribution.

Company Safe Harbor Non-Elective Contributions—The Company contributes 3.5% of all eligible compensation into all participant accounts. Employees receive this contribution regardless of whether they choose to contribute their own money to the Plan.

Participant Accounts—Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, age 50 and over catch-up contributions and Company Safe Harbor Non-Elective Contributions and Plan earnings, and charged with withdrawals, administrative expenses, and an allocation of Plan losses. Allocations are

based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments—Participants direct the investment of their contributions into various investment options offered by the Plan. Company contributions are automatically invested in the various investment options as directed by the participant. The Plan currently offers various mutual funds and a common collective trust as investment options for participants.

Vesting—Participants are immediately vested in their participant contributions, catch-up contributions, rollover contributions, and related earnings thereon. Participants begin vesting in the Company match contributions after two years of service and become fully vested after six years of service. The participant's vesting in the Company match increases 20% each year between years two and six of service. Participants are immediately vested in the Company Safe Harbor Non-Elective Contributions.

Notes Receivable from Participants—Prior to January 1, 2013, participants borrowed from their accounts up to a maximum of \$50,000 or 50% of their account balance, whichever was less. Loan terms did not exceed five years, however, terms exceeded five years for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bore interest at rates commensurate with local prevailing rates at the time funds were borrowed, as determined quarterly by the Plan administrator. Principal and interest were paid ratably through payroll deductions. Effective January 1, 2013, participant loans are no longer allowed by the Plan.

Payment of Benefits—A distribution may be made for disability, retirement, or termination of employment from the Company. A beneficiary or beneficiaries may request a distribution of the vested account balance in the event of participant death. Participants have distribution options including a lump sum option equal to the participant's vested interest in his or her account, a rollover of the funds into another employer's qualified 401(k) plan or into an IRA account. Participants may also elect to receive a hardship distribution if certain criteria are met.

Forfeited Accounts—When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$577 and \$21, respectively. These accounts will be used to reduce future employer contributions or to pay expenses. During the year ended December 31, 2024, employer contributions were reduced by \$4,358 from forfeited non-vested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will

occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition—The Plan's investments are stated at fair value. The fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Administrative Expenses—Certain administrative expenses of the Plan are paid by the Plan sponsor as provided in the Plan document. Participants pay administrative costs for certain distributions.

The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investment fees to the recordkeeper to offset the Plan's administrative expenses. Future Plan expenses can be paid from any excess remaining revenue sharing amounts.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. Amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, were \$31,301 and \$367 at December 31, 2024 and 2023. Benefits payable are not reported on the statement of net assets, however, are reported in the Form 5500.

Excess Contributions Payable—The Plan is required to return contributions received during the Plan year in excess of the IRC limits. There were no excess contributions payable to participants as of December 31, 2024, and 2023.

3. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market, but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund - A common collective trust that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 60 days prior notification and is subject to potential application of a twelve-month "put" or delay in payment.

5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are sponsored and managed by Fidelity Trust Management Company. Fidelity Trust Management Company is the trustee as defined by the Plan, and these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

The Plan no longer issues loans to participants under the deferred arrangement portion of the Plan, which were secured by the vested balances in the participants' accounts. However, there is still an outstanding loan balance of \$7,053.

Administrative revenues arise when investment managers return a portion of the investment fees to Fidelity Management Trust Company to offset the administrative expenses. Any excess resulting from this revenue sharing remains in an unallocated account from which future Plan expenses can be paid.

6. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

7. FEDERAL INCOME TAX STATUS

The Plan uses a non-standardized pre-approved plan document sponsored by Fidelity Management & Research Company LLC ("FMR"). FMR received an advisory letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the non-standardized pre-approved document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The

non-standardized pre-approved plan document has been amended since receiving the opinion letter, however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan Sponsor believes the Plan has maintained its tax-exempt status. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. SUBSEQUENT EVENTS

Subsequent events were evaluated through October 3, 2025, the date the financial statements were available to be issued.
