We have performed audits of the accompanying financial statements of the Bixal Solutions, Inc. 401(k) Retirement Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). **Note 1—Description of the Plan**

The following description of the Bixal Solutions, Inc. 401(k) Retirement Plan (the “Plan”) is provided for general purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

*General* – Bixal Solutions, Inc. (the “Company” or the “Plan Sponsor”) established the Plan on June 15, 2015, and amended and restated the Plan on June 6, 2024. There were no material modifications made to the Plan as a result of the most recent Plan amendment. The Plan is a defined contribution plan which is intended to qualify under section 401 of the Internal Revenue Code (“IRC”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Investment Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

*Eligibility* – The Plan covers substantially all employees of the Company who have a minimum of 90 days of service. There is no age requirement. In general, covered employees may enter the Plan on the first day of each month coinciding with or next following the date on which they satisfy the eligibility requirements.

*Participant Contributions* – Each year, participants may elect to contribute a percentage of their eligible compensation to the Plan in pre-tax or after-tax Roth contributions up to \$23,000, the maximum allowed under the IRC. IRC annual limitations apply to all participant salary reductions and similar contributions under this and other plans. In addition, participants 50 years of age or older may elect to make a catch-up deferral contribution of up to \$7,500 for the year ended December 31, 2024. Qualified distributions from other qualified retirement plans can be contributed to the Plan and retained as a rollover contribution.

*Employer Contributions* – The Company contributes 100% of the first 3% plus 50% of the next 2% of compensation that a participant contributes to the Plan as a safe harbor matching contribution. The safe harbor matching Company contribution is invested as directed by the participant. In addition, the Plan allows for a discretionary profit-sharing employer contribution each year. Participants must be employed on the last day of the Plan year and have 1,000 hours of service to receive their allocated share of the profit-sharing contribution. For 2024, the Company elected to make no profit-sharing contribution to the Plan. Contributions are subject to Internal Revenue Service (“IRS”) limitations.

*Participant Accounts* – Individual accounts are maintained for each participant and include participants’ salary deferral contributions, rollover contributions, plus an allocation of the Plan Sponsor’s safe harbor matching contribution, if any, profit-sharing contribution, if any, and Plan earnings (losses), including realized and unrealized gains and losses on investments, and charged with the participant’s distributions and the allocation of Plan expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – Participants are immediately vested in their salary deferral contributions, rollover contributions, and employer safe harbor matching contributions, plus actual earnings (losses) thereon. A participant also becomes 100% vested upon death, becoming disabled, or reaching retirement age, as defined by the Plan. The employer discretionary profit-sharing contribution is vested as follows:

*Investment Options* – Participants may direct Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal”, “qualified institution”, or the “Trustee”) as to the investment of their account balance into various investment options offered by the Plan. Participants may change their investment directions at any time, subject to such restrictions and procedures as established by Principal, the Plan, and the Company. The Plan’s investment committee selects the investment options available under the Plan.

*Payment of Benefits* – On termination of service, a participant may receive a lump sum amount equal to the value of the vested balance in their account or rollover their vested account balance to another qualified plan. Participants that have reached age 59½ may take in-service withdrawals. The Plan also allows, in certain hardship situations as defined in the Plan, participants to withdraw from their account balances while actively employed. These hardship withdrawals are subject to IRC restrictions and penalties. There is no provision for mandatory distributions by the Employer after a participant severs their relationship with the Company.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum amount that is equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are not to exceed five years, except for loans to purchase or construct a primary residence which are permitted to be repaid over a maximum of 15 years. Participant loans are secured by the participant’s remaining balance in the Plan and bear a reasonable rate of interest that provides a return commensurate with the prevailing interest rate charged on similar loans by persons in the business of lending money. As of December 31, 2024, interest rates on loans to participants ranged from 5.25% to 10.50% with the longest maturity date in September 2029. Participants repay loan principal and interest ratably through payroll deductions.

*Administration* – The Plan is administered by the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses are paid directly by the Plan Sponsor.

**Note 2—Summary of significant accounting policies**

*Basis of Accounting* – The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

*Risks and Uncertainties* – The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Note 2—Summary of significant accounting policies (continued)**

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

*Benefits Paid to Participants* – Benefits paid to participants are recorded when paid.

*Investment Valuation and Income Recognition* – Investments (other than fully benefit-responsive investments) in the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive investments are reported at contract value.

Contract value is the relevant measurement for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

*Administrative Expense* – The Plan pays certain maintenance expenses which are included in these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable are included in administrative expenses and charged directly to the participant's account.

*Fair Value Measurements* – U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability, including assumptions regarding risk.

**Note 2—Summary of significant accounting policies (continued)**

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

*Mutual Funds* – Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within Level 1 of the valuation hierarchy.

*Self-Directed Brokerage Account* – This investment provides access to invest in a wide-array of mutual funds and individual stocks that are publicly traded. Holdings in this account are classified within Level 1 of the valuation hierarchy.

*Pooled Separate Accounts* – These investments are public investment vehicles valued using NAV as a practical expedient to estimate fair value provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the funds, minus liabilities, and then divided by the number of shares outstanding. In accordance with Subtopic 820-10, the pooled separate accounts have not been classified under the fair value hierarchy.

*Common/Collective Trusts* – These investments are public investment vehicles valued using NAV as a practical expedient to estimate fair value provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the funds, minus liabilities, and then divided by the number of shares outstanding. In accordance with Subtopic 820-10, the common / collective trusts have not been classified under the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. As of December 31, 2024, there were no changes in methodology.

**Note 3—Information certified by the qualified institution (unaudited)**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the qualified institution, has certified the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

**Note 5—Guaranteed investment contract with insurance company**

The Plan is invested in a fully benefit-responsive guaranteed investment contract with Principal Trust Company (“Principal Trust”). Principal Trust maintains the contributions in a pooled account. The account is credited with earnings and (losses) on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal Trust, represents contributions made under the contract, plus earnings (losses), less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor’s business; (5) removal from the Plan of one or more groups or classifications of participants; (6) partial or complete Plan termination; or (7) Plan disqualification. The Plan administrator does not believe the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. There are no unfunded commitments as of December 31, 2024 and 2023 and the redemption frequency is daily. The guaranteed minimum interest rate is 1.00%. Under the terms of the existing contract, the composite crediting rate is currently reset on a semiannual basis and will never be less than the guaranteed minimum interest rate. Average yield earned by the Plan is calculated by dividing the annualized earnings (losses) of all fully benefit-responsive investment contracts by the fair value of all fully benefit responsive investment contracts. The average yield earned by the Plan is the yield earned (i.e., interest credited) on the group annuity contract. The interest rate history for the contract is as follows:

**Note 6—Parties-in-interest**

Certain Plan assets as December 31, 2024 are invested in funds sponsored by the Trustee. Transactions involving these investments are considered party-in-interest transactions for which statutory exemption exists under DOL regulations. Fees paid to the Trustee totaled \$68,023 for the year ended December 31, 2024. Notes receivable from participants also qualifies as party-in-interest transactions. Other income consists primarily of an expense sharing fee which is the result of adjustments made to investment options. The sharing fee is credited to participant accounts.

**Note 7—Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. In the event of Plan termination, participants will become 100% vested in their account balances.

**Note 8—Tax status**

The IRS has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter; however, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**Note 9—Subsequent events**

The Plan has evaluated subsequent events through October 1, 2025, in connection with the preparation of these financial statements, which is the date the financial statements were available to be issued.
