## **Independent Auditors' Report**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Haynie & Co. 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net asset available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

**Note 1 - DESCRIPTION OF PLAN**

The following description of the Haynie & Co. 401(k) Plan (the "plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions which is available from the plan administrator.

**GENERAL**

The plan is a defined contribution retirement plan covering all full-time and part-time employees of Haynie & Company, the plan sponsor, who have completed six months and 500 hours of service. Union employees and non-resident aliens are not eligible to participate in the plan. If the employee has not completed 500 hours of service in the first six months, they will have satisfied the service requirement after one year of service. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**CONTRIBUTIONS**

Participants may contribute a percentage of eligible annual compensation not to exceed the annual dollar limitation defined by the Internal Revenue Code, as defined in the plan. Participants may also contribute amounts representing rollover distributions from other qualified plans. Additionally, the plan includes an auto-enrollment provision where all newly eligible employees are automatically enrolled in the plan unless they formally elect not to participate. The auto-enrollment deferral rate is set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. All contributions are invested with Empower Annuity Insurance Company of America and Empower Trust Company, LLC. The company may make discretionary matching contributions of up to 50% of employee contributions for up to 2% of eligible compensation. The company made discretionary matching contributions of \$552,127 for the year ended December 31, 2024.

The company may also make discretionary profit sharing contributions to the plan, subject to certain limitations. There were no discretionary profit sharing contributions made to the plan for the year ended December 31, 2024.

**PARTICIPANT ACCOUNTS**

Each participant account is credited with the participant's contribution, the company's contribution, and the allocation of the plan earnings less any related investment expenses. Allocations of income, forfeitures and expenses are based on the proportion of each participant's account to the total of all participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**VESTING**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant becomes 20% vested in company contributions after two years of service and vests ratably thereafter until 100% vested after six years of credited service.

**INVESTMENT OPTIONS**

Upon enrollment in the plan, participants are able to direct their contributions, including company contributions, among any or all of the investment account options. Investment options are shares of registered investment companies held by Empower Trust Company, LLC and a guaranteed investment contract held by Empower Annuity Insurance Company of America. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options daily. There are no nonparticipant directed investments.

Contributions may be temporarily held as cash balances prior to the execution of the investment according to the participant's direction.

The plan provides for various investment fund options, which, in turn invest in a combination of stocks, bonds, and other investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risks. Market risk include global events which could impact the value of investment securities, such as tariff impositions or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts. The amount the plan may loan to a participant is limited by rules under the Internal Revenue Code. The maximum amount a participant may borrow is equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan amount is \$1,000. Loan terms generally range from one to five years. If used to acquire a principal residence the plan administrator can permit a longer repayment period. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions. The loans can be repaid at any time. The plan has determined that all notes receivable are fully collectible.

**PAYMENT OF BENEFITS**

On termination of service due to death, disability or retirement, a participant or beneficiary with a balance in excess of \$5,000 may elect to receive a single lump-sum distribution, a partial distribution, or installment distributions, equal to the value of the participant's vested interest in his or her account. Participants with a vested balance under \$5,000 must receive the distribution in a lump sum upon termination. Benefits are recorded when paid.

**HARDSHIP WITHDRAWALS**

Participants are permitted to withdraw, in a single sum, employee deferrals of their account balance under certain conditions. These conditions include unreimbursed medical expenses, the purchase or repair of damage of the participant's principal residence, the payment of post-secondary education tuition, the payment of certain burial or funeral expenses or to prevent eviction or foreclosure from the participant's principal residence.

**FORFEITURES**

Forfeitures of nonvested company contributions are used to pay any plan administrative expenses, reduce employer matching contributions or are allocated to each participant's account based on the proportion of each participant's account to the total of all participant account balances. There were unallocated forfeitures of \$8,216 and \$58,134 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeitures of approximately \$89,000 were used to offset company matching contributions.

**ADMINISTRATION OF PLAN ASSETS**

Plan assets are held in accounts managed by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians, and record keeping is performed by Empower Retirement, third party administrators. Certain administrative expenses are paid by the plan and therefore qualify as party-in-interest transactions. The accompanying financial statements include \$52,251 for the year ended December 31, 2024, related to these expenses. Employees of the plan sponsor, who are owners, directors, executives or members of the investment committee participate in the plan, and transactions with these individuals may qualify as party-in-interest transactions.

The plan also uses the services of an independent public accounting firm to audit the plan. Administrative expenses for the year ended December 31, 2024 includes \$12,000 paid by the plan for the independent public accounting firm's audit fee. Certain administrative expenses for the plan are paid by the plan sponsor and are not included in the financial statements.

**Note 2 - SUMMARY OF ACCOUNTING POLICIES****BASIS OF ACCOUNTING**

The financial statements of the plan are prepared using the accrual method of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results may differ from those estimates.

**GUARANTEED INVESTMENT CONTRACT**

The plan's guaranteed investment contract is valued at contract value as contract value is the relevant measurement attributable to fully benefit-responsive contracts. Contract value represents the amount the participants would receive if they were to initiate permitted transactions under the terms of the plan. The guaranteed investment contract value at December 31, 2024 and 2023 were \$530,614 and \$487,141, respectively.

**VALUATION OF INVESTMENTS AND INCOME RECOGNITION**

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the plan's gains and losses on investments bought and sold as well as those investments held during the year.

#### CONTRIBUTIONS RECEIVABLE

The plan records contributions receivable for any contributions owed to the plan, and not yet paid as of December 31, 2024 and 2023. This includes payroll that was paid before year-end, but contributions were not yet funded, and/or for employer contributions related to 2024 and 2023 that were not yet funded for the years then ended. For the years ended December 31, 2024 and 2023, participant contribution receivables were \$90,175 and \$111,361, respectively, and employer contributions receivable were \$172,911 and \$166,374, respectively.

#### NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the plan's financial statements.

#### SUBSEQUENT EVENTS

The plan has evaluated subsequent events through September 29, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

### Note 3 - FAIR VALUE MEASUREMENTS

The plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

FASB ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority and Level 3 inputs have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or 3 inputs were used by the plan.

#### *Level 1 Fair Value Measurements*

The fair value of registered investment companies is based on quoted net asset values of the shares held by the plan at year-end.

There have been no changes in the fair value measurement methodologies used at December 31, 2024 and 2023.

#### **Note 4 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

Key Guaranteed Portfolio Fund (the Fund) investment choice is a nontradeable obligation of Empower Annuity Insurance Company of America ("Empower"). The fund maintains the contributions in a general account of Empower. The objective of the Fund is to protect against loss of principal while providing returns comparable to money market funds and short-term treasury instruments. Characteristics of this investment allows for principal value to remain stable regardless of the volatility of the financial markets. This contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measurement of fully benefit-responsive investment contracts because this is the amount received by the participant if they were to initiate permitted transactions under the terms of the plan. Contract value represents contributions made, plus earnings, less participant withdrawals, and administrative expenses.

The fund has no stated maturity date. Interest rates are reset monthly as of the beginning of each month, during which a new interest rate is applied daily to the total outstanding balance of the investment. For deposit liabilities with no defined maturities, contract value is the amount payable on demand at the reporting date.

Certain events, such as the premature termination of the contract by the plan or the termination of the plan, may limit the plan's ability to transact at contract value with the issuer. The plan administrator does not believe that the occurrence of such events, which would also limit the plan's ability to transact at contract value with the participant, is probable.

In addition, certain events allow the Empower to terminate the contract with the plan and settle at an amount different from contract value. Such events include the following: (1) an uncured violation of the plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

**Note 5 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the plan custodians, certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Contract value of guaranteed investment contract
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividend income
- Interest income on notes receivable from participants
- Investments, as reflected in Schedule H, Line 4(i) - Schedule of assets (Held at End of Year)

The plan's independent public accountants did not perform auditing procedures with respect to the information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become one hundred percent vested in their accounts.

**Note 7 - TAX STATUS**

The plan sponsor has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service ("IRS") dated November 14, 2022, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The plan administrator believes that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified.

The plan has adopted the provisions of FASB ASC 740-10, *Income Taxes*, relating to accounting for uncertain tax positions. ASC 740-10 defines a recognition threshold and measurement process for accounting for uncertain tax positions and also provides guidance on various related matters such as interest, penalties, derecognition and disclosures. The plan does not have any plan level uncertain tax positions. The plan files income tax returns in the U.S. federal jurisdiction. The plan administrator believes the plan is no longer subject to U.S. federal examinations by tax authorities for years before 2021.
