For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1 - Description of Plan

The following description of the Layton Construction Company, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was established on October 1, 1985, and restated and amended in the Plan years 2010, 2012, 2015-2019, 2022, and 2024, is a defined contribution plan covering all eligible employees of Layton Construction Company, LLC (the "Sponsor") and the following related employers: Layton Southwest, Inc., Interior Construction Specialists, Inc. and Safety Specialists, Inc. Employees are eligible if they are age 21 or older and have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2022, the Plan was amended to make an election for purposes of ADP/ACP testing to current year testing method.

Effective February 22, 2022, the Plan was amended and restated to incorporate changes in the trust agreement.

Effective April 11, 2022, the Plan was amended to incorporate a provision that no other employers participate in the Plan.

Effective January 1, 2024, the Plan was amended to exclude all nonstatutory stock options and vested restrictive stock units from Plan compensation.

Contributions

Each year, participants may contribute up to 100% of eligible annual compensation, as defined in the Plan, provided that such contributions do not exceed the limitations under the Internal Revenue Code (the "Code") for 2024 of \$23,000, plus a maximum of \$7,500 in catch-up contributions for participants who have attained age 50 before the end of the Plan-year. Contributions may be made as a pre-tax deferral or after-tax (Roth) deferral. Highly compensated employees are subject to additional limits set forth in the Code. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The automatic deferral increases by 1% each year up to a maximum deferral rate of 6%, unless the participant elects otherwise. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions.

Contributions (cont'd.)

The Sponsor makes a Qualified Automatic Contribution Arrangement ("QACA") Safe Harbor employer matching contribution to each participant's account equal to 100% of the first 1% of each participant's contribution and 50% of the next 5% of each participant's contribution. For the year ended December 31, 2024, the Sponsor made QACA Safe Harbor employer matching contributions of \$4,500,893. The Sponsor may make discretionary profit-sharing contributions to the Plan at the option of the Sponsor's Board of Directors. For the year ended December 31, 2024, the Sponsor did not make a profit-sharing contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Sponsor's matching and profit-sharing contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and safe harbor employer contributions plus actual earnings thereon. Vesting in the Sponsor's profit-sharing contribution portion of their accounts is based on years of continuous service as follows:

| One year but less than two years | 50% |
| Two or more years | 100% |

In addition, a participant becomes 100% vested in all allocated Sponsor contributions upon death, disability or the attainment of age 59½ while employed by the Sponsor.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. The loans are secured by the balance in the participant's account and bear interest at reasonable rate of interest. The interest rate is determined as of the date of origination and is fixed for the loan term. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the funds are used to acquire a principal residence, in which case the maximum repayment period is ten years.

Payment of Benefits

On termination of service due to death, a participant's beneficiary receives a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$103,000 and \$9,000, respectively. These accounts will be used in any permissible method to restore forfeitures, reduce future contributions, or pay Plan expenses. Approximately \$100,000 of forfeitures were used to reduce 2024 employer contributions that were remitted to the Plan in 2025.

Revenue Credit Account

The Plan has a revenue credit account with the Trustee to cover Plan expenses. The revenue credit account must be used only for legitimate Plan expenses. Unused amounts for expenses may be allocated to participant accounts. The Trustee made no contributions to the revenue credit account during 2024.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the participant's account. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are reclassified as distributions once the participant is no longer employed by the Sponsor. Interest rates on loans outstanding at December 31, 2024 ranged from 3.25% to 8.50%.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment-related expenses are included in net appreciation in fair value of investments. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan.

Note 3 - Information Certified By Trustee

The following information, including investments and notes receivable from participants at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan.

Note 4 - Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Fair Value Measurement (cont'd.)

Common collective trusts: Valued at the NAV of units of the bank collective trust and composed primarily of collective instrument trust units. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount difference than the reported NAV. Participant transactions (purchases and sales) occur daily.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value at December 31, 2024 and 2023. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

Note 5 - Related Party Transactions and Party-In-Interest Transactions

The Trustee of the Plan is Fidelity. Therefore, fees paid to this entity qualify as party-in-interest transactions. The fees paid to Fidelity for recordkeeping services total \$19,736 in 2024.

Strategic Advisors, Inc. is a Plan advisor. In 2024, the fees paid to Strategic Advisors, Inc. totaled \$37,485.

Certain Plan investments are shares of mutual funds managed by Fidelity Investments Institutional Operations Company, Inc., which is an affiliate of Fidelity. Therefore, the transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in the net change in the fair value of investments.

Notes receivable from participants also qualify as party-in-interest transactions.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7 - Tax Status

The IRS has determined and informed the Plan administrator by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that at December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset, or require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - QNEC and QMAC Contributions - Employer

In 2023, the Sponsor identified an error concerning includible compensation for purposes of employee deferral and employer matching contributions. The terms of the Plan generally require that a Plan participant's eligible compensation excludes bonuses, commissions, compensation received for services performed for non-signatory related employers, and all fringe benefits for purposes of all contribution sources, except for purposes of employee deferrals and employer matching contributions. For the Plan year ended 2023, the taxable value of stock options was improperly excluded for purposes of employee deferral and employer matching contributions.

In 2024, the Sponsor corrected this error in accordance with the Internal Revenue Service's voluntary fiduciary correction program, which is part of the Employee Plans Compliance Resolution System ("EPCRS") by calculating and making Qualified Nonelective Contributions ("QNEC") and Qualified Matching Contributions ("QMAC"). The amount totaled \$119,037, including earnings. This amount represents the aggregate contributions the Sponsor should have contributed to participants' accounts based on their respective restricted stock units. This amount is recorded on the accompanying statement of changes in net assets available for the benefits for the year ended December 31, 2024 as "QNEC and QMAC contributions - employer."

As of January 1, 2024 the Plan was amended to exclude the taxable value of stock options from Plan compensation.

Note 10 - Subsequent Events

The Plan administrator has evaluated all events or transactions that occurred after December 31, 2024 through September 30, 2025, which is the date that these financial statements were available to be issued. During this period, there were no material subsequent events requiring disclosure.
