Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Girl Scouts of San Jacinto Council 401(k) Profit-Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Girl Scouts of San Jacinto Council 401(k) Profit-Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. Responsibilities of Management for the Financial Statements

Notes to Financial Statements for the year ended December 31, 2024

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of Girl Scouts of San Jacinto Council 401(k) Profit-Sharing Plan (the Plan) is provided for general informational purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

General – The Plan covers substantially all employees of Girl Scouts of San Jacinto Council (GSSJC), except for summer camp program staff, excluding camp directors, immediately upon date of hire. The Plan is a participant-directed, defined contribution plan established by GSSJC under the provisions of Section 401(a) of the Internal Revenue Code (the Code), with a cash or deferred arrangement qualified under Section 401(k) of the Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – The Plan provides for contributions by both the participant and employer as follows:

- *Participant contributions* – Participants may contribute up to 100% of their compensation as defined by the Plan, on a pre-tax basis or as Roth contributions on an after-tax basis, subject to certain limitations under the Code. The Plan allows catch-up contributions, as defined by the Code, for participants who have attained the age of 50 prior to the end of the year. Participants also may rollover any amounts they receive as distributions from another qualified plan into their individual account. The Plan includes an automatic salary deferral feature. GSSJC will automatically withhold a portion of the participants' compensation each payroll period and contribute that amount to the Plan as a salary deferral unless an alternative salary deferral election is made. The automatic deferral percentage is 4% and will increase 1% each year thereafter until the automatic deferral percentage reaches 8%.
- *Employer contributions* – GSSJC makes an employer matching contribution equal to 50% of the participant's contributions (excluding catch-up contributions) that do not exceed 4% of the participant's compensation as defined by the Plan. GSSJC also may make an additional discretionary contribution to all eligible participants who are actively employed with GSSJC on the last day of the Plan year. There was no additional discretionary contribution in 2024.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in employer contributions plus actual earnings thereon is based on years of continuous service. Participants vest 25% per year after two years of credited service, becoming 100% vested after five years of credited service. Participants also are 100% vested in the employer matching contributions plus actual earnings thereon upon attaining normal retirement age, if earlier.

Participant accounts – Each participant's account is credited with the participant's contributions, the employer matching contributions, and an allocation of the investment earnings and expenses for each fund in which their account is invested. Allocations of investment income are based on the proportion that each participant's account balance bears to the total of all participant account balances. Plan expenses not paid by the employer are allocated to each participant's account. The only benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes receivable from participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance

in the preceding one-year period or 50% of their vested account balance. Participants can have no more than two loans outstanding at any time. The balances in the participants' accounts secure the loans. Loan terms range from one to five years, unless for the purchase of a principal residence, for which loan terms may be up to 10 years. Interest rates are determined by Mutual of America Life Insurance Company (Mutual of America).

Forfeitures – The Plan uses any amounts forfeited to reduce future employer contributions. During 2024, \$19,496 in forfeitures was used to reduce employer contributions. There were no unused forfeitures at December 31, 2024 and 2023.

Benefit payments – The Plan provides for benefit distributions to the plan participants, or their beneficiaries, equal to the vested balance of their accounts upon death, disability, retirement, or other termination of employment. Participants may withdraw a portion or all of their elective participant contributions, while still employed, upon reaching the age of 59½. Additionally, participants may qualify for a hardship withdrawal of their elective participant contributions, while still employed, for the purpose of immediate and heavy financial needs, as defined in the Plan document.

Plan termination – Although it has not expressed any intent to do so, GSSJC has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination, participants become 100% vested in their employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation – Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment adviser and Mutual of America. See Note 6 for discussion of fair value measurements.

The Plan invests in a fully benefit-responsive investment contract, the Interest Accumulation Account (IAA), and reports this investment in the financial statements at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value of the fully benefit-responsive contract represents contributions plus earnings, less participant withdrawals and administrative expenses.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan

administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions from Plan participants and employer matching contributions are recorded in the year in which the participant contributions are withheld from compensation.

Benefit payments – Benefit payments to participants are recorded upon distribution.

Expenses – Certain expenses of maintaining the Plan are paid directly by GSSJC and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Certain investment management fees are included in net appreciation in fair value of investments. Other investment-related and recordkeeping expenses paid by the Plan are included in administrative expenses.

Estimates – Management must make estimates and assumptions to prepare financial statements in accordance with generally accepted accounting principles. These estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported amounts of additions and deductions. Actual results could vary from the estimates that were used.

NOTE 3 – TAX STATUS

GSSJC has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated November 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Code. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 4 – INVESTMENTS

At December 31, 2024 and 2023, substantially all assets of the Plan were invested in funds managed by Mutual of America, as an insurance company of the Plan. These transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participant account balances.

NOTE 5 – INFORMATION CERTIFIED BY INSURANCE COMPANY

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to notes receivable from participants and investments held at December 31, 2024 and 2023, net appreciation in fair value of investments and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America, a qualified institution.

NOTE 6 – FAIR VALUE MEASUREMENTS

All investments reported at fair value as of December 31, 2024 and 2023 are invested in pooled separate accounts. Pooled separate accounts are valued at net asset value by the issuer as a practical expedient based on the fair value of the underlying investments held less liabilities and are not required to be reported in the fair value hierarchy. There have been no changes in the methods used at December 31, 2024 and 2023. This valuation method may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate, the use of different methods or assumptions could result in a different fair value measurement at the reporting date.

The investment accounts included in pooled separate accounts consist of (1) equity accounts, (2) target-date retirement accounts, (3) asset allocation accounts, (4) fixed-income accounts, (5) balanced accounts, and (6) a money market account. Equity accounts seek a favorable rate-of-return through capital appreciation and investment income by investing primarily in a broadly diversified portfolio of U. S. common stocks. Target-date retirement accounts seek high total return over time through a combination of capital appreciation and income by investing in an asset allocation strategy designed for investors planning to retire at certain intervals. Asset allocation accounts seek capital appreciation and current income by investing in a target allocation of equity and fixed-income funds based on risk profiles of the account. Fixed-income accounts seek to provide a high level of current income over time consistent with prudent investment risk, as well as preservation of capital by investing primarily in investment grade, publicly-traded debt securities. Balanced accounts seek to provide capital appreciation and current income by investing in a diversified portfolio of various asset classes and investment strategies, including equity and fixed-income securities. The money market account seeks realization of current income consistent with the maintenance of liquidity, investment quality and stability of capital. Participant-directed redemptions have no restrictions; however, should the Plan discontinue its contract with Mutual of America, the date of discontinuance shall be the first day of the calendar month that is at least 31 days after the date notice is received by Mutual of America. There are no unfunded commitments at December 31, 2024.

NOTE 7 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into an investment contract with Mutual of America. The general account portion of this contract, or the IAA, represents a deposit administration contract, and the assets in this account are commingled with other assets of the insurance company. The IAA is fully benefit-responsive and reported at contract value. The IAA is credited with interest at the rate specified in the contract, but may not be less than 1%, and is charged with the purchase price of annuities when participants retire and with any incidental benefits (death, disability, and withdrawal) disbursed directly from the account. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events may limit the ability of the Plan to transact at contract value such as: (1) complete or partial plan termination or merger with another plan, (2) plan sponsor events such as bankruptcy, spin-offs, divestitures, layoffs, or retirement incentive programs, (3) the liberalization of Plan withdrawal or transfer rules, or (4) the failure of the trust to qualify for exemption from federal income taxes or any

required prohibited transaction exemption under ERISA. Upon occurrence of any of these events, a market value adjustment may apply. GSSJC does not believe the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 8 – SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 17, 2025, which is the date that the financial statements were available for issuance. As a result of this evaluation, no events were identified that are required to be disclosed or would have a material impact on reported net assets available for benefits or changes in net assets available for benefits.
