Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Sports, Hospitality and Entertainment 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 DESCRIPTION OF PLAN

The following description of Sports, Hospitality and Entertainment 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective January 1, 1998. The Plan has been amended and restated throughout the years to comply with tax legislation. The Plan was most recently restated effective January 1, 2022, and most recently amended effective November 15, 2024, to provide credit for predecessor service for Keens Steak LLC and to add the company as a participating employer and to modify certain Plan provisions for Keens Steak LLC participants. The Plan is a multiple employer plan and covers all employees of Fertitta Entertainment, Inc. (the Plan Sponsor) and its controlled group subsidiaries, Catch Fertitta, LLC and its controlled group subsidiaries, Rocket Ball Ltd., Landry's Management, L.P., Fertitta Hospitality, LLC, 1600 West Loop South, LLC, Top Shelf Holdings, LLC, Go Rio San Antonio, LLC, CC eSports, LLC, Fertitta Auto Group, LLC and Keens Steak LLC (collectively referred to as the Employer).

The Plan excludes leased employees, highly compensated employees; nonresident aliens with no U. S. source income; and employees covered by a collective bargaining agreement. The Plan also excludes hourly wage employees employed by any Employer (other than Keens Steak LLC) if that Employer is solely classified as a restaurant or bar (other than a salaried employee that is classified as "non-exempt" for purposes of the Fair Labor Standards Act), independent contractors, certain hourly-wage employees as defined in the Plan and residents of Puerto Rico are excluded from participation in the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan administrator is responsible for the oversight of the Plan. The Employee Benefits Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

The Plan permits employees (except as noted above) who have attained age 21 and completed one month of service to participate in the deferral portion of the Plan and one year of service with 1,000 hours to participate in the Employer matching portion of the Plan (except Rocket Ball Ltd. employees). Rocket Ball Ltd. employees who have attained age 21 and completed one month of service may participate in the Employer matching portion of the Plan.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect up to 75% of their eligible compensation contributed as pre-tax 401(k) or after-tax Roth contributions to the Plan. Participants who have attained age 50 are permitted to make catch-up contributions to the Plan. Participants direct the investment of contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified plans and certain IRAs. Contributions are subject to certain limitations.

Contributions (Continued)

The Employer may make a discretionary matching contribution each year to eligible participants. To be eligible to receive a matching contribution, participants (other than Rocket Ball Ltd. employees) must have completed one year of eligibility service with 1,000 hours and be employed on the last day of the Plan year, unless termination is due to death, disability, normal retirement (age 65), or early retirement (age 59½). For the year ended December 31, 2024, the Employer matching contribution for the employees of Rocket Ball Ltd. was equal to 50% of participant deferrals, limited to 6% of compensation with a dollar maximum of \$3,000. For Golden Nugget employees, the Employer matching contribution was equal to 15% of participant deferrals, limited to 5% of compensation for the year ended December 31, 2024. For Keens Steak LLC employees, the Employer matching contribution was equal to 100% of the first 3% of compensation an employee contributes to the Plan plus 50% of the next 2% of compensation an employee contributes to the Plan for the year ended December 31, 2024. For all other employers except Go Rio San Antonio, LLC, the Employer matching contribution was equal to 20% of participant deferrals, limited to 5% of compensation for the year ended December 31, 2024. For the year ended December 31, 2024, the Employer did not authorize an Employer Matching contribution for the employees of Go Rio San Antonio, LLC.

Participant Accounts

Each participant's account is credited with the participant's deferral contributions, the Employer's matching contribution, and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Income is allocated daily based on the shares in the participant's account. Participants direct the investment of contributions into the various investment options offered in the Plan.

Vesting

Participants are fully vested in their deferral contributions and actual earnings thereon. Vesting in the Employer portion of their accounts, plus actual earnings thereon, is based on years of credited service. Participants (other than Rocket Ball Ltd employees and Keens Steak LLC employees) vest at a rate of 20% per year, beginning with the second year of credited service. Participants are 100% vested after the completion of six years of credited service. Rocket Ball Ltd. employees are subject to a three-year graded vesting schedule, whereby they are fully vested upon completion of three years of credited service. Keens Steak LLC employees are immediately 100% fully vested in all employer contributions.

The Plan allows prior service credit for certain acquisitions as outlined in the Plan documents. Notwithstanding the above, a participant becomes 100% vested in their accounts upon attaining normal retirement age, death, or disability.

Payment of Benefits

Upon termination of service, death, disability, early retirement, or normal retirement, the participant may elect to receive the value of the vested interest in their account in the form of a lump sum distribution or installments. The Plan also allows for hardship distributions and in-service distributions upon attaining age 59½, subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the terminated participant's balance is between \$1,000 and \$7,000, the Plan administrator will authorize that the account balance be rolled into an IRA in the participant's name.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms are up to five years, except for loans to purchase a principal residence, for which loans may be repaid over a period of up to 10 years. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest is paid ratably through semi-monthly, bi-weekly, or weekly payroll deductions.

Forfeitures

Forfeited nonvested accounts may be first used to pay Plan expenses and then are used to reduce Employer contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$144,789 and \$78,953, respectively. Forfeitures of \$14,147 were used to reduce Employer contributions for the Plan year ended December 31, 2024. No forfeitures were used to pay Plan expenses for the year ended December 31, 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Estimates also affect the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Employee Benefit Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the trustee. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Employer, as provided by the Plan document. Expenses paid directly by the Employer are excluded from these financial statements. Fees related to the administration of benefit payments and participant loans are charged directly to the participant's account and are included in administrative expenses. The Plan utilizes an expense account to accumulate amounts used to fund administrative expenses. Investment advisory and recordkeeping fees are asset-based and are funded from this account and allocated to participant accounts. In addition, certain investment related expenses are included in net appreciation of fair value of investment presented in the accompanying statements of changes in net assets available for benefits.

Benefit Payments

Benefit payments are recorded when paid.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 30, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Empower Trust Company, LLC, the trustee, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds and money market mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer accounts.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) indicating that the pre-approved plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE 7 PLAN TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and collective trust funds managed by Empower Trust Company, LLC (Empower) and Prudential Bank & Trust, F.S.B. (Prudential). Empower and Prudential are the trustees as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions.

NOTE 9 NONEXEMPT TRANSACTION

During 2023 and 2024, the Employer failed to remit employee 401(k) deferral contributions for certain payroll periods within the timeframe prescribed by the Department of Labor. This is deemed a prohibited transaction in accordance with ERISA and the IRC. The Employer corrected the prohibited transaction for 2023 by depositing the 401(k) deferral contributions and lost earnings in 2024. The Employer intends to correct the prohibited transactions for 2024 by depositing the lost earnings in 2025.
