Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of Plan:

The following brief description of the Pension Savings Plan for Production Employees of Telescope Casual Furniture, Inc. (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan was established on April 1, 1996 by Telescope Casual Furniture, Inc. (the “Company”) as a defined contribution retirement plan covering production employees of the Company. The Plan allows employees to make pre-tax contributions subject to certain limitations, under Section 401(k) of the Internal Revenue Code. The Plan is subject to the provisions of ERISA.

The plan was amended and restated July 1, 2022, for the Cycle 3 Restatement and other legislative and regulatory changes.

Eligibility – Generally, production employees of the Company are eligible to participate in the Plan on the first day of the month following the completion of 3 consecutive months (probation period), and having attained the age of 18. Production employees are eligible for a non-elective profit sharing contribution after one year of service. Employees covered under another plan maintained by the employer, independent contractors, and non-resident aliens are excluded.

Contributions – Employees may contribute between 1% and 75% of their annual eligible compensation as defined by the Plan, subject to Internal Revenue Service limitations. Participants who are age 50 or older may elect to defer additional amounts called “catch up” contributions.

The Company, at its discretion, may also make a discretionary profit-sharing contribution based on eligible compensation as defined in the Plan document. Such contributions are allocated to the account balances of eligible employees in the same proportion that each participant’s eligible compensation bears to the total eligible compensation of all participants. In order to share in the profit sharing contribution, participants must be employed on the last day of the Plan year. During 2024 and 2023, the Company did not make any discretionary contributions.

Automatic Enrollment – Upon hire, employees are given a salary deferral agreement to elect to make elective deferrals into the Plan or to decline enrollment. If the agreement is not received once the employee becomes eligible to participate, the employee will have 3% automatically withheld and contributed into a default investment fund selected by the Company as a pre-tax contribution. A notice will be provided prior to the beginning of each plan year to allow participants to update their deferral information.

Participant Accounts – Accounts are participant directed. Account balances are tracked in units and the value is updated with the daily market price. As of any business day, accounts are charged or credited with earnings (dividends, capital gains, expenses, and market fluctuations) as well as account activity such as contributions, loans, distributions, and hardships.

(1) Description of Plan, continued:

Vesting – Participants are immediately vested in their voluntary contributions and earnings or losses thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 100% vested after three years of credited service, upon death, total and permanent disability or attaining age 55 while in service.

Withdrawal Privileges – Prior to termination, a participant may withdraw all or a portion of his pre-tax elective deferral account, excluding earnings on elective deferrals, in the event of undue financial hardship. The participant's request for a withdrawal shall include his statement and documentation proving that such a hardship exists and explain its nature. To qualify as a financial hardship withdrawal it must be determined that the withdrawal is to meet an immediate and financial need of the participant and the amount of the withdrawal is not reasonably available from other sources of the participant. Hardship withdrawals are limited to the following: financial needs arising on account of a college education, purchase of a principal residence, major medical expenses, prevention of eviction or foreclosure, burial or funeral expenses, and damage to a principal residence due to fire, storms or other casualty. The Plan Administrator has established uniform, nondiscriminatory guidelines to use in determining if such a condition of undue financial hardship exists. The Plan Administrator's determination shall be final. The participant has no legal or equitable right to such a withdrawal unless the immediate and financial need as defined has been demonstrated.

Withdrawal Provisions – The Plan provides for in-service distributions for participants that have attained normal retirement age. Such participants will be entitled to receive a distribution of all or a portion of their retirement account.

Payment of Benefits – Upon termination of service, disability, death or retirement, participants may elect to receive either a lump sum equal to the value of their accounts, a partial withdrawal, a life annuity or spousal survivorship annuity purchased from an insurance company.

Administrative Services – The Plan has entered into an agreement with Glens Falls National Bank and Trust Company, the Trustee, whereby all recordkeeping and investment functions are handled by the Trustee, including calculation of group and participant account balances, benefit payouts, and investment allocation of contributions. The administrative expenses paid from the assets of the Plan amounted to \$38,712 and \$14,993 in 2024 and 2023, respectively.

Forfeitures – Forfeitures of participants' non-vested account balances shall become available for payment of administrative expenses or used to fund employer contributions, including safe harbor contributions, QNECs, and QMACs.

(2) Summary of Significant Accounting Policies:

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with generally accepted accounting principles.

Use of Estimates – The preparation of the Plan's financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the date of the financial statements and the changes in net assets available for plan benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

(2) Summary of Significant Accounting Policies, continued:

Risks and Uncertainties – The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 - Fair Value Measurements below for discussion of fair value.

Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned. Security transactions are recorded on a trade-date basis. Gains or losses on sales of securities are based on average cost.

The Plan presents in the statements of changes in net assets available for plan benefits the net appreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Benefit Payment Recognition – Benefits are recorded when paid.

Date of Management Review – Subsequent events were evaluated through September 16, 2025, which is the date the financial statements were available to be issued.

(3) Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets;
- b. Quoted prices for identical or similar assets or liabilities in inactive markets;
- c. Inputs other than quoted prices that are observable for the asset or liability;
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

(3) Fair Value Measurements, continued:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(4) Information Certified by the Trustee:

At December 31, 2024 and 2023, the Plan's investments were held by the Trustee and monitored by the Plan's investment board. The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the Trustee as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

During 2024 and 2023, the Plan's investments (including investments bought, sold and held during the period) appreciated in value by \$202,906 and \$222,781, respectively.

(5) Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all amounts credited to the accounts of the participants shall vest and become non-forfeitable. The employer shall direct the Trustee to make or commence distribution to, or on behalf of, each participant the value of his or her account balance in the Plan.

(6) Tax Status:

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

(7) Related-Party and Party-In-Interest Transactions:

Plan investments are managed by Glens Falls National Bank and Trust Company, the Trustee of the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.
