Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of StrataTech Education Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 – PLAN DESCRIPTION

The following description of StrataTech Education Group 401(k) Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

General

The Plan is a defined contribution plan adopted by TWS Acquisition Corporation dba StrataTech Education Group (the Company) on July 1, 2010 and restated effective January 1, 2017. Substantially all employees of the Company and its subsidiaries who have completed at least 300 hours of service within the first six months of employment or completed one year of service are eligible to participate in the Plan. Employees may enter the Plan on the first day of the payroll period following the date on which the aforementioned requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan is administered by both the Company and Ascensus Trust Company (Ascensus). Among other duties, it is the responsibility of the administrators to interpret the Plan, decide on questions of eligibility, determine the amount and manner of benefit payments and maintain administrative records of the Plan. All Plan assets as of December 31, 2024 and for the period from November 14, 2024 through December 31, 2024 were held by Ascensus. All Plan assets as of December 31, 2023 and for the period from January 1, 2024 through November 13, 2024 were held by Newport Trust Company (Newport).

Trustee

The trustee of the Plan is Ascensus. The primary duties of the trustee is to authorize investments and monitor payment of contributions, loans and benefits as directed by the Plan administrators.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate at the time of borrowing, plus 2 percent. Principal and interest is paid ratably through bi-weekly or semi-monthly payroll deductions.

Contributions

Participants – The Plan permits each participant, at the participant’s option, to elect to contribute up to 100 percent of pretax compensation as a basic contribution to the Plan, not to exceed the Internal Revenue Service (IRS) limitations. For the year ended December 31, 2024, the maximum pretax salary deferral was limited to \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants are also permitted to make Roth contributions to the Plan, not to exceed the IRS limitations, and contribute amounts representing distributions from other qualified defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various separately managed accounts, mutual funds, exchange-traded funds and a common/collective trust as investment options for participants. Participants are fully-vested immediately in their contributions plus actual earnings thereon.

Employer – The Company provides safe harbor matching contributions equal to 100 percent of the participant’s annual contribution up to 3 percent of the participant’s base annual compensation contributed, and 50 percent on the next 2 percent of base annual compensation contributed. Company contributions vest in-full immediately. Total contributions for each participant are subject to certain IRS limitations.

Payment of Benefits

Participants may receive distributions from their accounts upon attainment of age 59½ (or age 55 and completion of 5 years of service), retirement as a result of disability, incurrence of a financial hardship (as defined), termination of their employment with the Company, death, or termination of the Plan. The participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested account balance, or installments over a period not to exceed the participant’s assumed life expectancy.

Forfeitures

Though Company contributions vest in-full immediately, forfeitures have historically arisen due to excess employer contributions. Amounts forfeited are used to fund future employer contributions or pay administrative expenses of the Plan. During the year ended December 31, 2024, \$12 in forfeitures were used to fund employer contributions. As of December 31, 2024 and 2023, the remaining forfeited amounts that could be used to fund employer contributions or pay future Plan administrative expenses were \$13 and \$45, respectively.

Plan Termination

Although the Company has not expressed any intent to discontinue the Plan, the Company may do so at any time subject to the provisions of ERISA. In the event of termination, participants would become fully vested in their employer contributions and assets of the Plan would be allocated to all participants and distributed in lump sum payments.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan does not have any fully-benefit responsive investments.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as determined by Ascensus. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Net change in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrators deem the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses

Plan investments are subject to certain investment fees based on a percentage of invested assets. Such fees are included within net change in fair value of the related investments on the accompanying statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participants' accounts and are included within administrative expenses on the accompanying statement of changes in net assets available for benefits. The majority of other administrative expenses related to the Plan are paid by the Company.

Use of Estimates

The preparation of financial statements requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

Plan management has evaluated subsequent events through the date of the auditors' report, September 29, 2025, which is the date the accompanying financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. That framework gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under the Financial Accounting Standards Board's *Accounting Standards Codification (ASC) 820*, are described as follows:

- a) Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- b) Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- c) Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value at December 31, 2024 and 2023. There were no changes in the methodologies used at December 31, 2024 and 2023:

Separately managed accounts: Valued at the daily unit value provided by the fund manager. The Plan's investment in these accounts is unitized at inception, and the unit values change based on the change in fair value of the underlying investments. These accounts primarily invest in mutual funds, exchange-traded funds, and fixed income securities, which are valued based on quoted prices.

Mutual funds and exchange-traded funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. Exchange-traded funds are listed on a national securities exchange for trading during the open hours of the exchange.

Common/collective trust: Valued at the net asset value (NAV) of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

NOTE 4 – TRUST CERTIFICATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, net change in fair value of investments, dividend income from investments and interest income from notes receivables from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus and Newport.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Participant loans are managed by Ascensus, and therefore, qualify as party-in-interest transactions.

During the year ended December 31, 2024, the Plan paid fees of \$16,476 to Newport for investment advisory and recordkeeping services which have been included within as administrative expenses on the accompanying statement of changes in net assets available for benefits.

NOTE 6 – TAX STATUS

The IRS has determined and informed the Company by a letter dated March 31, 2014, that the Plan has been designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been restated since receiving the advisory letter, the Plan administrators believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Participant and employer contributions are included within receivables on the accompanying statements of net assets available for benefits. These amounts are excluded from the Plan's Form 5500 for the years ended December 31, 2024 and 2023, which have been prepared on the cash basis of accounting.
