Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Brown Strauss, Inc. 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Modified Cash Basis Financial Statements

December 31, 2024 and 2023

Note 1 - Plan Description

The following description of Brown Strauss, Inc. 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on July 1, 1985 and subsequently restated. The Plan is available to employees of Blue Tee Corp.; Brown Strauss, Inc.; and Black Diamond Pipe and Tube, Inc. (effective November 1, 2023) (collectively, the "Company") who have completed one year of continuous service, with at least 1,000 service hours during their first 12 months of service or in any later plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The retirement committee controls and manages the operation and administration of the Plan. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) serves as custodian, manages plan assets, and maintains the Plan's records. Principal offers plan participants a variety of investment options.

Contributions

Contributions to the Plan include (i) salary reduction contributions authorized by participants; (ii) safe harbor matching contributions made by the Company, as defined in the plan document; and (iii) participant rollovers from other plans. Participants aged 50 and above may contribute additional amounts representing catch-up contributions allowed by the Internal Revenue Service (IRS). Employee contributions to the Plan are made through regular payroll deductions. Employees are eligible to contribute, on either a pretax or an after-tax basis through payroll deductions, a percentage subject to an annual limit of the lesser of 100 percent of eligible compensation or the annual IRS limitations in a calendar year.

The Plan includes an auto-enrollment feature that allows for employees who have met eligibility requirements to be automatically enrolled at a 7 percent deferral rate unless designating another deferral rate, including 0 percent. Auto-enrolled participant contributions are invested in the applicable T. Rowe Price Retirement Fund, as determined by the participant's age, which has been designated as the qualified default investment alternative by the Plan. The Plan includes an auto-enrollment deferral increase of 1 percent each year thereafter until a deferral rate of 10 percent is met for participants who are auto-enrolled or until the participant selects another deferral rate.

The Company matches 100 percent of each participant's deferral amount to the Plan, up to a maximum of 6 percent of such participant's eligible compensation. Participants may choose to have their contributions and the Company's matching contributions invested entirely or in increments of 1 percent in the guaranteed investment account or any of the mutual funds or pooled separate accounts offered by the Plan. Participants may elect to change their investment elections and to reallocate their account equity among the funds at any time. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain IRS limitations.

ESOP Distribution Rollovers

The Plan permits participants of the Brown Strauss, Inc. Employee Stock Ownership Plan (the "ESOP") to roll over distribution payments into the Plan. During 2024, the Plan received rollovers from the ESOP totaling \$2,986,453, which are included in rollover contributions on the statement of changes in net assets available for benefits - modified cash basis.

Note 1 - Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses and plan losses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants' contributions, employer contributions, and the related earnings are fully vested at all times and are not subject to forfeiture for any reason.

Benefit Payments

On termination of service due to termination, death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the Company. Furthermore, the Plan allows for terminated participant vested account balances of \$1,000 or less to be automatically distributed and balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan into an individual retirement plan.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Participants may have a maximum of two loans outstanding at any given time. The loans are collateralized by the participant's account balance; bear interest at rates that range from 5.25 to 10.50 percent, which are commensurate with local prevailing rates determined quarterly by the plan administrator at loan origination; and mature at various dates through 2049. Loans have a maximum term of 5 years, unless such loan is for the purchase of the participant's primary residence, in which case the repayment period may not exceed 25 years from the date of loan origination. Principal and interest are paid ratably through payroll deductions. Upon termination of a participant from employment, the participant's loan shall continue to be payable in accordance with the provisions of the participant's loan or be due in full. If a participant ceases to make note repayments and the plan administrator deems the participant note to be a distribution, the participant note balance is reduced and the deemed distribution recorded. Loans in the amount of \$216,832 were deemed a distribution in the current year and were recorded in benefits paid to participants in the statement of changes in net assets available for benefits - modified cash basis.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Principal or its affiliates. Principal is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The Plan prepares its financial statements on the modified cash basis of accounting. Revenue is recorded when received rather than when earned, expenses are recorded when paid rather than when the obligation is incurred, and investments are recognized at fair value or contract value. Accordingly, the financial statements are not intended to be in conformity with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Excess Contributions Payable

The Plan is required to return excess contributions received during the plan year in excess of the Internal Revenue Code limits. Such amounts required to be returned, but not returned as of year end, are accounted for as excess contributions payable on the statement of net assets available for benefits - modified cash basis. Amounts payable are netted against participant contributions on the statement of changes in net assets available for benefits - modified cash basis.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 2 - Summary of Significant Accounting Policies (Continued)

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 22, 2025, which is the date the financial statements were available to be issued.

Effective February 1, 2025, the Plan was amended to allow participants to become eligible after one year of service regardless of hours of service completed. In addition, the guaranteed minimum interest rate on the benefit-responsive investment contract changed to 2.80 percent effective June 1, 2025.

Note 3 - Certified Information

Principal (the "Custodian") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying modified cash basis financial statements and supplemental schedule of assets held at end of year - modified cash basis are based solely on information certified by the Custodian.

Note 4 - Investment Contracts

The Plan has a benefit-responsive investment contract with Principal Life Insurance Company (Principal Life). Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 2 percent. When establishing interest crediting rates for this product, Principal Life considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle in an amount different than contract value. An employer-level liquidation or employer-initiated transfer of the Plan's interest in the contract will be subject to a 12-month advance notice or a 5 percent surrender charge.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
