Opinion

Notes to Financial Statements December 31, 2024

Note 1 - Description of Plan

The following brief description of The Okonite Company, Inc. (the "Company") Employees' Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

In 1976, the Company adopted the Plan and related Employees' Stock Ownership Trust (the "ESOT"). During that year, the ESOT purchased 100% of the outstanding stock of the Company.

The Plan is a defined contribution plan which is noncontributory on the part of the participants. All employees of the Company become eligible to participate in the Plan on the first date of employment or January 1, 1976, whichever is later. Contributions are paid to the ESOT, which was established as part of the Plan. The Plan's trustee, PNC Bank (the "Trustee"), is responsible for the payment of the ESOT's debts and holds and invests excess contributions and income, if any, for the benefit of the participants.

Overall responsibility for administering the Plan (recordkeeping, reporting and disclosure, interpretation of provisions and benefit distributions) rests with an administrative committee appointed by the Board of Directors of the Company.

An investment committee, which is also selected by the Board of Directors of the Company, has exclusive responsibility and authority for the ESOT's investment in stock of the Company and makes all decisions which in any way involve the stock of the Company held by the ESOT.

The Trustee has discretionary investment authority and responsibility for all other assets.

Eligibility

Employees of the Company are generally eligible to participate in the Plan providing they are employed on the last day of the Plan year and have worked 1,000 hours during six months of service. A full-time employee is credited with 190 hours per month worked. Participants who do not have at least 1,000 hours of service during such Plan year are generally not eligible for an allocation of Company contributions for such year. Any person performing services for the Company, classified as an independent contractor or consultant, shall not be eligible to participate in the Plan.

Contributions

Annually, the ESOT allocates shares of its common stock to employees based on a specified formula. At December 31, 2024, there were 5,000,000 shares allocated to employees. When an employee retires, dies, or becomes disabled, the ESOT is obligated to purchase the individual's cumulative allocated shares at a share price determined by an independent appraisal. The Company makes annual contributions to the ESOT in amounts sufficient for the ESOT to repurchase shares from such employees.

Payments of benefits

Benefits are distributed in a single lump-sum payment of cash only upon retirement and attaining the age of 60, or immediately for death and disability, regardless of age.

The ESOT distributed to participants 444,377 shares in 2024 with a fair value of \$37,021,066 of which includes \$4,354,787 for distributions in 2023 but not paid until 2024. Fair value was determined based upon the value of a stock unit on December 31 of the year prior to the distribution. Contributions received in 2024 amounted to \$32,666,279.

Participant accounts

A Company stock account is maintained for each participant, which is credited or debited with beneficial ownership of shares of the Company stock allocable to the participant. An investment account is maintained for each participant, which is credited with amounts, other than the beneficial ownership of shares of the Company stock, allocable to the participant. Each participant's account is credited as of the last day of each Plan year with the net change in the number of shares of Company stock and net change in the fair value of other assets in the Plan. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Vesting

An employee is 100% vested after three years of service. However, an employee may also become fully vested upon the termination or the partial termination of the Plan.

Forfeitures

If an employee is not vested at the time of termination of employment, the employee's account balance will be forfeited. Forfeitures of nonvested benefits are redistributed to participants or used for other purposes in accordance with the trust agreement.

Plan termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Internal Revenue Code (the "Code"). Upon termination of the Plan, the Administrative Committee shall direct the Trustee to pay all liabilities and expenses of the trust fund and to sell shares of financed stock, if any.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Risks and uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Investment valuation and income recognition

The shares of Company common stock are valued at estimated fair value. See Note 3 for discussion of fair value measurement.

The investment in the Company represents ownership of 100% of the 5,000,000 outstanding shares of common stock of the Company. The stock is valued at December 31, 2024 and 2023 at the fair value of \$89.25 and \$83.31 per share, respectively, as determined by an independent appraisal.

The fair value of the investment in the Company at December 31, 2024 and 2023 amounted to \$446,250,000 and \$416,550,000, respectively, which has been established by the investment committee of the Plan as determined by an independent appraisal in the absence of readily ascertainable market values. Due to the uncertainties inherent in the valuation process, it is at least reasonably possible that the established value may differ significantly from the value that would be used had a ready market for the securities existed, which could be material to the Plan's financial statements.

Payment of benefits

Benefits are recorded when paid.

Operating expenses

All expenses of maintaining the Plan are paid by the Company.

Subsequent events

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in common stock of The Okonite Company, Inc.

Investments in common stock of The Okonite Company, Inc. are valued using the financial models usually referred to as analyses based on market approach and income approach. The market approach is predicated on the theory that the fair value of a closely held company can be estimated based on the prices investors are paying for the stocks of similar, publicly traded companies. By comparing the financial performance of comparable, publicly traded companies with that of the subject company, the appraiser can determine the appropriate multiples to use in estimating the fair market value of the subject company. The income approach is based on a discounted cash flow analysis. A pro forma analysis of the Company is developed in order to estimate projected earnings and cash flow. Fair value is estimated as the sum of the net present value of the earnings, plus a residual value reflecting the present value of future net cash flows subsequent to the forecast period.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of the Company could result in a different fair value measurement at the reporting date. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Note 4 - Tax status

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated May 12, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Code. The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Related party transactions and party-in-interest transactions

Investments in the Plan consist of common stock in the Company; therefore, these transactions qualify as exempt party-in-interest transactions. The Plan additionally has a number of service providers. Such parties are parties-in-interest under the Employee Retirement Income Security Act of 1974.

Note 6 - Administration of plan assets

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses are paid directly by the Company.
