To the Plan Administrator and Participants of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Hammer Packaging Corporation Retirement Savings Plan for Union Employees (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements (Plan's Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023**

---

**1. DESCRIPTION OF PLAN**

The following description of the Hammer Packaging Corporation Retirement Savings Plan for Union Employees (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General -

The Plan is a defined contribution plan covering the union employees of Hammer Packaging Corporation (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration -

The Company is the Plan sponsor and is responsible for general administration of the Plan. Voya Retirement Insurance and Annuity Company, Inc. is the custodian of the Plan's assets and Rimkus, Marciano & Associates, Inc. is the third-party administrator.

Eligibility -

Union employees, excluding non-resident aliens, leased employees and residents of Puerto Rico, of the Company are eligible to participate in the Plan after completion of three months of service. There is no minimum age requirement to participate in the Plan.

Investment Options -

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the investment options as indicated by the Plan sponsor, which provide diversified investment allocations. Participants may change their investment allocations at any time during the year.

Contributions -

Participants may make tax-deferred contributions of up to 75% of their compensation to the Plan, subject to the limits set forth in the Internal Revenue Code.

The Company makes discretionary non-elective contributions on behalf of Participants based upon an allocation formula established by the Company based on the age of the participant. Participants direct the investment of their contributions and Company non-elective contributions into various investment options offered by the Plan.

Participant Accounts -

Each participant's account is credited with participant contributions, Company non-elective contributions and actual earnings (losses) thereon. Participant accounts are also charged with an allocation of administrative expenses. Allocations are based on participant wages or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. DESCRIPTION OF PLAN (Continued)

### Vesting -

Participants are immediately vested in their 401(k) contributions, plus actual earnings (losses) thereon. Employer non-elective contributions vest 20% per year beginning upon completion of two years of service and are fully vested after six years of credited service.

### Forfeitures -

Forfeitures of non-vested account balances are allocated to the remaining participants in the Plan. Forfeitures totaled \$6,398 and \$24,043 during the years ended December 31, 2024 and 2023, respectively.

### Notes Receivable from Participants -

Participants may borrow up to the lesser of 50% of their vested account balances or \$50,000. Participants may choose an amortization schedule of up to five years, unless the note is used for a primary residence, in which case the amortization schedule may be up to 25 years. Principal and interest are paid through payroll deductions. Interest on notes receivable from participants is charged at the prime rate at the time of loan origination plus 2% (9.50% and 10.50% at December 31, 2024 and 2023, respectively).

### Benefit Payments -

The Plan provides for benefit payments upon either the termination of employment or the attainment of age 65. Benefit payments are made in the form of a partial payment, lump-sum distribution, or a rollover to another qualified investment. Additionally, the Plan provides for in-service withdrawals once a participant reaches age 70 ½, even if still employed.

### Hardship Withdrawals -

Hardship withdrawals can only be made if there is an immediate and heavy financial need, as defined in the plan document. Hardship withdrawals from the Plan are permitted from fully vested accounts.

### Plan Termination -

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant's account will become fully vested.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting -

The Plan's financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP).

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Investments -

The Plan's investments are reported at fair value as reported by the custodian and/or the investment managers. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments sold, as well as held, during the year. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### Fair Value Measurement -

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). There were no changes in valuation techniques in 2023 or 2024. The three levels of the fair value hierarchy under GAAP are described below:

- Level 1 - Valuations based on quoted market prices in active markets for identical assets or liabilities that the Plan has the ability to access. The Plan's mutual funds are valued utilizing level 1 inputs.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly. The Plan did not have any financial assets or liabilities measured at fair value utilizing Level 2 inputs.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement. The Plan did not have any financial assets or liabilities measured at fair value utilizing Level 3 inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Notes Receivable from Participants -

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Principal and interest are paid through payroll deductions. Delinquent notes are reclassified as distributions based on the terms of the Plan document.

### Benefit Payments -

Benefit payments are recorded when paid.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Estimates -

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. Significant estimates included in these financial statements include investment valuations, as described above.

### Risks and Uncertainties -

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the near term could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

### Income Taxes -

The Plan sponsor is required to determine whether a tax position of the Plan is more likely than not to be sustained upon examination by the applicable taxing authority, based on the technical merits of the position. As of December 31, 2024, the Plan has not recorded any provisions for accrued interest and penalties related to uncertain tax positions. By statute, tax years 2021 through 2024 remain open to examination by the major taxing jurisdictions to which the Plan is subject.

### Events Occurring after Reporting Date -

The Plan has evaluated events and transactions that occurred between December 31, 2024 and September 30, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

#### **4. SUMMARY OF INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The Plan administrator has elected the method of annual reporting permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian, Ascensus Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and at contract value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, including net appreciation in fair value of investments and interest and dividends, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets held for at end of year as of December 31, 2024 as shown on Schedule I, excluding notes receivable from participants.

#### **5. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan participates in a guaranteed investment contract option with Voya. The account is credited with earnings on the underlying investments and charged for the Plan withdrawals and administrative expenses charged by Voya. The contract is considered to be fully benefit responsive. As such, the contract is included in the financial statements at contract value. The contract value of the investment contract was \$146,736 and \$128,468 at December 31, 2024 and 2023, respectively. The crediting interest rate to participants for the contract as of both December 31, 2024 and 2023 was 3.00%. The guaranteed minimum crediting interest rate for the contract for both the years ending December 31, 2024 and 2023 was 3.00%.

Voya's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code 66
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's operations.

## **5. INVESTMENT CONTRACT WITH INSURANCE COMPANY (Continued)**

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

## **6. TAX STATUS**

The Plan has obtained an opinion letter for the prototype of the Plan, dated March 31, 2014, in which the Internal Revenue Service stated that the form of the Plan was in compliance with the applicable provisions of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

## **7. PARTY-IN-INTEREST TRANSACTIONS**

Voya Retirement Insurance and Annuity Company, Inc. is custodian of the Plan's assets. As such, transactions between Voya Retirement Insurance and Annuity Company, Inc. and the Plan qualify as party-in-interest transactions. Additionally, transactions involving notes receivable from participants qualify as party-in-interest transactions.
