**Note 1 - Description of plan**

The following description of the WisdomTree, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all full-time employees of WisdomTree, Inc. (the "Company" or "Plan Sponsor"), who have two months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Sponsor is responsible for oversight of the Plan. It has delegated to third parties certain functions. Ascensus Trust Company serves as the trustee of the Plan; Ascensus, Inc. serves as record keeper; and 3D Asset Management, Inc. ("3D"), a Securities and Exchange Commission ("SEC") registered investment advisor, serves as investment advisor to the Plan. 3D selects the investment offerings in the Plan, monitors investment performance and reports to the Plan Sponsor.

**Contributions**

Each year, participants may contribute up to the lesser of 100% of pre-tax annual compensation, as defined in the Plan, or the maximum amount permitted (\$23,000 for 2024) under the Internal Revenue Code (the "Code"). Participants may also contribute Roth deferrals to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company will make matching contributions in an amount to be determined each year. For the year ended December 31, 2024, the Company's matching contribution amounted to 50% of the amount contributed by a participant during the Plan year. In addition, the Company may make profit sharing contributions each year. To be qualified to receive a profit sharing contribution for a Plan year, an employee must be credited with 1,000 hours of services in the Plan year and be an employee on the last day of the Plan year. There were no profit sharing contributions made to the Plan for the year ended December 31, 2024. Participants also direct the investment of Company contributions in the same manner as they direct their own contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

**Participant accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after four years of credited service and the four-year grade vesting schedule is as follows:

**Notes receivable from participants**

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loan repayment period is generally up to five years from the date of the loan, unless it is used to acquire the principal residence of the participant which is then determined at the time of the loan. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. The interest rates for outstanding loans, as of December 31, 2024 ranged from 4.25% to 9.50% with maturity dates from 2025 to 2035. Principal and interest is paid ratably through monthly payroll deductions. Upon a participant's separation from service the loan will be a deemed distribution.

**Payment of benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Withdrawals from the salary deferral contribution, matching contribution and profit sharing contribution portion of a participant's account may be made in the event of a financial hardship in accordance with the provisions specified by the Plan. Participants who have attained age 59 1/2 are eligible to make in-service withdrawals from the vested portion of their account balance, in accordance with the provisions specified by the Plan.

**Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$26,596 and \$10,242 respectively. Forfeitures will be used to pay the Plan's administrative expenses or to reduce future employer contributions to the Plan. For the year ended December 31, 2024, employer contributions were reduced by \$18,406 from forfeited nonvested accounts.

**Note 2 - Summary of accounting policies**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

**Use of estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance companies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of

investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. "Fund specific" expenses are included in the net asset value of the underlying funds.

**Note 3 - Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 *Fair Value Measurement*, are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Exchange traded funds ("ETF") and unit investment trusts ("UIT"):* Valued at the closing price reported on the active market on which the individual securities are traded.

*Self-directed brokerage accounts:* Interest bearing cash is valued using the carrying amount as it considered to be a reasonable approximation of fair value. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded. American depository receipts are valued based on unadjusted, quoted market prices for identical assets in active markets.

*Common collective trust fund:* Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. For the years ended December 31, 2024 and 2023, there were no adjustments made to the reported NAV. Participant transactions (purchases and sales) may occur daily.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

**Note 4 - Related party transactions and party-in-interest transactions**

Certain Plan assets are invested in funds managed by WisdomTree Asset Management, Inc. (“WTAM”), a wholly-owned subsidiary of the Plan Sponsor and, therefore, these investments are considered party-in-interest transactions. Fees charged by WTAM for management of these investments are included in the net appreciation in fair value of these investments, and are not direct payments by the Plan. As described in Note 1, the Plan Sponsor has retained 3D, as an investment advisor for the Plan. Fees paid to 3D are paid directly by the Plan Sponsor, and are not charged to the Plan. As described in Note 2, the Plan made a direct payment to the third party record keeper of \$690. The Plan Sponsor pays directly any other fees related to the Plan’s operations.

**Note 5 - Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 6 - Tax status**

The underlying pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan

is required to operate in conformity with the Code to maintain its qualification status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8 - Certified investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee of the Plan as of December 31, 2024 and Ascensus, LLC as an authorized representative of the trustee as of December 31, 2024 and for the year then ended.
