Independent Auditor's Report

To the Trustees

Opinion

We have audited the financial statements of Brown Strauss, Inc. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023 and the changes in net assets available for benefits for the year ended December 31, 2024 in accordance with accounting principles generally accepted in the United States of America.

Management's estimates are based on information provided by Stout Risius Ross, LLC. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

Note 1 - Plan Description

Blue Tee Corp. established the Blue Tee Corp. Employee Stock Ownership Plan (the "Plan") effective January 1, 1996. In 2015, the Plan restructured and transferred Blue Tee Corp. into a newly formed holding corporation, BSI Holdings, Inc. (the "Company" or the "Plan Sponsor"). Brown Strauss, Inc. was created as a subsidiary of BSI Holdings, Inc., and BSI Holdings, Inc. owns both Blue Tee Corp. (formally dissolved in November 2023) and Brown Strauss, Inc. (collectively, the "Subsidiaries"). Additionally, in 2015, the Plan was renamed as the Brown Strauss, Inc. Employee Stock Ownership Plan. During 2023, Black Diamond Pipe & Tube, Inc. was acquired by Brown Strauss, Inc. and became a participating employer in the Plan effective November 1, 2023.

The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is available to all employees of the Subsidiaries, and their subsidiaries, if any, upon satisfying certain requirements, including the completion of one year of continuous service. The Plan is an employee stock ownership plan (ESOP) and is designed to comply with Section 4957(e)(7) of the Internal Revenue Code of 1986 (the "Code"), as amended, and is subject to the applicable provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Company, which has established the retirement committee (the "Committee") to control and manage the operation and administration of the Plan. GreatBanc Trust Company, an independent third party, has been appointed as trustee (the "Trustee"). All common stock held by the Plan is held in a trust established under the Plan. Principal Financial Group maintains the Plan's records as a third-party administrator.

Contributions

The Company's discretionary contributions are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the plan year. Amounts may be contributed at the discretion of the Company's board of directors. A participant who dies, retires (on or after the date on which the participant attains age 65), or becomes disabled during a plan year is still entitled to the contribution for the current plan year. The Company approved a contribution of 305.8434 shares with a value of \$4,420,966 to the Plan for 2024, which were contributed to the Plan subsequent to year end.

Vesting

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (the age of 65 or, if later, after five years of service), retirement due to disability, or if the Plan is terminated.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of the Company's contribution and forfeitures of terminated participants' nonvested accounts. Generally, only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation relative to total eligible compensation. Plan earnings and losses are allocated to each participant's account based on the ratio of the participant's account balance.

A participant's account may be converted to other investments at the end of the plan year in which a participant separates from service and will be allocated investment gains and losses according to pro rata gains and losses attributable to other investment assets of the Plan. The Committee may direct the Trustee with respect to such other investments, or the Committee may direct that such participant accounts be transferred to the Brown Strauss, Inc. 401(k) Savings Plan to be held in an account in the name of the participant.

Benefits Payments - Distributions

Upon termination of service, death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account; roll over to the Brown Strauss, Inc. 401(k) Savings Plan; roll over to another qualified plan at an outside financial institution; or receive installment annuities over no more than five years.

Benefit Payments - Diversification

Participants who have attained the age of 55 and have completed at least 10 years of participation in the Plan are eligible to diversify up to a cumulative 25 percent of the number of shares held in his or her ESOP account, less any shares previously diversified. After the sixth year, the cumulative percentage increases to 50 percent. Diversifications are accomplished in the same manner as distribution payments, with the participant having the same payment options. The Plan offers a supplemental diversification to participants attaining age 45 and having 10 years of plan participation, whereby the participant is eligible for diversification of up to a cumulative 25 percent of the number of shares held in his or her ESOP account, less any shares previously diversified.

Forfeitures
