## Independent Auditor's Report

To the Plan Administrator

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Kemp Quarries Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit.) The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kemp Quarries Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **A. DESCRIPTION OF THE PLAN**

The following description of Kemp Quarries Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan sponsored by Kemp Quarries (the Company) for the benefit of its employees. The Plan includes other adopting employers who are members of the same controlled group. Other adopting employers include Benton County Stone Company, Inc., Kemp Stone, Inc., Muskogee Sand Company, Inc., and River Valley Quarries LLC. The Plan was originally adopted January 1, 1999. Effective October 1, 2018, the Plan changed its name from Kemp Companies 401(k) Retirement Plan to Kemp Quarries Retirement Plan. Employees are eligible to participate in salary deferral contributions and receive employer matching contributions on the first day of the quarter after obtaining one year of service. The employer may make additional discretionary contributions as described further below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Principal Trust Company is the Plan's custodian (the Custodian).

*Contributions*

Each year, participants may contribute up to 100 percent of pre-tax annual compensation, as defined in the Plan, up to IRS maximum limits. Salary deferral contributions can be made on a pre-tax basis or directed towards a Roth (after-tax) account. Participants who are projected to be age 50 or older by the end of a calendar year may also make catch-up contributions. Employee rollover contributions are also permitted. The Company may also elect to make matching contributions. For eligible employees for the year ended December 31, 2024, the Company matched 50% of an employee's salary deferral up to 3% of the employee's compensation. The Company may also make an annual discretionary contribution, to be allocated to those employees who, in general, were active participants at any time during the calendar year and had more than 500 hours of service in the calendar year. The annual discretionary contribution is allocated to eligible employees based on compensation. For the year ended December 31, 2024, the Company made a discretionary contribution of \$175,000. Contributions are subject to certain limitations.

*Participant Accounts*

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the funds offered by the Plan and may change the allocation daily. Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting and Forfeitures*

Participants are vested immediately in their contributions plus actual earnings thereon. Participants become fully vested in Company contributions based on the schedule below or upon reaching normal retirement age as defined in the Plan document:

Six or more years	100%

Forfeited accounts from non-vested account balances are allocated to employees, who, in general, were active participants at any time during the calendar year and had more than 500 hours of service in the calendar year. Forfeited account balances available for allocation to eligible employees totaled approximately \$27,000 and \$26,000 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, approximately \$25,000 was allocated to eligible employees and approximately \$26,000 was forfeited from the non-vested portion of benefits paid to participants.

*Payment of Benefits*

If the vested portion of a participant's account does not exceed \$5,000, the participant's entire vested account shall be distributed as of the earliest of his retirement date, date of death, or date of termination. Accounts greater than \$1,000 but less than \$5,000 in value, unless elected differently by the participant or his beneficiaries, will be directly rolled over to an individual retirement account with an affiliate of the custodian. Accounts less than \$1,000 in value will be paid out fully to the participant or his beneficiaries. If the account balance is greater than \$5,000, a participant can also choose to receive installment payments, request a partial withdrawal, or defer receiving payments until age 70 ½.

**B. SUMMARY OF ACCOUNTING POLICIES**

*Basis of Accounting*

The financial statements of the Plan are prepared under the accrual basis of accounting.

*Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**B. SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

*Investment Valuation*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes D and E for discussion of investment valuation.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits*

Benefits are recorded when paid.

*Administrative Expenses*

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Investment-related expenses are included in net appreciation in fair value of investments.

**C. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**D. INVESTMENTS MEASURED USING THE NET ASSET VALUE PER SHARE PRACTICAL EXPEDIENT**

Investments held by the Plan include collective investment trust funds. There have been no changes in the methodologies used to value collective investment trust funds at December 31, 2024.

Collective investment trust funds are stated at fair value as determined by the issuer of the collective investment trust funds on the fair market value of the underlying investments, which is valued at net asset value (NAV) as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Accounting Standards Codification Topic 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs have the highest priority, and Level 3 inputs have the lowest priority. *Level 1 Fair Value Measurements*

Fair values are based on quoted market prices in active markets for identical issues that the Plan has the ability to access at the measurement date. The Plan's Level 1 investments include mutual funds based on quoted prices for identical assets on the measurement date.

*Level 2 Fair Value Measurements*

Fair values are based on inputs other than quoted market prices included within Level 1 that are observable for valuing the asset, either directly or indirectly. Observable inputs include quoted prices for similar assets in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs. The Plan does not hold any level two investments.

*Level 3 Fair Value Measurements*

Fair values are based on unobservable inputs used for valuing the asset. Unobservable inputs are those that reflect the plan's own assumptions about assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances. The Plan does not hold any Level 3 investments.

### **G. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

### **H. TAX STATUS**

The Plan operates under a non-standardized adoption agreement in connection with a prototype basic savings plan sponsored by the Custodian. The Internal Revenue Service advised on March 31, 2014, that the prototype plan constitutes a qualified plan under section 401 of the Internal Revenue Code and that the related trust was tax exempt as of the financial statement date. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Generally accepted accounting principles requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income examination for years prior to 2021.

### **I. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **J. PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$2,788 of administrative fees to the Custodian in 2024. The Plan incurs additional expenses related to general administration, record keeping and trust administration. These expenses and certain accounting and auditing fees related to the Plan are paid by the Company. The Company does not expect reimbursement from the Plan for these services. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

Certain plan investments are shares of mutual funds managed the Custodian. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

**K. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through the date of the independent auditor's report, which is the date the financial statements were available to be issued. No subsequent events were noted.
