## INDEPENDENT AUDITORS' REPORT

To the Participants and Administrator of the  
Hamilton-Madison House, Inc. 403(b) Thrift Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Hamilton-Madison House, Inc. Employee Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hamilton-Madison House, Inc. ### **Opinion**

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



- the information in the financial statements referred to above related to assets held by and certified to Mutual of America Life Insurance Company by a agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirement of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

**1. DESCRIPTION OF THE PLAN**

The following description of the Hamilton-Madison House, Inc. 403(b) Thrift Plan (the “Plan”) provides general information of the Plan. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

The Plan is a contributory defined contribution plan covering all employees of Hamilton-Madison House, Inc. (the “Sponsor”) except for employees who are covered under a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Sponsor amended the Plan effective on January 1, 2009, to comply with ERISA.

**Contributions**

All employees of Hamilton-Madison House, Inc. are eligible to make salary reductions. There is no minimum age requirement and no minimum service requirement for salary reductions. Participants may elect to make deferral contributions up to 100% of annual compensation, subject to certain limitations imposed by the Internal Revenue Code (“IRC”). IRC limitations for pre-tax and Roth contributions were \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make an additional \$7,500 catch-up contribution to the Plan for 2024.

The Sponsor has the discretion to contribute to the Plan; however, they will not match the employee’s contribution. Employees become eligible to receive Sponsor matching after completing one year of service and reaching age 21. A year of service, for eligibility purposes, is defined as follows:

**Contributions (continued)**

- A participant will have completed a year of service if, at the end of his or her first twelve consecutive months of employment with the Sponsor, a participant has been credited with 1,000 hours of service.
- If a participant has not been credited with 1,000 hours of service by the end of his or her first twelve consecutive months of employment, the participant will have completed a year of service at the end of the following plan year during which a participant was credited with 1,000 hours of service.

The Plan does accept rollovers and transfers from other qualified plans, but only for those employees eligible to participate in the Plan. Contributions to the Plan on behalf of a participant are invested at the direction of the participant in selections of mutual funds and an insurance company general account.

For the purpose of the Plan, compensation has a special meaning. Compensation is generally defined as total compensation that is subject to income tax and paid by the Sponsor during the Plan year. Compensation excludes reimbursement or other expense allowances, fringe benefits, moving expenses, certain deferred compensation, and welfare benefits.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and investment earnings. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Participants' Investment Options**

Participants must direct their salary deferral contributions to selected investments made available and determined by the Plan administrator. Participants may change their investment options at any time throughout the year via telephone or internet access to Mutual of America Life Insurance Company website.

**Vesting**

Participants are immediately vested in amounts attributable to their salary deferrals plus actual earnings thereon. The amount in a Participant's Employer Contribution Account shall be 100% vested upon the attainment of his or her Normal Retirement Age or if earlier, upon meeting the applicable vesting requirements below:

Years of Service	Vested Percentage
Less than 2	0%
2	20%
3	40%
4	60%
5	100%

The participants' accounts become 20% vested upon completing two years of credited service as defined and continue to vest at the rate of 20% for each successive year of service until 60% after four years of service and fully vested after five years of service.

**Notes Receivable from Participants**

Participants may borrow from their account up to a maximum equal to the lesser of: (a) \$50,000 reduced by the excess, if any, of their highest outstanding balance of notes payable to the Plan during the one year period ending on the day before the date of the new note over their current outstanding balance of notes as of the date of the new note; or (b) 50% of their vested interest in the Plan.

However, the participant may not request a note for less than \$1,000. Notes receivable must be repaid within five years unless the borrowing is for the purchase of a primary residence.

**Notes Receivable from Participants (continued)**

The outstanding notes receivable are included in the value of the Interest Accumulation Account of the General Account under the group annuity contract provided by Mutual of America Life Insurance Company. The funds used to provide plan loans to participants are attributable to the Plan's interest in the General Account of the group annuity contract funding the Plan.

**Forfeitures**

Forfeitures, if any, are used to reduce the future employer contributions under the Plan. At December 31, 2024, forfeited non-vested accounts totaled \$13,983. There was no amount allocated to participants as employer contributions.

**Payment of Benefits**

Participants may receive benefits upon death, disability, retirement, severance from employment, age 59 ½ withdrawals or reasons of proven financial hardship.

**Plan Termination or Plan Merger**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA.

In the event of any merger of the Plan with, or transfer of assets of the Plan to any other plan, each participant's account, immediately after such event, would equal the market value of the account prior to such event.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Although these estimates are based on management's knowledge of current events and actions it may undertake in the future, they may ultimately differ from actual results.

**Notes Receivable from Participants**

Participants may obtain a loan from the Plan secured by a portion of his or her accrued benefit invested in the Interest Accumulation Account of the General Account available under the group annuity contract provided by Mutual of America Life Insurance Company. Plan loans are collateralized by the participants' account balances at a rate of 20% in excess of the loan amount. Outstanding loan balances will be withdrawn from participants' accounts in an event of default and will be deemed as a distribution. As of December 31, 2023, no allowance for credit losses has been recorded. The participant notes receivable was \$20,453 as of December 31, 2024.

**Investment Valuation and Income Recognition**

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

**Investment Valuation and Income Recognition (continued)**

The Plan's investment in the Mutual of America Life Insurance Company's General Account is recorded at contract value, which deems to be fair value. This account is not benefit-responsive. Contract value represents contributions made under the contract, plus interest at a specified rate determined by Mutual of America Life Insurance Company, less withdrawals and transfers to other accounts. The unit value of the Plan's investments in the pooled separate accounts is determined based on the fair value of the underlying assets as determined by the fund manager.

Transaction gains and losses are determined on the first-in, first-out (FIFO) method and are reflected on a trade date basis. Interest, dividends and other income from investments are recorded on the accrual basis.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative expenses such as the trustee's custodial and administrative fees are paid by the Plan. Accounting and auditing fees are paid by the Sponsor. Administrative expenses for loans, distributions and withdrawals are paid by the participants.

**Risks and Uncertainties**

The Plan invests in mutual funds. Such investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with such investments and the level of uncertainty related to changes in the values of such investments, it is at least reasonably possible that changes in the values of the Plan's investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA as applicable to certain investments. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Mutual of America Life Insurance Company, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule.

Mutual of America Life Insurance Company certified the completeness and accuracy of total investments of \$8,793,437 and total participant notes receivable of \$20,453 at December 31, 2024, and total investment income of \$1,126,278 for the year ended December 31, 2024.

**4. INVESTMENTS**

**5. INCOME TAX STATUS**

The Plan, which received its latest determination letter on June 9, 2014, has been designed to qualify under Section 403(b) of the Internal Revenue Code (the "Code"). The terms of the Plan have been prepared to confirm with sample language provided by the Internal Revenue Service ("IRS") in Revenue Procedure 2007-71. The Plan has not filed for an individual determination letter. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

**5. INCOME TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan does not have any uncertain tax positions. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2018.

**6. FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, defines fair value as the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

FASB ASC 820 specifies a hierarchy of valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (observable inputs). In accordance with FASB ASC 820, the following summarizes the fair value hierarchy:

- Level 1 Inputs - Unadjusted quoted market prices for identical assets and liabilities in an active market that the Company has the ability to access.
- Level 2 Inputs - Inputs other than the quoted prices in level 1 that are observable either directly or indirectly.
- Level 3 Inputs - Inputs based on prices or valuation techniques that are both unobservable and significant to the overall fair value measurements.

FASB ASC 820 requires the use of observable market data, when available, in making fair value measurements. When inputs used to measure fair value fall within different levels of the hierarchy, the level within which the fair value measurement is categorized is based on the lowest level input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual Funds:* Valued at the net asset value (“NAV”) of shares held by the Plan at year end.

*General Account:* Valued at amortized cost, or contract value, which is deemed to be fair value for an insurance company general account.

The method described above may produce a fair value that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
