To the Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Electrico, Inc. 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the financial Statements section of our report. We are required to be independent of Electrico, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Electrico, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

A. Description of Plan

The following description of the Electrico, Inc. (Company or Plan Sponsor) 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

- 1. General.** The Plan is a defined contribution plan covering all employees of the Company, with the exception of leased employees and residents of Puerto Rico, who have completed two (2) months of service. Employees are eligible for salary deferrals beginning on the first day of the month coinciding with or following two (2) months of service. Employees are eligible to participate in the Plan for purposes of matching and profit sharing contributions upon attainment of age 18 and six (6) months of service. The entry date for matching and profit sharing contributions is the first day of the Plan year coinciding with or next following satisfaction of the eligibility requirements. Participants who perform services subject to the Service Contract Act, Davis-Bacon Act or similar Federal, State, or Municipal Prevailing Wage Statutes are eligible to receive profit sharing contributions as defined in the Plan Adoption Agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.
- 2. Contributions.** Each year, participants may contribute up to the maximum amount allowed by law or \$23,000 (in 2024; thereafter as adjusted by the U.S. Secretary of the Treasury) in a calendar year. Participants who have obtained age 50 before the end of the Plan year may be eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various collective trusts and one mutual fund as investment options for participants. The Company may make discretionary matching contributions equal to a uniform percentage of each participant's salary deferral. The matching percentage is limited to salary deferrals which do not exceed 5% of the employee's compensation. Additional profit sharing amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain Internal Revenue Service (IRS) limitations.
- 3. Participant Accounts.** Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of any employer discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- 4. Vesting.** Participants are immediately vested in their salary deferral and rollover contributions plus actual earnings thereon, and effective January 1, 2022, the Company's prevailing wage contributions. Vesting in the Company's regular wage matching and profit sharing contribution is based on years of service, as defined in the Plan. A participant is 100% vested in those portions of their accounts after five years of credited service and is determined as follows:

- 5. Payment of Benefits.** On termination of service due to death, disability or retirement, participants (or their designated beneficiaries) who have a balance greater than \$5,000 may elect to receive the total vested balance in a lump sum distribution or installments or may leave the balance in the Plan until a minimum distribution is required. A participant with a vested balance of less than \$5,000 will receive a mandatory lump sum distribution. A distribution of vested balances between \$1,000 to \$5,000 will be rolled over to an IRA unless the participant makes an affirmative election to either receive or roll over the distribution. Balances under \$1,000 will be paid as a lump sum distribution.

In-service distributions are allowed for participants upon attainment of age 59 ½.

Financial hardship withdrawals are permitted as set forth in the Plan to satisfy an immediate and heavy financial need. See also Note A.8 Plan Amendments below for certain legislative and regulatory changes related to hardship distributions and other Plan provisions.

- 6. Forfeited Accounts.** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,728 and \$9,314, respectively. These accounts may be used to pay the Plan’s ordinary and necessary administrative expenses and to reduce the Company’s contribution. For the year ended December 31, 2024, \$1,530 of Plan expenses were paid from forfeitures and \$5,882 of forfeitures were used to reduce employer contributions.
- 7. Investment Fund Fee Offset.** Under the Retirement Plan Administrative Services Agreement between Standard Retirement Services, Inc. (Standard) and the Company, Standard may receive compensation from the Plan’s investment funds. The compensation balances are reflected as an increase in the net asset value of Collective Trust Funds and used to offset ERISA-qualified administrative expenses of the Plan or may be allocated to participant accounts to offset participant expenses under the Plan. At December 31, 2024 and 2023, the Plan had a zero balance. For the year ended December 31, 2024, the Plan received no compensation, and no amounts were used to offset the Standard’s administrative fees. See also Note H Related Party Transactions and Party-In-Interest Transactions.

- 8. Plan Amendments.** Effective April 1, 2024, the Plan Adoption Agreement was amended and restated to include certain provisions for Plan Administration.

SECURE 2.0 Act of 2022: The Plan Sponsor has implemented operational updates to comply with applicable provisions of the SECURE 2.0 Act, including the increase in the required minimum distribution age, expanded eligibility for long-term part-time employees. The Plan does not currently permit Roth contributions. As a result, catch-up contributions for participants earning over \$145,000 will not be permitted beginning January 1, 2026. Although the Plan has not yet been formally amended, the amendment is expected to be executed by December 31, 2026, in accordance with IRS guidance.

B. Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts (FBRICs), which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable as an expense.

Contributions Receivable and Allowance for Expected Credit Losses: In June 2016, the FASB issued Accounting Standards Update (ASU) 2016-13, Financial Instruments – Credit Losses (ASC Topic 326) Measurement of Credit Losses on Financial Instruments. ASC Topic 326 significantly changed how entities measure credit losses for most financial assets and certain other instruments that are not measured at fair value through net income. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing an entity’s exposure to credit risk and the measurement of credit losses. Financial assets held by the Company that are subject to the guidance in ASC Topic 326 are contributions receivable. The Plan adopted the standard effective January 1, 2023. The impact of the adoption was not considered material to the Plan’s financial statements and primarily resulted in new and enhanced disclosures only. No allowance for current expected credit losses was considered necessary at December 31, 2024 and 2023.

Corrective Contributions: Corrective contributions include qualified nonelective contributions or other plan corrections and are generally recorded in the year of the event as ‘other employer contributions’ in the statement of changes in net assets available for benefits. Any associated receivable is presented as ‘other employer contribution receivable’ as of the Plan’s year-end.

Corrective Distributions: Corrective distributions include Plan corrections that are generally recorded in the Plan year deemed payable to participants. Corrective distributions may also be required in the event that employee contributions exceed contribution limitations of the Plan. These amounts are netted against contributions in the statement of changes in net assets available for benefits and the associated liability is presented as ‘excess contributions payable’ as of the Plan’s year-end.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Generally, the Plan’s administrative fees and expenses are paid by the Plan and allocated to participant accounts. The Plan’s individual account fees and expenses are charged directly to participant accounts. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Certain expenses of maintaining the Plan paid by the Company are excluded from these financial statements.

Subsequent Events: The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

C. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the custodian of the Plan).

D. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification Topic 820 (ASC Topic 820) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Mutual funds, which are actively traded, are valued at quoted market prices on nationally recognized securities exchanges and represent the net asset value (NAV) of shares held by the Plan at year-end and are classified as Level 1 within the valuation hierarchy.

Collective Trust Funds: The Plan's stable value investment option is Reliance Trust New York Life Anchor Series 1 (herein referred to as the Fund). The Fund is intended to provide a stable return on investment and protection of principal from changes in market interest rates. The Fund is a collective investment trust that invests in a group annuity contract (which has underlying investments in various guaranteed investment contracts, synthetic guaranteed investment contracts and securities) issued by the fund provider. The NAV per unit is calculated as of the close of trading on the NYSE (generally, 4:00 p.m. U.S. Eastern time). The NAV per unit is computed by dividing the total fair value of the assets of a Fund, less its liabilities, by the total number of units outstanding at the time of such computation.

Collective Trust Funds (continued)

The Fund includes FBRICs at contract value in determining the NAV. Participant withdrawals from the Fund are generally transacted at the fund's per-share NAV. Certain events prompting a withdrawal from the Fund may be transacted at the fair value of its underlying investments, which may be less than the NAV. Participants are generally prohibited from transferring their respective balances (in whole or in any part) in the Fund directly into other Plan investment options that are considered to be competing investment options. Instead, Participants must first transfer such balances into a non-competing Plan investment option for 90 days before transferring such balances into a competing Plan investment option.

The NAV of the Reliance Advisory Trust portfolios is determined by the custodian, Reliance Trust Company. Units of each Fund are valued each day on which the New York Stock Exchange (NYSE) is open for trading in accordance with the valuation procedures established by the custodian. The NAV per unit is calculated as of the close of trading on the NYSE (generally, 4:00 p.m. U.S. Eastern time). The NAV per unit is computed by dividing the total fair value of the assets of a Fund, less its liabilities, by the total number of units outstanding at the time of such computation.

With respect to the underlying funds, securities listed on a securities exchange, market or automated quotation system for which quotations are readily available are valued at the closing price on the primary exchange or market on which they are traded on the day of valuation or, if there is no such reported sale on the valuation date, at the most recent bid quotation on the principal exchange. If a market price is not readily available or if such price is deemed unreliable, it will be valued at fair value in accordance with valuation procedures established by the custodian. The custodian's determination of fair value involves consideration of a number of subjective factors and, therefore, no single standard for determining fair value will apply.

E. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the employer contributions allocated to their accounts.

F. Tax Status

Upon the restatement of the Plan on February 1, 2016, the Plan became a volume submitter profit sharing plan with CODA established by Standard Retirement Services, Inc. The Plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, that the form of plan is qualified under Section 401(a) of the IRC. The Company has not sought an individual determination letter for the plan and is relying on the opinion letter, as provided for in Revenue Procedure 2005-16. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRS and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

G. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

H. Related Party Transactions and Party-In-Interest Transactions

During 2024 and 2023, Reliance Trust Company was the custodian of the Plan and Standard was the recordkeeper. During 2024 and 2023, certain Plan investments were investments in collective trusts managed by Reliance Trust Company. The financial statements include recordkeeping expenses paid by the Plan.

Fees paid during the year for accounting and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services.

These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
