## **Note 1. Description of the Plan**

### ***General***

The following description of the Purgo 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Purgo Intermediate Holdings, LLC (Sponsor) for the benefit of its employees, and employees of participating employers, who are age 18 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company serves as the Plan's trustee.

### ***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Sponsor make annual contributions of up to 90% of eligible compensation, not to exceed the maximum allowed under IRS rules and regulations.

Participants who have reached age 50 by the end of the plan year and who have already made the maximum elective deferral may make an additional pre-tax "catch-up" contribution. The Plan permits eligible employees to designate some or all deferral contributions as Roth deferral contributions at the time deferral elections are made.

The Sponsor makes discretionary matching contributions of 50%, up to 6%, of the employees' salary deferral amounts. Employee rollover contributions are also permitted even if an employee has not yet satisfied the eligibility requirements; however, the employee may not become a participant in the Plan until they have satisfied the eligibility requirements. The Company may also make additional discretionary nonelective contributions. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan will automatically enroll eligible employees at 3% of annual compensation. Each plan year, participants shall have the percentage of their annual compensation that the participant has either elected or is deemed to have elected to contribute to the Plan automatically increased by 1% until the percentage of annual compensation is equal to 6% of compensation.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Sponsor's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after three years of continuous service.

### ***Notes Receivable From Participants***

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance, reduced by the participant's highest outstanding loan balance in the previous 12 months. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll deductions. Notes receivable from participants are secured by the vested balances in the respective participants' accounts. Interest on the loans is based on prevailing rates for loans which would be made under similar circumstances as determined by the Plan Administrator.

### ***Payment of Benefits***

Upon termination of service due to death, disability, or retirement a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on an accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Investments in registered investment companies are stated at fair value based on the quoted market price. The value of the common/collective trust is valued at the net asset value (NAV) provided by Fidelity Management Trust Company. The Plan uses NAV as a practical expedient to estimate fair value without adjustments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Contributions***

Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

### ***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

### ***Administrative Expenses***

Administrative expenses may be paid by the Sponsor or the Plan at the Sponsor's discretion.

## **Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024
- Investment income and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information except for comparing such certified investment information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedule.

## **Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of mutual funds managed by Fidelity Management Trust Company, the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Sponsor provides certain administrative services at no cost to the Plan.

## **Note 5. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan has no Level 2 or Level 3 securities.

**Investments Measured Using NAV per Share Practical Expedient**

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 7. Tax Status**

The Plan operates under a pre-approved plan sponsored by FMR LLC. The plan document has been filed with the appropriate agency and an opinion letter obtained. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued.
