Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Morgan Engineering Systems, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Morgan Engineering Systems, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of

the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the Morgan Engineering Systems, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan agreement and the summary plan description for hourly and salary employees for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all salary and hourly employees of Morgan Engineering Systems, Inc. (the Plan Sponsor) who have completed a one-month eligibility period and are age 18 or older. The plan entry date is the first day of the month that coincides with or follows the date that the participant satisfies the age and one-month eligibility period requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974.

Contributions

Each eligible participant is permitted to make pre-tax elective deferrals up to 100% of their compensation, subject to the maximum amount permitted by law, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan Sponsor elected safe harbor provision. In accordance with the provision, the Plan Sponsor will contribute a safe harbor matching contribution to participant's accounts in an amount equal to 100% of the participant's elective deferrals that are not in excess of 4% of the participant's plan compensation. The Plan Sponsor made safe harbor employer matching contributions of \$495,010 for the year ended December 31, 2024. All contributions are limited to the maximum allowed as a deduction under the Internal Revenue Code (IRC).

Vesting

A participant is fully vested immediately in elective wage deferrals, amounts rolled over from other plans, and safe harbor matching contributions. Participants are 100% vested in the employer's non-elective non-safe harbor contribution and actual earnings thereon after six years of service or once they reach the normal retirement age of 65, become totally disabled, or die. Vesting for employer non-elective non-safe harbor contribution contributions is as follows:

Participant Accounts

Each participant's account is credited with the participant's contribution including elective deferrals and rollover contributions and an allocation of the Plan Sponsor's contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations

are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments of the Plan are fully participant-directed.

Notes Receivable from Participants

Participants are permitted to borrow from their vested interest of their individual account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Participants are allowed one outstanding loan at any time. The loans are secured by the participants' vested account balance. These loans are generally payable in equal installments through payroll deductions, and bear interest at rates ranging from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions. Loan terms range from 1-5 years.

Payment of Benefits

Upon retirement, death, disability, or termination of employment, a participant, or a designated beneficiary, may elect to receive the vested balance in the participant's account in the form of a single lump-sum cash payment, installments, or a rollover into another retirement plan. In the event that the participant's account balance is less than \$5,000, the plan administrator may make a single payment without the election or request of the participant. If a participant's vested account balance exceeds \$5,000, the plan administrator may make a direct rollover to an individual retirement account, if the participant does not make an election within the designated period. Non-terminated employees may make withdrawals in excess of \$500 from their vested account balance upon reaching age 59 1/2, becoming disabled, or as a hardship as needed. Hardship withdrawals are subject to additional rules and conditions as outlined in the plan agreement.

Forfeitures

The Plan provides that all forfeitures may be used to pay plan expenses or to reduce future matching contributions. During the year ended December 31, 2024, no forfeitures were used for such purposes and there were \$966 and \$312 of forfeitures available at December 31, 2024 and 2023, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates that affect reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment adviser, custodian, and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the

accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant does not make note repayments and the plan administrator considers the participant note to be in default, the note balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Certain investment management and other fees are paid directly by the Plan. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Plan sponsor has evaluated subsequent events through September 25, 2025, which is the date the financial statements were available to be issued.

3. Information Prepared and Certified by the Custodian and Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income, interest from participants and benefit payments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the custodian and trustee of the Plan.

4. Fair Value Measurements

The authoritative accounting guidance establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative accounting guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be

observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Registered investment companies - Valued at the closing price reported on the active market on which the individual securities are traded.

Common/collective trusts: Valued at the daily net asset value (NAV) of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Money market deposit account - The fair value of money market deposit accounts is estimated to approximate deposit account balances, payable on demand, as no discount for credit quality or liquidity were determined to be applicable.

Self-directed brokerage accounts - Assets in these accounts primarily consist of cash, money market funds (valued as noted above), registered investment companies (valued as noted above), exchange traded funds and common stocks that are valued daily on the basis of readily determinable market prices.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in the employer contributions.

6. Tax Status

The Internal Revenue Service (IRS) has determined that the prototype non-standardized profit-sharing plan with cash or deferred arrangement is designed in accordance with the applicable sections of the IRC and informed Schwab Retirement Plan Services, Inc. of such in a letter dated September 21, 2020. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7. Transactions with Parties in Interest

Charles Schwab Trust Bank is the custodian and trustee and holds all of the Plan's investments. Charles Schwab Trust Bank is a party in interest of the Plan as defined by ERISA Section 3 (14) and accordingly, investment transactions in the respective funds are parties in interest transactions. Certain administrative expenses related to the Plan are paid by the Plan Sponsor. Additionally, the Plan pays another provider for investment advisory services which qualify as party in interest transactions. Other than as described above, or pursuant to a trust agreement, the Plan has no agreements or transactions with any parties in interest.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
