### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of R.J. Zavoral and Sons, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of R.J. Zavoral and Sons, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 PLAN DESCRIPTION**

The following description of the R.J. Zavoral and Sons, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all full-time employees of R.J. Zavoral and Sons, Inc. (the Company) and the related participating employers, Clay Products, Inc. and East Side Demo, Inc., who have attained the age of 19. Employees who have achieved 90 days of service are eligible to make elective deferrals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a committee appointed by the Company. Third Party Administrators serve as the providers of the Plan, maintain records of the participant data and hold the Plan assets.

**Contributions**

Each year, participants may contribute up to 100 percent of annual compensation, as defined by the Plan, subject to Internal Revenue Code (IRC) limitations. The Plan permits pretax and roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make an additional "catch-up" contribution, subject to IRC limitations. The Plan contains an automatic enrollment feature whereby employees will be notified approximately 30 days prior to when the Company will begin to automatically deduct 3 percent on a pre-tax basis. The Company contributes a safe harbor contribution that is equal to 3 percent of each participant's compensation, as defined by the Plan.

In addition, the Company will contribute amounts designated in accordance with the Plan document. The contribution is described as a percentage of prevailing wage compensation, a specific flat dollar amount, or an amount per hour worked. Rates may differ for different job classifications and may differ from project to project. Contributions are subject to certain limitations.

The Company may also contribute a nonelective contribution at its discretion. Employees must be employed at the end of the year to receive the discretionary employer contributions.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans or individual retirement accounts.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the employer's contributions, and an allocation of the Plan earnings. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. Participant accounts are charged with the allocation of administrative expenses that are paid by the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

### **Vesting**

Participants are immediately vested in their deferral contributions, prevailing wage contributions, safe harbor contributions made by the employer, qualified nonelective contributions and rollover contributions plus actual earnings thereon. Vesting in the remainder of their account is based on years and hours of service. A participant is 100 percent vested after six or more years of credited service.

### **Payment of Benefits**

A participant is eligible to request a distribution of their vested account balance based on any of the following events: death, disability, financial hardship, attainment of normal retirement age, minimum required distributions, in-service upon attaining age 59½ and termination of employment. On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of their account, or a series of substantially equal periodic installments. Generally, certain minimum distributions are required for participants who have separated from service and have reached required minimum distribution age.

For terminated employees who have not elected distribution with vested accounts greater than \$1,000, but less than \$7,000, accounts are subject to a mandatory distribution through a rollover to an individual retirement account. For terminated employees who have not elected distribution with vested balances of \$1,000 or less, accounts are subject to a mandatory distribution through a lump sum payment.

### **Forfeitures**

Forfeitures remain in the participant's name for five years, in the event the participant re-enters the Plan at a later date. As defined by the Plan, forfeitures may be used to pay Plan expenses, reduce employer contributions or be allocated to participants as an additional discretionary nonelective contribution. No forfeitures were used to pay Plan expenses for the years ended December 31, 2024 and 2023. Forfeitures totaling \$38,846 and \$42,057 were used to offset employer contributions for the years ended December 31, 2024 and 2023, respectively. There were no forfeitures allocated to participants for the years ended December 31, 2024 and 2023. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$22,382 and \$19,726, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("U.S. GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the providers. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from the financial statements.

**NOTE 4 FAIR VALUE MEASUREMENTS**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at NAV of units held by the Plan at year end. The NAV, as provided by the insurance company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the insurance company. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate accounts, the investment advisor reserves the right to temporarily delay withdrawal in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The Plan holds an investment contract which is a custodial guaranteed investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

**Guaranteed Investment Account**

The Plan investments include the Principal Fixed Income Guaranteed Option, which is a guaranteed general-account backed group annuity contract that has been issued by Principal Life Insurance Company to Principal Trust Company as custodian. The contract is a fixed, deferred group annuity. It provides guaranteed protection of principal with a set rate of return. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets and expected values for the composite crediting rate period, as stated in the contract. Interest crediting rate is reset semi-annually. The average yield earned by the Plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average for years ended December 31, 2024 and 2023 is 1.55 percent and 1.65 percent, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401 (a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501 (a) of the Internal Revenue Code.
2. Premature termination of the contracts.
3. Plan termination or merger.
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

**NOTE 6 AMENDMENT AND TERMINATION OF PLAN**

The Board of Directors has the right to amend the Plan if it determines that it is necessary or desirable to do so. Further, although the Company intends to continue the Plan, it reserves the right to terminate it. Any termination of the Plan is subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**NOTE 7 INCOME TAX STATUS**

The Internal Revenue Service has determined and informed the Company in a letter dated June 30, 2020 that the pre-approved plan document adopted by R.J. Zavoral and Sons, Inc. Retirement Plan is acceptable under the applicable section of the Internal Revenue Code and is, therefore, not subject to tax under present income tax law. The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 8 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Principal Trust Company and Principal Life Insurance Company are the providers of the plan as defined by the plan document. As such, transactions with the providers qualify as party-in-interest transactions. Total fees paid by the Plan to Principal Trust Company amounted to \$44,214 and \$35,937 for the years ended December 31, 2024 and 2023, respectively.

Certain Plan investments are units of pooled separate accounts and guaranteed investment contracts that are managed by Principal Life Insurance Company, the provider as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.
