INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Whitworth Tool, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Whitworth Tool, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Whitworth Tool, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the

We are required to be independent of Whitworth Tool, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis-of-Matter

The accompanying financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Note B to the financial statements, the Board of Directors of Whitworth Tool, Inc., the Whitworth Tool, Inc. 401(k) Plan's sponsor, voted in September 2025 to terminate the Plan, which indicates that the Plan is not a going concern. The financial statements do not include any adjustments that might be necessary upon termination. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Whitworth Tool, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

NOTE A - DESCRIPTION OF PLAN

The following description of Whitworth Tool, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. Except for the following exclusions, the Plan is a defined contribution plan covering all employees of Whitworth Tool, Inc. (Company) who are age eighteen or older. Employees are eligible to participate in the Plan on the first entry date following their date of hire, and there is no service requirement for matching contributions. The Plan excludes collectively bargained employees, nonresident aliens, and employees acquired through acquisition or merger. Eligible participants may enroll in the plan on the first day of each quarter of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Each year, participants may contribute up to the maximum allowed by the Internal Revenue Code of pre-tax and Roth contributions, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions and Company contributions into various mutual funds, pooled separate accounts, and collective trust investments offered by the Plan. The Company may make matching and non-elective contributions at its discretion. The Company elected to match 100% of the first 3% of eligible base compensation. Contributions are subject to certain IRS limitations.

Participant Accounts. Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's non-elective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and non-elective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested interest in the Plan or \$50,000. A participant may not have more than two loans outstanding at any time. Loans are subject to specific requirements and loan terms generally range from one to five years, or longer if used to purchase a principal residence. The loans are secured by the balance in the participant's account. The interest rate charged for a participant's loan is the prime rate plus 2%, which is determined by the Plan administrator at the time of the loan. Principal and interest are paid ratably through weekly payroll deductions. At December 31, 2024, interest rates ranged from 5.25% to 10.50% and maturity dates ranged from February 2025 to August 2029.

Forfeited Accounts. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$14, respectively. These accounts may be used to restore participant's forfeitures, pay Plan expenses, and reduce future employer non-elective and matching contributions, and will be disposed of in that respective order. During 2024 and 2023, \$0 was used to pay Plan expenses, \$651 and \$174 was used to reduce employer contributions, and \$0 and \$531 were allocated to participant's, respectively.

NOTE A - DESCRIPTION OF PLAN (continued)

Payment of Benefits. On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or minimum required distributions. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or rollover the balance to another qualified Plan. Participants who reach age 59 ½ may also receive distributions of their vested account balance.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors. See Note C for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

Other Employer Contributions Receivable

Other employer contributions receivable represent corrective contributions due to participants from the Company. Corrective contributions due were \$1,577 and \$1,623 as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable

At December 31, 2024 and 2023, amounts payable to participants totaling \$0 and \$3,113, respectively, for contributions in excess of amounts allowed by the IRS are recorded as excess contributions payable, with corresponding reductions to contributions. The Plan distributed the excess contributions prior to March 15th.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. See Note D for more information on expenses.

Payment of Benefits

Benefits are recorded when paid.

Recently Adopted Accounts Standards

In June 2016, the Financial Accounting Standards Board ("FASB") issued Accounting Standards Update ("ASU") No. 2016-13, Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments ("ASU 2016-13" or "ASC 326"). ASU 2016-13 revises the accounting requirements related to the measurement of credit losses and requires organizations to measure all expected credit losses for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts about collectability. Assets must be presented in the financial statements at the net amount expected to be collected. The FASB has subsequently issued additional ASUs amending certain aspects of ASU 2016-13. Management adopted this new accounting standard during 2023 and it did not have a material or significant impact on the Plan financial statements.

Date of Management's Review of Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued. In September 2025, the board of directors of Whitworth Tool, Inc., the Plan sponsor, voted to terminate the Plan effective September 6, 2025. Plan management did not identify any other subsequent events requiring recognition or disclosure.

NOTE C - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at net asset value (NAV) of units of an insurance company's pooled separate accounts. The NAV, as provided by the issuer, is used to estimate fair value. The issuer indicates these accounts have readily determinable fair values. The underlying assets in the pooled separate accounts are mutual funds that are registered with the Securities and Exchange Commission. The mutual funds are required to publish their daily NAV and to transact at that price. The pooled separate accounts, however, are not deemed to be publicly traded.

Common Collective Trusts: Valued at the NAV of units of a bank or insurance company's common/collective trusts. The NAV, as provided by the issuer, is used to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. The issuer indicates these accounts have readily determinable fair values. NAV is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3.

NOTE D - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are mutual funds, pooled separate accounts, and common collective trusts managed by Principal. Principal is custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to the custodian for investment management services of \$53,371, which was not covered by revenue sharing. These direct fees were allocated to participant's accounts. Additionally, a portion of fees incurred by the Plan for investment management and administration services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than direct payments. The Plan sponsor pays directly any other fees related to the Plan's operations. Party-in-interest transactions also include notes receivable from participants and fees paid to Baird the Plan investment advisor. See investments issued by parties-in-interest on the supplemental schedule.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE F - TAX STATUS

The Plan adopted a Prototype Plan. The IRS has determined and informed the submitters of the Prototype Plan by a letter dated June 30, 2020, that the Prototype Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Prototype Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE F - TAX STATUS (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

NOTE G - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company, conducting business as Principal Trust Company, and Principal Life Insurance Company (collectively Principal) the custodian of the Plan. Principal held the Plan's investment assets and executed investment transactions from January 1, 2023 to December 31, 2024.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I – GROUP ANNUITY CONTRACT

In December 2019, the Plan entered into a modular group annuity contract with Principal Life Insurance Company. The investment option selected under this contract is in pooled separate accounts. Changes in investment direction to these accounts can be made at any time as allowed by the Plan. Investment results on these accounts are net after operating expenses and management fees. These accounts contain no guarantee of investment performance and are valued at NAV. Transfers may be made without charge and can generally take place on any business day at their current value as of the date of transfer.
