## Independent Auditors' Report

The Board of Trustees

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Revecore 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

## Notes to the Financial Statements

December 31, 2024 and 2023

### (1) Description of plan

The following description of the Revecore 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan and was established in July 1999 and was amended and restated on January 1, 2022. Employers participating in the Plan include Bottom Line Systems, LLC, Medical Reimbursements of America, Inc. (through January 1, 2023), Rocky MRA Acquisition Corp. (through March 1, 2025), Kemberton Healthcare Services, LLC (effective August 1, 2023) and Cura Revenue Cycle Management, LLC (effective August 1, 2023) (together as the "Company" or "Plan Sponsor"). The Plan covers employees of the Company who have completed three months of service. Employees will have the opportunity to become a participant on the first "entry date" of each month, once that employee satisfies those requirements ("participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective August 1, 2023, Kemberton Healthcare Services 401(k) Plan was merged into the Plan. As a result of the merger, \$6,055,952 of participant balances were transferred into the Plan.

Effective August 1, 2023, Cura 401(k) Plan was merged into the Plan. As a result of the merger, \$321,780 of participant balances were transferred into the Plan.

#### (b) Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or after tax in the form of Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into any combination of several investment options offered by the Plan. Participant contributions are permitted up to 100% of compensation subject to certain IRC limitations. Participants over the age of 50 may make elective catch-up contributions, subject to certain IRC limitations.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4.0% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

The Company may make matching contributions to the Plan. For both the years ended December 31, 2024 and 2023, the Company made matching contributions equal to 50% of the participant's deferrals up to a maximum of \$1,000. Contributions are subject to certain statutory limitations.

(c) Participant accounts

Each participant's account is credited (charged) with the participant's contributions, and allocations of Plan Sponsor contributions, investment earnings (losses), and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their elective salary deferrals and rollover contributions plus actual earnings (losses) thereon. Vesting in Plan Sponsor contributions are based on years of service as defined in the Plan agreement. Vesting begins upon the completion of the first year of service, and a participant is 100% vested after three years of credited service for the period from January 1, 2024 through December 31, 2024 and after five years of credited service for the period from January 1, 2023 through December 31, 2023.

(e) Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable from participants are secured by the balance in the participant's account. The interest rate on these notes is set at the prime rate and is reviewed by the Plan administrator on a regular basis. Principal and interest are paid ratably through payroll deductions.

(f) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures may be used to reduce the Plan Sponsor's contributions to the Plan. Forfeited nonvested accounts totaled \$36,990 and \$73,013 at December 31, 2024 and 2023, respectively. Forfeitures totaling \$43,769 and \$143,268 were used to reduce Plan Sponsor contributions in 2024 and 2023, respectively.

(g) Payment of benefits

On termination of service due to death, permanent disability, or retirement, a participant becomes vested in their entire account. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account. Active participants may also take distributions from the Plan upon attainment of age 59½.

(h) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are generally taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's vested account balance.

(i) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Expenses of administering the Plan and fees related to notes receivable from participants and distributions are charged directly to the applicable participants' accounts and are included in administrative expenses. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments.

(j) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

(b) Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment valuation and income recognition

Investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and the Standard Insurance Company ("Standard"). See Notes 4 and 5 for discussion of fair value and contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Payment of benefits

Benefits are recorded when paid.

(e) Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in the administrative expenses and are expensed when they are incurred. The participant notes receivable are secured by the balances in the respective participants' accounts and bear interest at fixed rates ranging from 3.25% to 8.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

(f) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2024 and August 28, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments disclosed and reported in the accompanying financial statements and supplemental schedule of assets (held at end of year), including the fair value and contract value of investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest on notes receivable from participants for the years ended December 31, 2024 and 2023 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Standard.

(5) Investment contract with insurance company

The Plan holds a fully benefit-responsive investment contract that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan's traditional guaranteed investment contract is \$3,307,601 and \$2,616,057 at December 31, 2024 and 2023, respectively.

Standard maintains the contributions to the stable value investment contract in its general account. Standard guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated monthly based upon contract provisions, and it may not be less than 1.00%. Standard's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include plan termination, plan merger, premature contract termination initiated by the Plan Sponsor, and certain other Plan Sponsor-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Standard may terminate the contract. Examples of circumstances which would allow the Standard to terminate the contract at an amount less than contract value include the Plan's loss of its qualified status and uncured material breaches. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

(6) Income tax status

The Plan is currently operating under a pre-approved plan document that has been accepted under Section 401(a) of the IRC for use by employers for the benefit for their employees. This document received a favorable opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020. A determination letter has not been received specific to the Plan. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Related party and party-in-interest transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan Sponsor, and certain others. The Plan holds units of pooled separate accounts managed by The Standard and a fully benefit responsive investment contract issued by the Standard. These transactions and the Plan's payment of investment management fees to the Standard qualify as party-in-interest transactions. Notes receivable from participants held by the Plan and third party investment fees paid by the Plan also reflect party-in-interest transactions.
