## INDEPENDENT AUDITORS' REPORT

The Trustees

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan for Employees of Chautauqua Opportunities, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to financial statements.

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of Plan

The following description of the 403(b) Thrift Plan for Employees of Chautauqua Opportunities, Inc. (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a tax-deferred retirement plan sponsored by Chautauqua Opportunities, Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on January 1, 1995 and restated on May 1, 2020.

(b) Contributions

Eligible participants may make elective deferrals up to the maximum annual limitations as provided by the Internal Revenue Service (IRS) beginning on the date of hire. Participants who have attained the age of 21 and completed one year of service are eligible for the Company's non-elective contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also roll-over amounts representing distributions from other qualified plans. The Company may make a non-elective contribution. Participants direct the investment of their contributions into various mutual funds offered by the Plan.

(c) Participant Accounts

Each participant's account is credited with the participant's contributions, as well as allocations of the Company's contribution and Plan earnings. Participant accounts are charged with an allocation of investment and administrative expenses that are paid by the Plan. Allocations are based on the participant's earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their elective deferrals, including catch-up contributions, and rollover contributions and earnings thereon. Vesting in employer contributions, and earnings thereon are based on a three-year schedule as follows:

(1) Description of Plan, Continued

(e) Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested balance, whichever is less. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate which provides the Plan with a return commensurate with the interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are paid ratably through payroll deductions.

(f) Payment of Benefits

On termination of service, death, disability, or retirement, a participant will be paid in a lump sum in the form of a cash distribution, or in certain circumstances, in property or in installments over a period not more than the participant's assumed life expectancy. In addition, a participant can withdraw all or any portion of his or her vested account balance in the event of financial hardship subject to certain penalties.

(g) Forfeited Accounts

Forfeitures of non-vested employer contributions, which remain after an employee has terminated employment, shall be used to reduce future employer contributions payable and administrative expenses to the Plan. Forfeitures for the years ended December 31, 2024 and 2023 amounted to \$5,920 and \$5,769, respectively.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value, except for the interest accumulation account, which is reported at contract value. Fair value is the price that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(d) Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

(e) Contributions

Contributions from Plan participants and the Company contributions are recorded in the year in which the participants compensation is earned.

(f) Payment of Benefits

Benefits are recorded when paid.

(g) Operating Expenses

Certain expenses of maintaining the Plan are paid by the Company.

(h) Subsequent Events

The Plan has evaluated subsequent events through the date of the report which is the date the financial statements were available to be issued.

(i) Reclassifications

Reclassifications have been made to certain 2023 balances in order to conform to the 2024 presentation.

(3) Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

(3) Fair Value Measurements, Continued

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- Separate accounts - Consist solely of investments in mutual funds registered with the Securities and Exchange Commission and are carried at the net asset value at which the mutual fund shares are actively traded.

(4) Interest Accumulation Account

The general account is credited from time to time with a contractual rate of return but will not be below a minimum guaranteed interest rate. Mutual of America (MOA) reserves the right to change the interest rates at their discretion. Requests for withdrawals can be made at any time and are processed on the day they are received. The general account fixed income assets are carried at contract value. At December 31, 2024 and 2023, the balance in the interest accumulation account amounted to \$194,822 and \$177,501, respectively.

(5) Financial Certifications

The financial information relating to the Plan's assets at December 31, 2024 and 2023, as well as investment income and investment transactions as of and for the years then ended, have been derived from information provided by MOA and have been certified by them as complete and accurate. The incorporation of this financial information in the accompanying financial statements is based solely on their certifications and has not been audited by independent auditors.

The custodian also certified the completeness and accuracy of \$721,248 and \$784,880 of investment income, including interest and dividends, and net appreciation in fair value of investments for the years ended December 31, 2024 and 2023, respectively. Additionally, the custodian certified the completeness and accuracy of the interest income on notes receivable from participants of \$6,108 and \$4,462 for the years ended December 31, 2024 and 2023, respectively.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants shall have a vested interest in their account of 100%.

(7) Party-In-Interest Transactions

MOA is the custodian of the Plan's assets therefore, these transactions qualify as a party-in-interest. Notes receivable from participants also qualify as party-in-interest transactions.

(8) Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(9) Tax Status

The Plan adopted prototype non-standardized 403(b) plan through a third party administrator. This prototype plan received a favorable determination letter on March 31, 2017 from the Internal Revenue Service (IRS) indicating that the features, as then designed, conform with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions and the Department of Labor; however, there are currently no audits for any tax periods in progress.
