NOTE A - DESCRIPTION OF THE PLAN

The following description of the Calumet Electronics Corporation 401(k) Plan provides only general information. Participants should refer to the Summary Plan Description ("SPD") for a more complete description of the Plan's provisions.

General

The 401(k) Plan, established January 1, 2004, is a defined contribution plan with employee salary deferral and employer matching and discretionary components covering all eligible employees of Calumet Electronics Corporation. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees must satisfy certain age and service conditions to participate in the Plan. Employees must have attained the age of nineteen and have completed one year of service. A year of service is earned by working a minimum of 1,000 hours during the 12-month period immediately following the date of hire. If 1,000 hours is not earned in the first 12-month period, a year of service will be earned if the employee works 1,000 hours during any Plan year after the hire date.

Contributions

Each year, participants may elect to contribute up to 100% of their annual compensation on a pre-tax (traditional) or after-tax (Roth) basis, up to the Internal Revenue Service maximum allowable amount (\$23,000 in 2024 and \$22,500 in 2023). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 and \$6,500 in 2024 and 2023 respectively). Additionally, the Company may elect to make discretionary contributions monthly and/or annually. In the Plan years ending December 31, 2024 and 2023, the Company contributed to the 401(k) Plan an amount equal to \$30 per month for participants who opted out of the Company's AFLAC hospitalization policy.

Participant Accounts

Each participant's account is credited with Calumet Electronics Corporation's contribution and an allocation of gains or losses under the Plan at the end of each business day in which the New York Stock Exchange is open. Allocations are based on the participant's account balances. There may be fees or expenses allocated to participant accounts, which are generally allocated either proportionally based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. Fees related to the processing of distributions will be directly charged to the participant.

Forfeitures

Forfeitures of the non-vested employer discretionary contributions of terminated participants' accounts are used to reduce employer contributions made to the Plan, or applied to Plan expenses. There were forfeitures of \$7,770 and \$3,357 in Plan years 2024 and 2023, respectively.

Vesting

Participants' elective deferrals are immediately 100% vested. Rollover contributions are 100% vested. Certain qualified employer contributions, as defined in the SPD, are immediately 100% vested. Employer matching and discretionary contributions become vested under the following schedule:

Payment of Benefits

Upon termination of employment, participants are entitled to the full value of their vested account balance. Participants with vested benefits of \$5,000 or less will be required to receive a distribution of the entire vested benefit in a lump sum as soon as administratively feasible. If the vested balance exceeds \$5,000, the account will not be distributed to the participant prior to normal retirement date without consent. Upon consent, the balance will be paid directly to the participant as a lump sum, or the payment will be rolled over directly to an IRA or other eligible plan selected by participant. Upon normal retirement age, employees automatically become 100% vested in all contributions in the Plan. The Plan also contains hardship, disability, and death benefits as defined in the SPD.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with United States generally accepted accounting principles (U.S. GAAP).

Investment Valuation and Income Recognition

The Plan has entered into the following investment contracts with VOYA Retirement Insurance and Annuity Company (VRIAC):

Variable return investment contract - VRIAC maintains the contributions in pooled separate accounts. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by VRIAC.

Fixed rate return investment contract - VRIAC maintains the contributions in an unallocated general account. The account is guaranteed minimum rates of interest and may credit interest that exceeds the minimum guaranteed rate. The rate is subject to change, but will never fall below the guaranteed minimum.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note C for discussion of fair value measurements.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. As of December 31, 2024 and 2023, there were no undistributed excess contributions in the Plan.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Organization evaluates events occurring subsequent to the date of the financial statements in determining the accounting for disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through the date of the accompanying independent auditor's report, which is the date the financial statements were available to be issued.

NOTE C - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.
Level 2	Inputs other than quoted prices included within level 1 that are observable for the asset or liability, either directly or indirectly.
Level 3	Inputs consist of unobservable inputs for the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Pooled Separate Accounts: The pooled separate accounts are valued at their accumulation unit value (AUV). AUV is the value of each unit in the separate account. The separate account is valued daily as the number of accumulation units held multiplied by the AUV. The AUV is determined daily based on the Net Asset Value (NAV) of shares of the underlying fund, the fund's dividends, and the contract's separate account charges.

Guaranteed Investment Contract or Common Trust Funds: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - PLAN TAX STATUS

The Company obtained its latest determination letter on March 7, 2012, in which the Internal Revenue Service stated that the Plan, as then designed, was in accordance with applicable requirements of the Internal Revenue Code. The Plan was restated effective January 1, 2022 in accordance with Internal Revenue Service and Department of Labor provisions and restatement timelines.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E - PLAN TERMINATION

It is the intent of Calumet Electronics Corporation to continue the Plan indefinitely. However, the Company has the right to terminate the Plan at any time. Termination includes a complete discontinuance of contributions under the Plan or a partial termination. If the Plan is terminated, all amounts credited to participant accounts become 100% vested, regardless of the Plan's current vesting schedule.

NOTE F - RISK AND UNCERTAINTIES

The Plan invests in a variety of investment funds. Investments are generally exposed to various risks, such as credit, interest rate, and overall volatility risk. Due to the level of risk associated with various investments, it is possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Fees paid to mutual fund managers, the amounts of which are unknown, are netted against investment income. Professional fees for the administration and audit of the Plan were paid by Calumet Electronics Inc.

NOTE I - AMENDMENTS

The Plan was restated effective January 1, 2022 in accordance with IRS and DOL provisions. There were no Plan amendments during the 2024 Plan year end.
