Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the TradeLink LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Notes to Financial Statements

Note 1. Description of Plan

The following description of the TradeLink LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan that, with the exception of nonresident aliens and independent contractors, covers all employees of TradeLink LLC and TradeLink Capital, LLC (collectively, the Company) who are at least 18 years of age. Eligible employees may participate in the Plan as of the beginning of the month after their start date at the Company following the attainment of 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: The Plan is designed as a qualified cash deferred arrangement pursuant to Section 401(k) of the Internal Revenue Code (IRC) and provides for the following contributions:

Participant contributions - each year, participants may contribute, pre-tax, up to 75 percent of annual compensation, as defined, subject to IRC limitations, which was \$23,000 for 2024. Participants may, in lieu, make after-tax Roth contributions, subject to certain limitations. Participants who have attained age 50 before the plan year-end are eligible to make catch-up contributions of up to \$7,500 for 2024. Participants may change their salary deferral election on the first day of any calendar month.

Participant rollover contributions - A participant may contribute amounts distributed or transferred from another qualified plan.

Company match and profit-sharing contributions - The Company, at its sole discretion, may make discretionary matching contributions and/or a profit-sharing contribution on behalf of eligible active participants. Such contributions, if any, are limited to the maximum amount permitted under the requirements of the IRC. Company matching contributions and profit-sharing contributions total \$0 and \$1,500, respectively, for the year ended December 31, 2024.

Investment options: Participants may direct participant and Company contributions, if any, into various investment options offered by the Plan. Participants may change their investment options each business day.

Participants' accounts: Participants' accounts are credited with the participant's contribution and rollover contributions, and allocations of Company contributions, if any, and plan earnings or losses, and charged with administrative expenses. Allocations are based on participants' earnings or account balances, as defined.

Vesting: Participants are immediately vested in their contributions, rollover contributions and Company profit-sharing contributions. Participants vest in Company matching contributions at 50% after one year of service and become fully vested (100%) after two years of service. However, any Participant who becomes disabled or reaches Normal Retirement Age, as defined in the Plan documents, while still employed by the Company, will be fully vested regardless of their length of service. There were no unvested balances as of December 31, 2024 and December 31, 2023.

Note 1. Description of Plan (Continued)

Notes receivable from participants: Participants may borrow from their fund account a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Note terms range up to 5 years, or 10 years for the purchase of a primary residence. Notes are due and payable in full upon termination of employment. The notes are secured by the balance in the participant's account and bear interest based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances at the time of loan origination as determined by the Plan Administrator. A participant may have only one note outstanding at a time. Outstanding loans as of December 31, 2024 had interest rates ranging from 4.50% to 8.50% with maturities through December 2027.

Payment of benefits: Payments of benefits are made to participants or their beneficiaries upon death, normal retirement, attaining age 59 1/2, proven financial hardship or disability. Benefits are payable in a lump sum.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Those in the Plan's governance determine the Plan's valuation policies utilizing information provided by the Plan's trustee. See Note 4 for a detailed discussion of fair value measurements.

Purchases and sales of investments are recorded on trade date. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Plan administration: Investment advisory, portfolio management and recordkeeping fees are paid by the Plan with investment advisory and portfolio management fees being included in net appreciation or depreciation of fair value of investments. All other significant costs related to plan administration and professional services are paid by the Company.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Principal and interest is repaid ratably through payroll deductions. Defaulted notes receivable from participants are recorded as distributions based upon the terms of the plan document. For the year ended December 31, 2024, no notes receivable from participants were deemed uncollectible.

Note 3. Information Certified or Provided by Fidelity Management Trust Company

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified or provided by Fidelity Management Trust Company (the trustee) and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information contained in the financial statements and supplemental schedule:

The trustee also certified to the completeness and accuracy of \$3,174,119 of net appreciation in fair value of investments, \$950,716 of interest and dividends related to the aforementioned plan investments, and \$4,913 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable for the asset or liability and includes situations where there is little, if any, market activity for the asset or liability.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies and money market funds: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require transfer of investments from one fair value level to another. The Plan evaluates the significance of the transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Levels 1, 2 or 3.

Note 5. Related-Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of registered investment companies managed by Fidelity Investments. Fidelity Investments is an affiliate of Fidelity Management Trust Company, which is the trustee of the Plan and third-party administrator and, therefore, these transactions qualify as party-in-interest transactions.

The Plan made a direct payment to an affiliate of the trustee of the Plan, the recordkeeper, of \$18,453 during the year ended December 31, 2024.

Certain employees of the Company provide administrative services for the Plan and are not reimbursed for their services from the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants will become fully vested in any unvested account balances.

Note 7. Tax Status

Effective September 1, 2021, the Plan adopted a defined contribution plan sponsored by Fidelity Management & Research Co. The defined contribution plan has received an opinion letter, issued to the plan sponsor, dated June 30, 2020, from the Internal Revenue Service (IRS) stating that the Plan is qualified under Section 401(a) of the IRC and any employer adopting this defined contribution plan will be considered to have a plan qualified under the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since the receipt of the opinion letter; however, the Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that through December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the TradeLink LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan that, with the exception of nonresident aliens and independent contractors, covers all employees of TradeLink LLC and TradeLink Capital, LLC (collectively, the Company) who are at least 18 years of age. Eligible employees may participate in the Plan as of the beginning of the month after their start date at the Company following the attainment of 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: The Plan is designed as a qualified cash deferred arrangement pursuant to Section 401(k) of the Internal Revenue Code (IRC) and provides for the following contributions:

Participant contributions - each year, participants may contribute, pre-tax, up to 75 percent of annual compensation, as defined, subject to IRC limitations, which was \$23,000 for 2024. Participants may, in lieu, make after-tax Roth contributions, subject to certain limitations. Participants who have attained age 50 before the plan year-end are eligible to make catch-up contributions of up to \$7,500 for 2024. Participants may change their salary deferral election on the first day of any calendar month.

Participant rollover contributions - A participant may contribute amounts distributed or transferred from another qualified plan.

Company match and profit-sharing contributions - The Company, at its sole discretion, may make discretionary matching contributions and/or a profit-sharing contribution on behalf of eligible active participants. Such contributions, if any, are limited to the maximum amount permitted under the requirements of the IRC. Company matching contributions and profit-sharing contributions total \$0 and \$1,500, respectively, for the year ended December 31, 2024.

Investment options: Participants may direct participant and Company contributions, if any, into various investment options offered by the Plan. Participants may change their investment options each business day.

Participants' accounts: Participants' accounts are credited with the participant's contribution and rollover contributions, and allocations of Company contributions, if any, and plan earnings or losses, and charged with administrative expenses. Allocations are based on participants' earnings or account balances, as defined.

Vesting: Participants are immediately vested in their contributions, rollover contributions and Company profit-sharing contributions. Participants vest in Company matching contributions at 50% after one year of service and become fully vested (100%) after two years of service. However, any Participant who becomes disabled or reaches Normal Retirement Age, as defined in the Plan documents, while still employed by the Company, will be fully vested regardless of their length of service. There were no unvested balances as of December 31, 2024 and December 31, 2023.

Note 1. Description of Plan (Continued)

Notes receivable from participants: Participants may borrow from their fund account a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Note terms range up to 5 years, or 10 years for the purchase of a primary residence. Notes are due and payable in full upon termination of employment. The notes are secured by the balance in the participant's account and bear interest based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances at the time of loan origination as determined by the Plan Administrator. A participant may have only one note outstanding at a time. Outstanding loans as of December 31, 2024 had interest rates ranging from 4.50% to 8.50% with maturities through December 2027.

Payment of benefits: Payments of benefits are made to participants or their beneficiaries upon death, normal retirement, attaining age 59 1/2, proven financial hardship or disability. Benefits are payable in a lump sum.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Those in the Plan's governance determine the Plan's valuation policies utilizing information provided by the Plan's trustee. See Note 4 for a detailed discussion of fair value measurements.

Purchases and sales of investments are recorded on trade date. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Plan administration: Investment advisory, portfolio management and recordkeeping fees are paid by the Plan with investment advisory and portfolio management fees being included in net appreciation or depreciation of fair value of investments. All other significant costs related to plan administration and professional services are paid by the Company.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Principal and interest is repaid ratably through payroll deductions. Defaulted notes receivable from participants are recorded as distributions based upon the terms of the plan document. For the year ended December 31, 2024, no notes receivable from participants were deemed uncollectible.

Note 3. Information Certified or Provided by Fidelity Management Trust Company

The following is a summary of the Plan's asset and income information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified or provided by Fidelity Management Trust Company (the trustee) and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information contained in the financial statements and supplemental schedule:

The trustee also certified to the completeness and accuracy of \$3,174,119 of net appreciation in fair value of investments, \$950,716 of interest and dividends related to the aforementioned plan investments, and \$4,913 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable for the asset or liability and includes situations where there is little, if any, market activity for the asset or liability.

Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies and money market funds: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require transfer of investments from one fair value level to another. The Plan evaluates the significance of the transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Levels 1, 2 or 3.

Note 5. Related-Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of registered investment companies managed by Fidelity Investments. Fidelity Investments is an affiliate of Fidelity Management Trust Company, which is the trustee of the Plan and third-party administrator and, therefore, these transactions qualify as party-in-interest transactions.

The Plan made a direct payment to an affiliate of the trustee of the Plan, the recordkeeper, of \$18,453 during the year ended December 31, 2024.

Certain employees of the Company provide administrative services for the Plan and are not reimbursed for their services from the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants will become fully vested in any unvested account balances.

Note 7. Tax Status

Effective September 1, 2021, the Plan adopted a defined contribution plan sponsored by Fidelity Management & Research Co. The defined contribution plan has received an opinion letter, issued to the plan sponsor, dated June 30, 2020, from the Internal Revenue Service (IRS) stating that the Plan is qualified under Section 401(a) of the IRC and any employer adopting this defined contribution plan will be considered to have a plan qualified under the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since the receipt of the opinion letter; however, the Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that through December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
