INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the
LOOP LLC Employees' Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of LOOP LLC Employees' Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements (collectively, the financial statements).

Plan management (Management), having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024, and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by the institution that Management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with US GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect Management's responsibility for the financial statements.

In preparing the financial statements, Management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1: DESCRIPTION OF THE PLAN

The following description of the LOOP LLC Employees' Savings Plan (the Plan) provides only general information. Participants should refer to the Plan documents or Summary Plan Description for a more complete description of the Plan's provisions, which is available from Plan management.

General

The Plan is a defined contribution plan that is administered by LOOP LLC (the Company) and managed by Vanguard Fiduciary Trust Company (Vanguard). The Plan was established on May 1, 1978, and was subsequently revised multiple times. The latest revision was made on January 1, 2016. The Plan covers full-time regular employees of the Company and any subsidiary or affiliated corporation that adopts the Plan. Employees are eligible to join the Plan beginning the first pay period following the first month anniversary of their date of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Once eligible, a participant may authorize pretax and/or after-tax contributions totaling from 1% to 50% of his/her base compensation. Pretax contributions are limited, however, to an annual contribution level of \$23,000 per year in 2024. If an eligible employee has not declined participation, such employee is automatically enrolled at a 7% rate. Employees age 50 or over can make additional pretax "catch-up" contributions up to \$7,500. The Company will match the employee's contribution (pretax or after-tax basis, but excluding catch-up contributions) up to 7% of the employee's base compensation.

Rollovers

Eligible participants may elect to rollover distributions from a former employer's qualified retirement plan into the Plan.

Participant Accounts

Valuation of the trust assets held in each fund is performed daily and, on the basis thereof, the value of each participant's account is determined. Each participant's account is credited with the participant's and employer's contributions and the investment's earnings or losses, and charged with any distributions made to the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are fully vested in both pretax and after-tax voluntary contributions when made. Participants vest in the employer matching contributions upon either early or normal retirement, death, disability, five years of service (20% per year), or termination of the Plan by the Company, all as defined in the Plan documents.

Notes Receivable from Participants

A participant may borrow the lesser of \$50,000, reduced by the highest outstanding receivable balance from the participant in the previous 12-month period, or 50% from the portions of his/her account derived from vested employer contributions, employee contributions, and any earnings thereon, subject to several specific rules as defined in the Plan. Repayments are made through biweekly payroll deductions over a period established at the time the loan is made. The loan bears interest at a rate of 1 percent more than the prime interest rate at the date of issuance of the loan, as determined by the LOOP LLC Administrative Committee (the Committee). Notes receivable from participants are secured by the applicable participant's vested account balance and valued at amortized cost. In 2024, the Prime Rate ranged from 7.50% to 8.50%, therefore the interest rate applied to loans in the LOOP plan ranged from 9.00% to 9.50% from January 1, 2024, to December 31, 2024. The current outstanding loans in the plan have various maturity dates through November 8, 2038.

Payment of Benefits

Distributions of benefits (vested balances) to participants can be made in lump sum or by annuity contracts over extended periods at the participant's election or rolled into another plan. Certain restrictions may apply to the withdrawal of participant accounts.

Forfeited Accounts

If a participant terminates his/her employment with the Company and fails to return to employment within the Plan year, the nonvested portion of his/her account is forfeited and may be used to reduce current or future Company contributions payable to the Plan. The 2024 and 2023 ending balance of forfeitures were \$48,051 and \$46,113, respectively. During 2024, \$48,730 was utilized to reduce company matching contributions. The remaining balance will be utilized in subsequent years.

Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Plan Expenses

Expenses incurred in the administration of the Plan were paid by the Company in 2024. Administrative expenses of \$82,501 were paid for with plan assets during 2024. Additionally, expenses in connection with notes receivable from participants are charged to participants' accounts.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3: INVESTMENTS (CERTIFIED BY TRUSTEE) & FAIR VALUE MEASUREMENTS

Certain information in the accompanying financial statements and Schedule of Assets (Held at End of Year) related to investments and notes receivable from participants held as of December 31, 2024 and 2023, as well as net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was certified as complete and accurate by Vanguard Fiduciary Trust Company, the Plan's trustee (the Trustee). This certification was provided in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management obtained this information and agreed to or derived it from the information certified by the Trustee.

The Financial Accounting Standards Board (FASB) ASC 820, *Fair Value Measurement*, (FASB ASC 820) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets;

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Vanguard Brokerage Option is valued based on quoted market prices of the underlying securities held within the account, consistent with Level 1 inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4: PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds managed by an affiliate of Vanguard, which is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE 5: RISKS AND UNCERTAINTIES

The Plan invests in various securities including mutual funds, common collective trusts, and pooled separate accounts. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

As of December 31, 2024 and 2023, approximately 15% and 12% of the Plan's net assets were invested in a single mutual fund. These concentrations expose the Plan to a greater risk of loss should the value of these investments decline significantly.

NOTE 6: PLAN TAX STATUS

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated May 18, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code of 1986, as amended (IRC). There have been no amendments to the Plan since the last determination letter. The Plan Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. There is no provision for income taxes as the Plan was qualified and the related trust was tax-exempt under the IRC as of December 31, 2024 and 2023. U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7: SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 2, 2025, the date of the financial statements were available to be issued.

Effective April 18, 2025, the Plan's trustee and recordkeeping services transitioned from Vanguard Fiduciary Trust Company to Fidelity Investments. All Plan assets were transferred and reconciled in accordance with the Plan's provisions with no material discrepancies noted.
