# METALSA – UAW RETIREMENT AND SAVINGS PLAN

## NOTES TO FINANCIAL STATEMENTS

### 1. DESCRIPTION OF PLAN:

The following description of Metalsa (“Plan Sponsor” and “Employer”) - UAW Retirement and Savings Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan covering all full-time employees of the Employer who are members of a collective bargaining unit at one of the following facilities: Elizabethtown, KY, Hopkinsville, KY, and, Roanoke, VA. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Salaried employees and other non-bargained employees of the Plan Sponsor are covered under the Metalsa Retirement Savings Plan.

#### Contributions

*Participant Deferral (Pre-tax):* Plan participants can elect to contribute from 1% to 50% of their eligible compensation, not to exceed the allowable amount under Section 402(g) of the Internal Revenue Code. Contributions are based upon total eligible compensation, which is base pay, overtime, shift premium pay, vacation pay and other paid time-off, incentive earnings, and other cash compensation, before any other Plan Sponsor sponsored benefit reductions (such as health care contributions, etc.). Eligible compensation will not include long-term disability benefits, separation pay, or other benefit payments, or perfect attendance bonuses paid in Elizabethtown. Contributions made by highly compensated employees may be restricted by dollar limits set annually by the Internal Revenue Service. Participants’ contributions are made through automatic payroll deductions every pay period. Pre-tax deferral contributions and related earnings are not taxable to the participant until they are withdrawn from the Plan.

*After-Tax Participant Contributions:* The Plan also allows participants to contribute a portion of their eligible compensation into the Plan as an after-tax contribution. After-tax participant contributions are contributed to the Plan from amounts that have already been treated as taxable income. These contributions will not reduce their taxable income in the year in which they contribute a portion of their eligible compensation into the Plan but will be tax-free when distributed from the Plan. Earnings on after-tax participant contributions will not be taxed until they take a distribution from the Plan. The total pre-tax and after-tax contributions cannot exceed 50% of their eligible compensation.

*Rollovers:* Participants who were members of an unrelated qualified plan may elect to make a rollover contribution from that plan to the Plan.

*Employer Contributions:* Employer contributions are determined by participant location and applicable collective bargaining agreements in place.

#### 1. DESCRIPTION OF PLAN - (Continued):

##### Contributions – (Continued)

If the participant is employed in the collective bargaining unit at the Elizabethtown, KY facility, the Employer will make matching contributions as follows:

1. For participants who became members of the Elizabethtown bargaining unit on or after January 1, 2003, fifty percent (50%) of the amounts the participant has contributed to the Plan during the year as eligible compensation deferral contributions, but only with respect to eligible compensation deferral contributions (not after-tax contributions) and only with respect to that portion of the participant's deferral contributions for the Plan year that do not exceed five percent of that participant's eligible compensation, or
2. For any participant who became a member of the Elizabethtown, Kentucky bargaining unit prior to January 1, 2003, the sum of seventy-five percent (75%) of the first \$350 they contribute to the Plan as deferral contributions during the year, and thirty percent (30%) of that portion of their deferral contributions for the Plan year that exceeds \$350, provided that, the Employer matching contributions made on behalf of the participant with respect to their deferral contributions shall not exceed five percent (5%) of that participant's eligible compensation; and
3. For a participant who became a member of the Elizabethtown, Kentucky bargaining unit prior to January 1, 2003 and makes after-tax contributions to the Plan, Employer matching contributions equal to the sum of seventy-five percent (75%) of the first \$350 they contribute to the Plan as after-tax contributions during the year, and thirty percent (30%) of that portion of their after-tax contributions for the Plan year that exceeds \$350, provided that, the total Employer matching contributions made on behalf of the participant with respect to their after-tax contributions shall not exceed five percent (5%) of that participant's compensation.

Participants at the Roanoke, VA facility are eligible for Employer matching contributions of one-hundred percent (100%) of the first three percent (3%) and fifty percent (50%) of the next two percent (2%) of their eligible compensation.

Participants at the Hopkinsville, KY facility are eligible for Employer matching contributions of fifty percent (50%) (twenty-five percent from January 1, 2023 to May 20, 2024) of the amount the participant has contributed to the Plan during the year as deferral contributions, but only with respect to pre-tax deferral contributions (not after-tax contributions). The Employer matching contribution is calculated with respect to the portion of the participant's deferral contributions for the Plan year that do not exceed five percent (5%) of that participant's eligible compensation.

Any Employer matching contributions will be credited to a separate matching contributions account. All amounts credited will be one-hundred percent (100%) vested and non-forfeitable at all times.

### NOTES TO FINANCIAL STATEMENTS - (Continued)

#### 1. DESCRIPTION OF PLAN - (Continued):

##### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer's contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants immediately vest in their contributions and Employer matching contributions plus actual earnings thereon.

##### Investment Options

Upon enrollment in the Plan, a participant may direct contributions to a variety of investment funds.

##### Benefits Paid

The Plan is designed to provide participants with benefits at the time of retirement. However, if employment with the Plan Sponsor is terminated, the balance of a participant's vested Plan accounts becomes distributable to them. Upon proper notification of the Plan Administrator, the account balance will be distributed to the participant in the form of a lump-sum cash payment. The participant may also request a rollover distribution, as soon as practicable after separation from service.

The normal retirement age for the Plan is 65. Participants may continue as participants in the Plan past the normal retirement age.

If a participant dies before any or all of their account balance has been distributed to them, their beneficiary will be entitled to receive all undistributed benefits. Participants automatically become 100% vested in their account balance upon their death.

Prior to terminating service or attaining normal retirement age, a participant under certain hardship conditions may elect to receive a distribution of their contributions, certain Employer contributions and earnings thereon.

Participants may elect to take a withdrawal from the after-tax contributions account balance (including earnings on the after-tax contributions) or from any portion of their rollover account balance or prior plan account balance (if any) attributable to after-tax contributions that were made to the Dana 401(k) Savings Plan before 2010. The participant may not take more than two such withdrawals during any one year. The amount of the withdrawal may not be less than \$500, or, if less, has to be the entire after-tax contributions account balance.

### NOTES TO FINANCIAL STATEMENTS - (Continued)

#### 1. DESCRIPTION OF PLAN - (Continued):

##### Participants Notes Receivable

Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at prime plus 1% as of the loan origination date. Principal and interest is paid ratably through monthly payroll deductions. Only actively working participants may borrow funds. Inactive participants, former employees or beneficiaries may not take out a loan.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

The following accounting policies, which conform to accounting principles generally accepted in the United States ("GAAP"), have been used consistently in the preparation of the Plan's financial statements:

##### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

##### Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Participants Notes Receivable

Notes receivable from participants are valued at cost at borrowing less principal repayments received from participant, plus any accrued interest.

##### Benefits Paid

Benefits are recorded when paid.

##### Income Taxes

The income tax returns of the Plan for 2024, 2023 and 2022 are subject to examination by the income taxing authorities, generally for three years after it is filed.

### NOTES TO FINANCIAL STATEMENTS - (Continued)

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - (Continued):

##### Administrative Expenses

Substantially all expenses of maintaining the Plan are paid by the Plan Sponsor. Participant loan fees are charged directly to the participant's account and included in administrative expenses.

#### 3. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### 4. FAIR VALUE MEASUREMENTS:

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Accounting standards establish fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. There are no Plan assets requiring the use of Level 3 inputs as of both December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Registered Investment Companies* – Shares of registered investment companies (mutual funds) are valued at quoted market prices on the last business day of the Plan year, which represent the fair market value of shares held by the Plan.

*Common Collective Trust* – The common collective trust is valued at the net asset value (“NAV”) of the units held by the Plan. The NAV is based upon the value of the underlying investments which are traded on an active market.

#### 5. TRANSFER TO/FROM OTHER PLAN:

As described in Note 1, the Plan Sponsor also sponsors the Metalsa Retirement Savings Plan for its employees who are not members of a collective bargaining unit. Bargained employees may change employment, with the Plan Sponsor, to positions that preclude them from continuing their membership in a collective bargaining unit. These participants become immediately eligible in the Metalsa Retirement Savings Plan and their balance from the Plan is transferred to the Metalsa Retirement Savings Plan. Likewise, as Metalsa Retirement Savings Plan participants become members of a collective bargaining unit, they immediately become eligible in the Plan and their Metalsa Retirement Savings Plan balance is transferred in to that plan.

#### 6. TAX STATUS:

The Plan is an adoption of a prototype plan sponsored by Vanguard Fiduciary Trust Company (“Trustee”). The IRS has determined and informed the Trustee by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and; therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

#### 7. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:

For the years ended December 31, 2024 and 2023, all assets are held and invested by the Trustee. The Trustee also receives and holds all income from the investments. In accordance with DOL Section 2520.103-8, verification of the transactions and investment values is not required and is not within the scope of the audit. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the Trustee as of December 31, 2024 and 2023 and for the year ended December 31, 2024:

#### 9. RELATED PARTY TRANSACTIONS:

Certain plan administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

Plan investments were managed by Vanguard Fiduciary Trust Company and the Plan is administered by Vanguard Corporation. Vanguard Fiduciary Trust Company is the Trustee as defined by the Plan and; therefore, these transactions qualify as party-in-interest.

Participant notes receivable qualify as party-in-interest transactions. Loan fees are paid by the participants and are included in administrative expenses of \$12,122 for the year ended December 31, 2024. All other Plan expenses are paid by the Plan Sponsor.

#### **10. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **11. SUBSEQUENT EVENTS:**

The Plan Sponsor has evaluated all subsequent events through September 23, 2025, the date the financial statements were available to be issued.
