Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Consumer Directed Choices, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination

As discussed in Note 5 of the financial statements, the Board of Directors of Consumer Directed Choices, Inc., the Plan's sponsor, voted to terminate the Plan effective July 11, 2025, and management determined liquidation is imminent. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.



Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Description of Plan

The Consumer Directed Choices, Inc. 401(k) Plan (Plan) was established on September 1, 2009. The Plan is sponsored by Consumer Directed Choices, Inc. (Plan Sponsor). The Plan Sponsor is an enrolled provider within the New York Statewide Medicaid-funded program, Consumer Directed Personal Assistance. Through this program, eligible individuals (Consumers) directly employ and supervise personal assistants (Personal Assistants). The Plan covers eligible Personal Assistants as well as eligible employees of the Plan Sponsor (collectively, Employees). The Plan was most recently restated effective January 1, 2024.

The following description of the Plan is provided for general informational purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a multiple-employer, defined contribution plan covering eligible Employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective November 14, 2024, Ascensus Trust Company (Ascensus) acquired Newport Trust Company (the trustee of the Plan as of December 31, 2023) and Newport Group, Inc. (the recordkeeper of the Plan as of December 31, 2023). Upon completion of the acquisition, Ascensus became the Trustee and Recordkeeper of the Plan. Contributions, participant elective deferrals and participant accounts are held by the Trustee, which invests cash received and income from investments based on written instructions from the Plan Sponsor and participants and makes distributions to participants. The Finance Committee of the Board of Directors is responsible for oversight of the Plan and for determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

b. Contributions

Each year, participants may contribute a percentage of their pre-tax compensation, subject to certain limitations as defined by the Plan. In addition, participants may contribute after-tax Roth elective deferral contributions to the Plan. Contributions are subject to certain limitations as defined by the Plan and the Internal Revenue Code (IRC). The maximum participant deferral was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make catch-up contributions, up to a maximum of \$7,500 for the years ended December 31, 2024 and 2023. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan allows for the Plan Sponsor to make discretionary profit sharing and discretionary match contributions. The discretionary profit sharing contribution is class-allocated with each employee in a separate class. The discretionary match contribution allows for the Plan Sponsor to determine the match formula, and who receives a match contribution, each Plan year. The following paragraphs describe the employer discretionary contributions for the Plan years ended December 31, 2024 or 2023:

Management and administrative employees: The discretionary profit sharing contribution for management and administrative employees was 4% of eligible wages for each of the years ended December 31, 2024 and 2023. Management and administrative employees must be employed on the last day of the Plan year to be eligible for the discretionary profit sharing contributions. The discretionary match formula was 100% of the first \$6,000 and 50% of the next \$3,000 contributed by each management and administrative employee for the years ended December 31, 2024 and 2023. Management and administrative employees must be employed on the last day of the Plan year to be eligible for the discretionary match.

b. Contributions (Continued)

Personal Assistants: The Plan Sponsor matched 50% of the first \$2,000 of the Personal Assistant's salary reduction contributions for each of the years ended December 31, 2024 and 2023. Personal Assistants must complete 500 hours of service and be employed on the last day of the Plan year to be eligible for the discretionary match. There were no discretionary profit sharing contributions made to Personal Assistants for the years ended December 31, 2024 or 2023.

Participants who are not employed on the last day of the Plan year due to death, disability, or retirement, but otherwise meet the eligibility requirements, will receive the discretionary match and/or profit sharing contribution, if any.

Participants direct the investment of their contributions, along with Plan Sponsor contributions made on their behalf, into various account options offered by the Plan.

c. Plan Eligibility

Employees are eligible to participate in the Plan on the date of their employment.

d. Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of: (a) the Plan Sponsor's discretionary match contributions, if any; (b) the Plan Sponsor's discretionary profit sharing contribution, if any; and (c) Plan earnings (losses), net of charges for an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts is based on years of continuous service. A participant is not vested until they attain three years of credited service, at which time they become 100% vested. A participant is fully vested upon death, disability, or retirement.

f. Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. In addition, the \$50,000 limit is reduced by the highest outstanding loan balance (of any previous loan made) in the previous 12 months. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. In general, principal and interest are paid ratably over a period not to exceed five years through regular payroll deductions. Participants do not become eligible for a second loan until the first loan is fully paid.

g. Payment of Benefits

Upon the termination of service due to death, disability, retirement or other reasons, a participant (or their beneficiary upon death) may elect to receive an amount equal to the value of the participant's vested interest in their account as a lump-sum payment, a direct rollover to an IRA or qualified plan, or a series of substantially equal installments. However, if the vested portion of a participant's account balance is \$5,000 or less (excluding rollover balances), this amount will be paid as a lump-sum distribution to the participant as soon as possible following their termination, retirement or disability, or to their beneficiary following death. A participant who is still an active employee may take a financial hardship distribution, subject to the provisions of the Plan. In-service distributions may also be made to participants who have reached age 59½, subject to provisions of the Plan.

h. Forfeitures

Forfeitures may first be used to pay Plan expenses. Forfeitures not used to pay Plan expenses are added to the employer's matching contributions and allocated in the same manner, in accordance with the Plan document. Forfeiture account balances totaled \$36,541 and \$10,759 as of December 31, 2024 and 2023, respectively, which were allocated to employees as employer contributions during the following Plan year.

Note 2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) for defined contribution plans.

b. Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants on the measurement date. The Plan Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and the Trustees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

d. Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year the employee contributions are withheld from compensation.

e. Participant Notes Receivable

Participant notes receivable are stated at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. If a participant ceases to make loan repayments, the loan is deemed to be in default. Defaulted loan balances are taxable income to the participant in the year of default. Defaulted loans remain Plan assets until the loan is repaid or the participant has a distributable event. Loans treated as distributions totaled approximately \$11,300 during the year ended December 31, 2024. There were no loans that were treated as distributions during the year ended December 31, 2023.

f. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

g. Payment of Benefits

Benefits are recorded when paid.

h. Administrative Expenses

Certain expenses of the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

i. Subsequent Events

The Plan administrator has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued. See Note 5.

Note 3. Certified Investments

Certain information related to cash, investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including cash (non interest-bearing), investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on participant notes receivable for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Newport Trust Company and Ascensus.

Note 4. Investments and Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There were no changes to the methodology during the years ended December 31, 2024 or 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Plan Termination

The Plan Sponsor's Board of Directors adopted a resolution to terminate the Plan effective July 11, 2025. As a result, management determined that liquidation was imminent as of July 11, 2025. Personal Assistants, along with terminated management and administrative employees, may elect to withdraw their account balance, rollover their account balance into another qualified plan, or rollover their account balance to an Individual Retirement Account (IRA) with Ascensus. Management and administrative employees that are employees as of the termination date of the Plan may also elect to have their account balances transferred to a newly formed plan sponsored by the Plan Sponsor. All participants became fully vested in their account balances as of the date of Plan termination.

Note 6. Tax Status

The Plan Sponsor has adopted a pre-approved plan document that has received an opinion letter from the IRS dated November 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

The Plan's management evaluates tax positions taken by the Plan and recognizes a tax liability or asset if an uncertain tax position was taken and it is more likely than not that the tax position would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party Transactions

Administrative expenses incurred and paid by the Plan Sponsor totaled approximately \$62,500 and \$38,200 for the years ended December 31, 2024 and 2023, respectively. Certain Plan administrative functions are performed by officers or employees of the Plan Sponsor who do not receive compensation for such functions from the Plan.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events that could impact the value of investment securities, such as international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and, such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
