### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of the EEDU LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ### ***Opinion***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

# EEDU LLC 401(k) Plan

## *Notes to Financial Statements*

### 1. Description of the Plan

The following description of the EEDU LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan, established effective January 1, 2022, is a defined contribution plan covering substantially all employees of EEDU LLC (the “Plan Sponsor”). The Plan was amended and restated effective October 1, 2022 to add deferral, Roth and safe harbor contribution features to the Plan. Employees must be at least 18 years of age and complete 3 months of service in order to become a participant in the Plan and begin making elective deferrals and receiving Plan Sponsor safe harbor matching contributions and non-elective contributions. In accordance with the Plan agreement, the following classes of employees are excluded from eligibility:

- Employees covered by a collective bargaining agreement;
- Leased employees;
- Non-resident aliens; and
- Interns.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by Human Interest, Inc. (the “Plan Administrator”).

In March 2025, the Plan Sponsor initiated termination of the Plan. See Note 6.

**Contributions** – Participants may elect to contribute a specific percentage or dollar amount of their annual compensation as a pre-tax or Roth contribution. Participants may elect to defer up to 90% of compensation on a pre-tax basis, or 50% of compensation on a Roth basis, limited by the amount imposed by law. Additionally, participants age 50 or older may elect to make a catch-up contribution limited to the amount imposed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (i.e., rollovers).

The Plan provides for automatic enrollment of all eligible employees upon reaching the applicable age requirements. Employees who are automatically enrolled have 3% of their eligible compensation deferred on a pre-tax basis. Each year on January 1, employees’ deferral rates automatically increase by 1%, up to a maximum of 15%.

The Plan Sponsor safe harbor matching contribution is equal to 100% of salary deferrals up to 1% of employee compensation, plus 50% of salary deferrals that exceed 1% of employee compensation but that do not exceed 6% of employee compensation.

## **EEDU LLC 401(k) Plan**

*Notes to Financial Statements (continued)*

### **1. Description of the Plan (continued)**

The Plan Sponsor may also make non-elective contributions to the Plan. Employees must be actively employed by the Plan Sponsor on the last day of the Plan year in order to receive non-elective contributions.

The Plan Sponsor may also make additional qualified non-elective contributions for the benefit of such participants determined at the discretion of the Plan Sponsor. The Plan Sponsor did not make any non-elective contributions or qualified non-elective contributions for the year ended December 31, 2024.

***Vesting*** – Participants are immediately vested in their salary deferral, rollover contributions, qualified non-elective contributions, and actual earnings thereon. Participants vest in Plan Sponsor safe harbor contributions after 2 years of service. Participants vest in Plan Sponsor non-elective contributions at the rate of 20% per year of service after two years and become fully vested after six years.

***Participant Accounts*** – Individual accounts are maintained for each Plan participant. Participant accounts are increased by participant contributions, Plan Sponsor contributions and the participant's share of Plan earnings. Participant accounts are decreased by participant distributions and each participant's share of Plan expenses and losses. The allocation of earnings and losses to participant accounts is based upon the value of an individual account in relation to the total assets of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Payment of Benefits*** – Upon termination of employment, retirement, death, disability, or as required by law, a participant may elect to receive a lump-sum distribution in an amount equal to the vested value of their account. The Plan permits in-service distributions for participants age 59 ½ from accounts in which the participant is fully vested in. Otherwise, in-service distributions are allowed from all accounts upon attainment of normal retirement age (65). The Plan also allows in-service distributions for financial hardships, as defined in the Plan documents. The Plan includes a force out provision under which participants who terminate employment and have a vested account balance less than \$5,000 are automatically required to receive a distribution from the Plan.

***Forfeitures*** – Forfeitures from non-vested Plan Sponsor contributions may be used to pay Plan expenses or reduce Plan Sponsor contributions. The Plan used forfeitures amounting to \$5,258 to offset Plan Sponsor safe harbor contributions during the year ended December 31, 2024. The forfeitures balance available for use at December 31, 2024 was \$19,774.

***Notes Receivable from Participants*** – Participants may borrow a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one loan outstanding at a time and the minimum loan amount is \$1,000. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest.

### 1. Description of the Plan (continued)

Repayment terms may not exceed five years. Principal and interest is paid ratably through each payroll deduction. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan agreement.

***Income Taxes*** – The Plan delegated authority to CCH Incorporated to adopt the CCH Incorporated Basic Plan Document #01. The Plan relies on an opinion letter issued by the Internal Revenue Service (“IRS”) as evidence that the Plan is qualified under section 401 of the Internal Revenue Code (the “Code”). Accordingly, no provision for income taxes has been included in the accompanying financial statements. The Plan has been amended since the effective date of the letter. However, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

### 2. Summary of Significant Accounting Policies

***Basis of Accounting*** – The accompanying financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

***Investment Valuation and Income Recognition*** – The Plan’s investments consist of mutual funds and cash accounts and are stated at fair value, as determined by Matrix Trust Company (the “Trustee”). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The Plan presents, in the accompanying statement of changes in net assets available for benefits, the net appreciation in the fair value of its investments which consists of the realized gains and losses and the unrealized net appreciation or depreciation of those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Administrative Expenses*** – Certain accounting and administrative expenses of the Plan are paid by the Plan Sponsor. Expenses relating to investment activity are paid by the Plan.

***Payment of Benefits*** – Benefits are recorded when paid.

***Party-in-Interest Transactions*** – Certain Plan investments are managed by the Trustee as defined by the Plan. Accordingly, transactions involving these investments qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

### **2. Summary of Significant Accounting Policies (continued)**

***Risks and Uncertainties*** – Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

***Use of Estimates*** – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

***Subsequent Events*** – The Plan Sponsor has evaluated subsequent events, for recognition or disclosure, through October 1, 2025, the date the accompanying financial statements were available to be issued. See Note 6.

### **3. Information Certified by the Trustee (Unaudited)**

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the investments and participant loans included in the accompanying financial statements and supplementary information are complete and accurate at December 31, 2024 and 2023.

The Trustee also certified interest and dividend income totaling \$9,838, and net appreciation in fair value of investments of \$38,462 for the year ended December 31, 2024.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date. All assets held for investment by the Plan utilize Level 1 inputs as their primary measure of fair value as of December 31, 2024.

**4. Fair Value Measurements (continued)**

- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security. There were no assets of the Plan that utilized Level 2 inputs as its primary basis for calculating fair value as of December 31, 2024.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity’s own assumptions about the assumptions that market participants would use in pricing the asset or liability. There were no assets of the Plan that utilized Level 3 inputs as its primary measure of fair value as of December 31, 2024.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

**Cash** – Cash consists of contributions that are deposited into the Plan and typically take one day to trade into the mutual funds as directed by participants.

**Mutual Funds** – Shares of mutual funds are valued at quoted market prices of shares held by the Plan.
